RAILROAD BUILDING THAT WILL RESULT IN HARBOR IMPROVEMENT

The Sluslaw harbor may not be all that is desired, but it is a fact that much shipping comes in and goes out of the mouth of the river in the course of a year. News items reprinted in the Guard today from the Florence West tell of several lumber laden schooners going to sea with their cargoes last week.

It should be borne in mind that the Sluslaw bar has been neglected by the government and that very little money was ever spent on its improvement, one reason given for this neglect being the lack of tonnage to justify the expense. With the building of the Eugene-Sluslaw rail road this excuse for passing up the Sluslaw will have been removed, because it will become the shipping port of a large and prosperous part of the Willamette valley. Our delegation in congress will have something definite to base their plea for fund upon the moment ground is broken for the new railroad, and it is more than probable that, ere the steel rails reach tidewater, the government will have been stirred to take such action that the mouth of the Sluslaw will afford a shipping port for the extensive commerce that will follow the building of the railroad.

DAY OF THE APPRENTICE HAS PASSED FOR GOOD

The Pennsylvania apprenticeship act of 1770 has been repealed, for thus has been wiped from the statute books an enactment which some later-day philanthropists consider little less than a "barbarism and legalization of a form of slavery." It is true that the act, which was modeled on the old British law, has in late years been honored more in the breach than in the observance, and that the old apprenticeship system, as it obtained in Pennsylvania and other states, worked hardship on youths in many cases and was subject to grave abuses.

Moreover, it does not seem practical that the system could be continued under the present labor regime and the processes by which, owing to much machine work, labor is so greatly divided and subdivided. Yet it cannot be doubted that with its passing the world has been deprived in numerous spheres of honest and enduring work and artistic handicraft productions that no machine and no modern and progressive methods can substitute or compensate for.

The apprentice who served his time and becoming a master had pride in and a love for his vocation, and was influenced by sentiment that in the nature of things cannot prevail now. As to various crafts, especially those pertaining to articles of household furnishing and adornment, he put an indefinable character and individuality into what he produced, easily recognizable to those who study what is now known as the antique. In all fields of labor, more or less, he was the true artisan, and not infrequently if unconsciously, perhaps, the true artist.

Between the interstate commerce and railway commissions, complaining shippers and protesting merchants' associations, the Southern Pacific Company seems to have its hands about full, with little prospects for its attorneys getting a vacation, even in the sweltering days of midsummer.
