CHAS. DAUGHERTY IS KILLED AT SACRAMENTO

Charles E. Daugherty, a son-in-law of County Commissioner H. D. Edwards, of this city, was killed at Sacramento, Cal., Sunday. The manner of his death is not learned, but it is presumed that he was run over or struck by a train, as he was employed as a bridge inspector for the Southern Pacific Company. Mrs. Daugherty was visiting in Portland and arrived up last night on the local. Commissioner Edwards was at Blue River and he and his daughter, Miss Ina, arrived down from there this morning, having driven all night. The remains will arrive in Eugene tomorrow for interment. Mrs. Daugherty is almost prostrated by grief.

time she was on the dry dock in 1906 for repairs made necessary by the damage sustained during the San Francisco earthquake, she had been on the run almost continuously. The Columbia made a remarkable record because of her promptness in reporting at the two ports. During the first fifteen years she was only on one occasion at sea longer than one night on the trip south.

The steamer was 300 feet long, 35.5 feet beam and 23.3 feet depth of hold. She was of 1745 tons net register. The Columbia was one of the staunchest built of the earlier-day vessels, and was operated from 1880 until 1905 before she was placed in drydock. At that time she was lifted at the Union Iron Works in San Francisco, and was given an overhauling that placed her in better condition than when she made the trip around the Horn.

TELEGRAPHIC NEWS IN BRIEF FORM

A dispatch from Tapachula, Mexico, says that Plutarco Bowen, an American who recently fled from Guatemala to that town, has been kidnapped by a force of Guatemalan troops who crossed the border into Mexico at night and entered Tapachula. Bowens was carried on a horse into Guatemala. He was taken to the town of San Marcos and there executed by a firing squad. His pleadings for a trial by jury were ignored.

At West Point Colonel Charles Ayres, of the United States army, who gained prominence by criticising the officers for excluding his wife from the grounds at West Point, has been declared incapable of serving in the army on account of Bright's disease by medical examiners.

A committee of Elks at Philadelphia awarded Denver lodge \$250, second prize for traveling the greatest number of miles to the convention. New Orleans got the first prize of \$300. New York won first prize of \$500 for having the largest number in the parade.

It has been learned that Mrs. Russell Sage has recently given \$250,000 to the association for the relief of respectable, aged, indigent females in the city of New York.

At Sandy Hook, Ky., Judge James Hargis, central figure in the famous feud, has been acquitted on the charge of complicity in the murder of Dr. Cox. The state refused to enter into the case because its witnesses failed to appear. Because Judge Moody declined to send the case to Breathitt county the court ordered the jury to acquit Hargis.

At Pullman, Wash., fire early Saturday morning destroyed the Pacific Coast elevator and warehouse, the Standard Oil tanks and house and the warehouses of a number of Pullman merchants. The loss will total nearly \$30,000, and is distributed as follows: Stewart Chure Hardware Company, \$8000; Billy Reed Furniture Company, \$1200; Frank Campbell, \$6000; Pacific Coast Elevator Company, \$12,400; Springfield Lumber Company, \$2000; Standard Oil Company, about \$5000.

LARGE HOP DEAL AT LOW PRICES

One of the largest transactions in hops that has been made at Silverton for several months was consummated Monday evening when J. L. Bower sold his entire lot of 1906 hops to T. A. Livezey & Co., of Salem. The lot consisted of 130 bales and the price received is too low to mention. Mr. Bower held the crop over, hoping to receive a better price, but as there is not much reason to hope for an increase at the present time he disposed of them Monday for what they would bring. From all appearances it was a great sacrifice. He was offered much more several months ago. At this rate of sale there is not much encouragement for hop growers, and unless better prices prevail this fall there will be fewer hops raised in Oregon next year. The transaction Monday was a losing deal for Mr. Bower.

Little has been done in the hop market during the past few months, on account of the low price and it is doubtful if there will be many hops moving between now and the time for harvesting the new crop unless the prices take a turn for the better. — SILVERTON APPEAL.
