CAPTAIN MOON MAY GO BACK TO MILITIA

HIS NAME PROMINENTLY MENTIONED FOR CAPTAIN OF CO. C. TO SUCCEED CAPTAIN WILLIAMS—IS OLD O. N. G. OFFICER AND CAPTAIN OF CO. C IN THE PHILIPPINES

The advancement of Captain J. M. Williams, of Company C, and Captain C. C. Hammond, of Company A, to the respective ranks of lieutenant-colonel and major of the new Fourth regiment, causes a vacancy to exist in each of these companies, which will be filled at elections to be held by the companies within the next week. Company A's election will occur tomorrow night and that of Company C next Monday night.

There has been considerable speculation among the militiamen, as well as among their friends and the outside public in general as to who will be chosen to succeed Captains Williams and Hammond. As far as the sentiment of the members of Company A can be learned, First Lieutenant Raymond Babb is their choice for captain. In case of his election Second Lieutenant J. M. Renne will be advanced to the rank of first lieutenant and a new second lieutenant will have to be chosen from the prominent among those mentioned for the place are Corporal W. W. Hanstetter and Private W. G. White. Both are old militiamen and both were members of Company C, Second Oregon Volunteers, and served in the Philippines during the Spanish-American war and the Philippine Insurrection. Both have good records and are thorough tacticians.

For captain of Company C William S. Moon, of the firm of Moon & Tingley, is perhaps most prominently mentioned, although First Lieutenant Geo. Willoughby has a strong following, and it is said that his name will have to be chosen from the ranks. Militiamen, having been captain of Company C, Second regiment, O. N. G., before the Spanish-American war and was captain of Company C, Second Oregon Volunteers, in the Philippines, having served with distinction. Since being mustered out of the volunteer service, Captain Moon has not been identified with any military organization, although he never lost interest in the affairs of the Oregon National Guard. He was considered one of the best drill masters in the Oregon regiment in the Philippines, and is a strict disciplinarian. Lieutenant Willoughby is also a veteran Guardsman, and if elected to the captaincy would fill the position with dignity and credit to himself and company.
