While here the matter of a low rate for an excursion to Portland on Thanksgiving day, which was planned by the Commercial Club as Eugene day, the occasion being the football game between Oregon and Multnomah, was discussed. HITCHCOCK REFUSES TO GIVE ANSWER

New York, Nov. 20.—Raymond Hitchcock, the actor, refused to answer questions put to him when he was called today as a witness in the action for criminal libel brought by former Congressman William Astor Chanler against William R. Hearst. Hitchcock based his refusal upon his constitutional rights in that, as he was himself under indictment he could not be compelled to make answers which might tend to incriminate or degrade him. The witness

was sustained by the court and an adjournment taken until tomorrow, as the defense was not prepared to call other witnesses today.

Hitchcock is under indictments growing out of charges made by young girls, and the libel alleged by Mr. Chanler associated the complainant with Hitchcock in the society of these girls.

The defense today asked Hitchcock whether Chanler was present at the actor's Great Neck, L. I., home on a certain Sunday in the latter part of 1906, when two girls were guests at his house. To this and subsequent questions the witness refused to reply.
