

HARRY THAW'S FATE IN HANDS OF JURYMEN

New York, Jan. 31.—Today for the second time Harry Thaw, slayer of Stanford White, passed into the hands of a jury of his peers. The jurors retired at 11:40 this morning, after listening to the charge of Judge Dowling, who sought to impress upon them that the burden to prove the sanity of the defendant rested upon the prosecution throughout the trial, and declared that if, from all the evidence in the case the jurors entertained a reasonable doubt of his sanity the defendant was entitled to the benefit of that doubt. At the same time he pointed out the provisions of the statute which provides that the only persons excused from criminal responsibility are those who suffer from such a defect of reason as either not to know the nature or quality of their act, or not to know that the act is wrong.

The reading of the charge took 40 minutes, and Thaw listened intently. "If your verdict should be 'not guilty,'" the justice said, "under the

specification of the defendant's plea as to insanity, you will add a clause on the ground of the defendant's insanity at the time of the commission of the act charged in the indictment. In any other verdict you may render you will specify the degree."

The jury requested all the exhibits in the case.

At 12:15 Justice Dowling ordered a recess until 2 p. m. The jury returned from luncheon and resumed their deliberations at 3 o'clock.

Chicago Wheat Market.

STANDARD OIL ACQUIRES MONOPOLY IN SOUTH AFRICA

London, Jan. 31.—The correspondent of the Daily Mail at Durban announces that the Standard Oil Company has acquired the South African trading interests in the Shell Transport and Trading Company, limited, thus establishing a monopoly in South Africa.

ARSENAL EXPLOSION INJURES MANY

Philadelphia, Jan. 31.—Five men were injured, three seriously, by the explosion today in the schrapnel department of the United States arsenal at Frankfort. Six hundred women employees in an adjoining building were panic stricken and rushed to the exits, but fortunately the women escaped unhurt.

WHEAT PRICES FORCED DOWN BY FOREIGN SURPLUS

Chicago, Jan. 31.—Exceedingly heavy shipments from Argentina caused a slump in the wheat market today. The amount was over 9,000,000 bushels, half a million more than expected, and the market opened with a flood of selling orders, which continued throughout the day. At times the market was almost demoralized. Prices steadied somewhat just before the close.

DYNAMITE WRECKS MINE OFFICIAL'S HOME

Trinidad, Jan. 31.—The residence of A. Alexander, superintendent of the Frederick mine, twenty miles from here, was partly wrecked by the explosion of dynamite today. The explosives were placed under the bedroom where three children were sleeping, but all the inmates of the house escaped with slight injuries. It is believed the explosion was caused by discharged miners.

EUGENE'S NEW HOSPITAL ENTIRELY COMPLETED

The Eugene General Hospital has been entirely completed and is now open for patients. The building was opened for public inspection yesterday and a reception to the people of the city was held during the afternoon. Everybody who visited the institution admired the building and the completeness with which it is furnished.

The building is located on the east slope of College Hill, on a part of the old Humphrey place. It is a frame structure, two full stories high, with an attic and basement, 40x96 feet in dimensions, exclusive of the large porch in front, which is 12x30 feet in dimensions. The exterior of the building is covered with cement over steel lath, giving it the appearance of a brick structure. John Hunzicker was the architect and W. H. Alexander the contractor. The workmanship is of the best and reflects great credit on the architect, the builder and all who were in any manner connected with its construction.

In the basement of the building is the heating plant, the store room, laundry rooms and the kitchen. On

the first floor are the reception hall, the house physician's office, the matron's room, the head nurse's room, three large wards with six beds each and a number of private rooms. On the second floor are only private rooms, some of them having private baths, separate toilets, etc. The operating rooms are in the north end of the building on this floor, and are fitted up with the latest appliances and fixtures known to surgical science. The walls are enameled throughout and the floors are of raccolith.

The entire building is lighted by electricity, and gas is also being installed. The building is heated by steam.

The woodwork on the interior of the building is very beautiful, and the exterior, as seen by the picture, is finished so as to give a handsome and pleasing effect. The furniture was furnished by the Campbell-Fellman Company, of this city, and is the best ever installed in any Northwest hospital.

The institution is a credit to the city and to the company of local citizens which built it. Eugene is proud of it.

CHAMBERLAIN CONFIRMS HIS HENEY INTERVIEW

GOVERNOR SAYS THAT SENATOR FULTON TOLD HIM THAT SMITH TOOK OLD MAN'S MONEY AND DIDN'T KEEP HIS AGREEMENT—REPEATED CONVERSATION TO FEDERAL AUTHORITIES WHEN CALLED ON

Governor Chamberlain today, before leaving for Albany, confirmed his interview with Henev, to the extent of saying that Fulton came into his office and branded J. S. Smith as a grafter, saying:

"He took the old man's money and didn't keep his agreement."

Senator Fulton, in an interview, said all he did was to warn the governor against appointing Smith, on the ground that he was a grafter.

Governor Chamberlain says Fulton made his statements voluntarily, and that he gave out no statement of the matter until called upon for it by the federal authorities, and then not for the purpose of injuring Fulton, but in line of duty as a public official.

It was after Fulton told him what he did that he set on foot an investigation to ascertain if Smith had really accepted a bribe. He found that, while there had been clearly an attempt to bribe a member of the legislature, Smith had gone into it with an understanding with a committee of which John C. Young and H. L. Barkley were members, to tell the cat and find out the facts as to money being used.

The Attack Not Political

"It was published in the newspapers that Smith had received \$1500, but it was never so stated by Fulton or Smith. It was stated by others that money was being used, but I knew nothing of it personally. I do not know that I shall be a candidate, or what use I shall make of the incident, in case I am forced into the campaign. If my friends insist I shall make a campaign it will not be a personal one against any man. I do not expect to go to the senate. It is an aggregation of moneybags, and I have no money to spend wining and dining that bunch, in order to get legislation that the people of the state want put through."—Salem Journal.

GENERAL PENSION BILL INCREASED

Washington, Jan. 29.—A general pension bill which, if ratified, will increase the pension roll by about \$12,000,000, was introduced in the house today by Chairman Sewell, of New Hampshire, of the committee on invalid pensions.

The bill, which has the support of that committee, provides for the payment of a pension of \$12 a month, instead of \$8, as at present, to all widows of veterans of the Mexican war, of whom there survive about 7400; of the Indian wars, who approximate 3700; all widows of veterans of the civil war married prior to June 27, 1890, of whom there are about 185,000; and all widows of Spanish-American war veterans who died of disease contracted in the service. There are about 1000 of these.
