UNIVERSITY WINS FIRST ROUND IN REFERENDUM FIGHT

Salem, Or., Jan. 29.—Circuit Judge William Galloway today decided the question of the ballot title for the University of Oregon appropriation bill by ordering that the title of the act be adopted as the ballot title. Attorney-General Crawford had prepared a ballot title which described the bill as one to increase the annual appropriation from \$47,500 to \$125,000. Friends of the bill protested and asked that the title be changed to read "fixing" the annual appropriation for the University at \$125,000, making no mention of former appropriations. The question was argued before Judge Galloway, who held that neither title is fair. That prepared by the attorney-general he found objectionable because it mentions \$47,500 as the former appropriation, whereas the matriculation has been getting about \$30,000. That proposed by friends of the bill was objectionable because it contained the word "fixing," whereas the amount is not "fixed," but any legislature can change it. The title of the act, which Judge Galloway has ordered used, describes the measure as one to amend section 3529 of Ballinger & Cotton's annotated laws by increasing the annual appropriation for the support and maintenance of the University of Oregon.

Text of Decision.
The court held that the ballot title does not give a true and impartial statement of the purpose of said measure and the same is liable to create an erroneous impression as to the true amount of the increase of the appropriation for the University of Oregon, and that the title of said measure as passed by the legislative assembly gives a true and impartial statement of the purpose of the measure and should be adopted as the ballot title for the same. Therefore, it is ordered, adjudged and decreed that the ballot title of said house bill No. 37, Chapter 64 of the general laws enacted and adopted by the 24th regular session of the legislative assembly of Oregon for the year 1907 be "To amend section 3529 of Ballinger and Cotton's annotated code and statutes of the state of Oregon by increasing the annual appropriation for the support and maintenance of the University of Oregon," and that the secretary of state shall cause said ballot title to be adopted for said house bill No. 37, Chapter 64 of said general law, and the same is hereby adopted by the secretary of state.

Judge Galloway's decision is satisfactory to both sides of the controversy. Walter Winslow, who brought the proceeding on behalf of the University, and M. E. Pogue, attorney for the Grangers, who filed the referendum petitions, say that the title adopted meets their approval. The decision is regarded as a victory for the University.

NEWS OF THE UNIVERSITY OF OREGON

The six debaters for the University of Oregon teams in the interstate league were chosen last Saturday night in the final tryouts in Villard hall. Jesse H. Bond was selected as the best individual debater, and presented with the alumni medal. Bond also was made leader of the affirmative team to debate Idaho here on March 27. His first colleague will probably be W. C. Nicholas, second Walter Eaton. Clarence Wheelton was given leadership of the negative team, with Earl Kirkpatrick as first colleague, and in all likelihood T. R. Townsend as second. Townsend was made first colleague on the affirmative team, and Eaton second on the negative, but the change as already presented will probably be made. The negative team will contest with the University of Washington at Seattle also on March 27.

The question for discussion was the same as the one which will be used in the league debates, "Resolved, that the present laws relating to Chinese immigration should be extended to include the Japanese immigrants."

While Pacific coast feeling is strong for the exclusion of Japanese the negative side makes out a strong argument for non-extension.

Y. M. C. A. Banquet.
The Young Men's Christian Association gave a banquet to seventy-five of its members at Frank's hall on the evening of January 25. After full justice had been done to the good things the merriment began.

All present joined in the "Toast to Oregon." A quartette composed of Steelquist, Moore, Lewis and Davis followed with a selection, which was much appreciated. Owing to the fact that Walter McCrede, manager of the Portland baseball team, could not be with the Oregon college nine for over two weeks, the services of the Rose City man will not be secured, though there was a strong possibility of that good fortune.

McCrede has his own squad on hand, which will occupy his time from March on. He has gotten together about thirty men from which to select the members of the Portland baseball team.
