It believes in the popular election of United States senators and this is practically accomplished when the legislator pledges himself to vote for the choice of the people, as expressed at the polls. The candidate who refuses to sign Statement No. 1 must naturally be understood as opposing the election of United States senators by the people, and should not receive the support of a single voter who believes in that principle. It is a plain issue upon which there is no opportunity of evasion or equivocation.

CUBA REVIEWED

No one doubts the honesty of the promises of our government, but every one doubts whether Cuba will actually see these promises to be fulfilled. If the nation is saved it must be saved in spite of itself, says Lieutenant G. M. E. Murphy, in Harper's Weekly. But the government has decided to grant it another chance.
