CRUSADE AGAINST CHICAGO ANARCHISTS IS BEING WAGED

Chicago, March 3.—Frank Zajicek was arrested early today, charged with sending a threatening letter to Procopius Muzil, a prior of the Benedictine Fathers. According to the police the prisoner has confessed.

Chicago, March 3.—Isidore Maron, twenty years old, a Russian Jew, known as the "haired boy," a companion of Lazarus Averbuch, the anarchist who was shot and killed yesterday in an attempt to assassinate Chief of Police Shippy, was arrested today near Averbuch's home. Maron is known to have been an intimate companion of the slain anarchist, and they were together throughout an anarchistic meeting at Workmen's hall on Sunday night preceding the attempt to kill Shippy.

After his arrest he was closely questioned and for a time refused to admit his identity. Considerable anarchistic literature was in his possession when searched at the police station. He speaks English badly. Averbuch's sister, in broken English, talking sometimes through an interpreter, told the police she had four sisters, one of whom lived in Odessa. The others, with two younger brothers, were with their parents in Austria, living near Vienna. Her father she declared was an orthodox Jew, and had never taken part in any revolutionary movement, and that she herself had never read any of her brother's anarchistic books. When asked if she thought he might have been insane she replied: "He is very peculiar. I don't know why he did what they say he did. I only know he good boy, good brother."

In addition to Maron, several persons are being held by the police in connection with the attempted assassination of Shippy including Averbuch's sister, a bartender named Korimoros, and a cobbler named Beraman. In whose shop the anarchists are said to have met.

Detectives worked all night to trace Averbuch's other relatives, his mother, sister and brother, said to be in Chicago. Joseph Freedman, aged 28, was arrested on a street car because he remarked to a fellow passenger: "I see they tried to kill the chief of police; they ought to kill him and a lot more like him."

The possibility of deporting anarchists from the city was brought to the attention of the United States district attorney today, and that federal official declared himself ready to take any steps warranted by evidence which may be presented to him. He added that the reconvening of the federal grand jury today makes that body instantly available for any action that may be necessary to hasten possible cases.

A conference of city officials was held at the home of Chief of Police Shippy today. Mayor Busse, Assistant Chief of Police Scheuttler, Captain O'Brien, of the detective bureau, and Inspector Baccus participated. Means of dealing with the manifestations of anarchy were discussed with a view to ridding the city of such activities. Harry Shippey, the wounded son of the chief, passed a good night.
