Baker City, Ore., Feb. 22.—To the Editor of the Journal—Have followed with interest the campaign that is being waged against the state university by Eugene Palmer and others of Linn county, and I take this opportunity to ask Mr. Palmer the following questions:
1.—Are those who were instrumental in calling this referendum opposed to state support of higher education, especially to the Oregon State University? In other words, would they vote to abolish this worthy institution if the opportunity presented itself?
2.—How do Mr. Palmer and his associates expect the university to run after July 1 of this year if the pending appropriation bill does not
