RAILS SOON ARRIVE FOR PARK EXTENSION

WORK ON STREET CAR LINE OUT MOSS AVENUE TO HENDRICKS' PARK WILL BEGIN IN SHORT TIME—SURVEYING FOR LINE WAS BEGUN THIS AFTERNOON

A. Welch, general manager of the Portland, Eugene & Eastern Railway Company, arrived up from Portland last night to look after the company's operations here. To a reporter this forenoon he stated that several carloads of rails for the extension of the street car line to Hendricks' park are on the way to Eugene, and are expected to arrive within a few days. Work on the extension will then begin. Simon Klovdahl, the company's engineer, began surveying for the line on the hill this afternoon. There is no loop line from the existing extension for the present, although at some future time the two extensions will be united by an east and west line. The park line will branch off from the main line at Damper's store in Fairmount, and extending out Moss avenue will end near M. Starvord's barn, which is near the west entrance to the park. Mr. Welch said that the work of building the line toward Springfield is progressing satisfactorily, and that the work of putting in the trestle along the bottom beyond Judkins' Point will begin soon.

BIG BOOST MEETING AT ROSEBURG

MANAGER HARTOG, OF COMMERCIAL CLUB, ATTENDED—HELD TO ENTHUSE PEOPLE ON PAYING QUESTION

John H. Hartog, manager of the promotion department of the Commercial Club, returned today at noon from Roseburg, where he addressed a big boost meeting last night. The meeting was held in Elks' hall and was attended by over 600 people, the large hall being filled to overflowing. Mr. Hartog says the meeting was the most enthusiastic of its kind he ever attended. Besides himself, Judge Hamilton and other prominent citizens of that city spoke. The meeting was held to enthruse the people on the matter of paying. An election will be held Monday, at which time the proposition of issuing \$35,000 bonds for paving will be voted upon. Mr. Hartog says the sentiment there is almost unanimous for paying and he thinks the bonds will carry by a large majority.

AMERICA LEADS IN JAPANESE TRADE, SAYS REPORT

Tokio, April 1.—Trade reports, which have been gazetted, show that America leads with a total of 211,000,000 yen. Of this amount imports were 80,000,000 and exports 131,000,000 yen. China is next to America, with a total of 144,000,000 yen. England next, with 138,000,000 yen. The total Japanese trade for the year amounted to 926,000,000 yen, and the balance this year is somewhat unfavorable to Japan.
