

PRIZE AWARD AT CHERRY FAIR YAMHILL FIRST

Salem, Or., July 17.—Yamhill county is the winner of the \$150 silver cup, the "grand prize" of the cherry fair. Lane county came next and Polk is third. Five counties, Yamhill, Lane, Linn, Polk and Wasco competed for the grand prize. According to the rules of the cherry fair Marion, as a county, was not allowed to compete for the big cup.

The awards of the judge, which were made at 10:30 o'clock this morning, consisting of 35 handsome silver cups, a similar number of diplomas, and many cash prizes, are as follows:

The grand prize, special sterling silver cup valued at \$150, donated by Marion county, Oregon, for the best display of cherries, commercial pack, by any county or grower, to consist of not less than three varieties and not less than 12 10-pound boxes (or 8 carton 10-pound boxes). This cup must be won three times by the same county or grower before becoming the property of the winner. Competitors for this prize must state whether they desire the entry made in their own name or that of the county. The cherries in this competition to be returned to the exhibitors at the conclusion of the fair, won by Yamhill county; Lane county, second, and Polk county, third. The other counties which were represented by handsome displays were Linn and Wasco.

JULES CAPTURED AFTER SHORT FIGHT

Marysville, Cal., July 17.—Exhausted from want of food, his clothes in tatters and himself worn out from tramping the mountains for three days, seeking to evade his pursuers, Adolph Jules, the Italian who last Tuesday shot down and killed two fellow countrymen at a construction camp on the Western Pacific Railway, and attempted to

murder the American foreman and his wife, was captured today at Toll Gate by a sheriff's posse in Plumas county, after a sharp fight.

Finding himself intercepted and his retreat cut off, Jules opened fire upon the posse with his rifle with which he had shot Antonio Liberato and Giovanni Pucini in the Western Pacific camp. He was quickly surrounded and after many shots were exchanged, finding that he could not break through the cordon about him, surrendered to the officers.

To prevent a lynching, the prisoner was hurried to Oroville and placed in jail.

SLUGGERS FINED \$30 AND \$20 RESPECTIVELY

NEWMAN COMES TO TOWN AND GIVES HIMSELF UP—HE IS GIVEN THE LARGER FINE.

Frank Newman, one of the boys who assaulted Homer Henderson, the merry-go-round man the other night and who skipped when Constable Plank went out to the cherry orchard yesterday to arrest him, came into town last evening and gave himself up to Chief of Police Farrington, after having been unable to find the constable. The chief locked him up in the city jail. Newman appeared in the justice court this morning at 9:30 o'clock and entered a plea of guilty. He was fined \$30 and costs. Louis Miller, the other boy mixed up in the affair, was fined \$20 and costs. The reason of the difference in the fines is that Newman seemed to be the principal aggressor in the fight and according to witnesses invited the trouble.
