

NEWS FROM LABOR WORLD

Hebrew painters and paper hangers of Boston are reforming their old union.

The San Francisco Building Trades Council has organized an athletic association.

The girls employed in an Adelaide, Australia, clothing factory went on a strike to resist a reduction of wages.

Steam engineers of Cleveland, O., are making strong efforts to introduce eight-hour shifts in packing houses in place of 12-hour shifts.

White and negro longshoremen at New Orleans have signed a five-year contract with the stevedores and steamship agents, establishing a scale.

A seceding organization from the Brotherhood of Railroad Employees has taken the name of the Brotherhood of Railroad Station Employees.

The next convention of the International Brotherhood of Bookbinders will be held during the second week in June, 1910, at Cedar Rapids, Ia.

The book and job scale of the San Francisco Typographical Union has been increased from \$22 to \$24 a week.

All employers have accepted the new scale under an agreement.

The telephone service at Sheboygan, Wis., was tied up for two hours recently by a strike of the girl operators, who demanded a week's vacation with pay, and obtained the concession.

Twenty-five hundred children's jacket makers, who went on a strike in New York a few weeks ago, to resist a reduction of wages, have won their strike in all but a few shops and have returned to work at their former wages.

The railway trackmen are planning for a the establishment of a home for their aged and indigent members. It is proposed to acquire

a tract of five hundred acres near Fort Scott, Kas., upon which to locate the institution.

The St. Paul Typographical Union has decided to make a label exhibit at the Minnesota state fair this year, and will ask the Minneapolis union to join with it. Last year the St. Paul union had a highly creditable label display.

The National Brotherhood of Operative Pottery has voted to fix an age limit for all apprentices entering the trade. Resolutions were adopted which will hereafter make it necessary for all new apprentices to be sixteen years of over.

In New York state a bill which takes from the health boards of the first-class cities the inspection of mercantile establishments and places it in the hands of the labor department was passed and will go into effect on October 1.

One of the principal matters of the next convention of the United Brotherhood of Carpenters and Joiners, which will meet in Salt Lake City, September 15, is the plan to start an old-age pension, similar to that of the International Typographical Union.

It has been announced that the well-known English labor leader, J. Weir Hardie, who is also a member of parliament, intends to attend the convention of the Trades and Labor Congress, to be held at Halifax, N. S., on September 21, and that he will also attend a meeting of miners at Springhill.

Representatives of the Glassblowers of America won a notable victory on the final day of their recent wage conference with the manufacturers of glass bottles, which was held at Atlantic City, N. J., when they obtained a wage scale at the same figure as last year, with the same working hours.

GENERAL NEWS IN BRIEF FORM

John Flanagan, of the Irish-American A. C., while giving an exhibition at Queenstown, broke the world's record for a 16-pound hammer throw, distance 181 feet and 8 inches.

A New York dispatch says: Although Conrad Steingrueber laughed at the Christ hospital physicians in Jersey City, who said that he would die in 24 hours from the effects of the bite of a dog, the prophecy was fulfilled today. Steingrueber said he was a disbeliever in hydrophobia and that he would be around again in a few days. He rapidly grew worse, however. He remained conscious until the end and almost the last words he spoke were that he would get well. He was bitten three weeks ago.

A torrent of rain poured over Lincoln and the surrounding country yesterday and kept visitors away from Fairview. Bryan bustled himself in his study preparing speeches. A large Manchester man, narrates the News, attempted to swallow a snake, tail foremost, but twice the little reptile succeeded in getting away from her. On the third attempt the snake was compelled to give up, having been almost pecked to death.

A Wallawa county man picked 196 gallons of strawberries from 1,750 plants. Of this number 376 plants were planted the first of May, 1907, and this season yielded 58 gallons.

THIS IS MY 50TH BIRTHDAY

Dear Admiral Schroeder. Bear Admiral Sauton Schroeder, who commands the fourth division of the Atlantic battleship fleet on his present trip around the world, was born in Washington, D. C., August 17, 1849.

He was graduated from the navy academy at Annapolis in 1868, and reached the grade of lieutenant in 1872. In 1871, while attached to the Pacific squadron, he took part in Admiral John Rodgers' expedition against the Koreans. In 1879 he was placed in charge of the removal of the obelisk from Egypt to Central Park. In 1898 he was executive officer of the battleship Massachusetts and was advanced three numbers for his conduct in the Spanish war. From 1899 to 1903 Captain Schroeder was governor of the Island of Guam, and later was stationed at Washington at chief intelligence officer.

A store's advertisements tell the people what is "doing" at that store—what is new, what is inviting, why today is a good time to visit the store. People look for the ads to tell them these things just as naturally as they would look at a clock to tell the time.

Sometimes a clock does not run—sometimes a store's ad does not run. A "run-down" clock or ad are about equally unsatisfactory, unserviceable, misleading.

Curious thing about it is that a merchant who would think it absurd to have a run-down or out-of-repair clock will, sometimes, deliberately let his ad stop running. It's not wise nor good business, nor defensible on any known grounds—but it is sometimes done.
