

## THE MILLS EASTERN RATES LOWER THAN COAST

In the case of the Lumber Manufacturers and Tacoma Lumber companies and other numerous other Northern Pacific railroad; also Northwest Washington Lumber Association, Burroughs, and the Oregon Lumber Association, Eastern Lumber Company and Oregon Short Line, the interstate commission today authorized a difference of ten cents per cord on fir lumber points. This is with the provision that the differential or difference cents below

the rates that prevailed prior to November 1 last, and that the differentials prescribed in the case of the Potlatch Lumber Company and others against the Northern Pacific and other carriers must be observed. This permission does not sanction the endorsement or establishment of higher rates for a shorter haul than for a longer haul in the same direction, when the shorter haul is included within the longer. The effect of this ruling is that the lumbermen in the Spokane district are to get a lower rate to the East than the coast mills have, but that this difference in rates cannot exceed ten cents per hundred pounds.

In the circuit court cases of George C. Beebe vs. Eliza J. Beebe and Leo M. Travis vs. Henry Loretz, in which Mr. Travis is attorney, a motion was filed by the plaintiffs this morning for dismissal.

## GERMANY'S ACTION ONLY OF SMALL MOMENT

MERELY SUGGESTION TO POWERS THAT TIME HAS COME TO RECOGNIZE NEW SULTAN—ENGLAND STILL REFUSES TO ACT, BUT FRENCH EXCITEMENT IS COOLING DOWN

Berlin, Sept. 3.—The action of Germany concerning Morocco was explained today as a limited suggestion to the signatories of the Algeiras act that the time had arrived to recognize Mulai Hafid as sultan. Official wonderment is expressed over the agitation of the French and English newspapers.

It appears that the French government desires to make certain private arrangements with Mulai Hafid before coming out in his behalf, while another probable cause of the dissatisfaction in France is that certain French interests have made loans to Abdul Aziz.

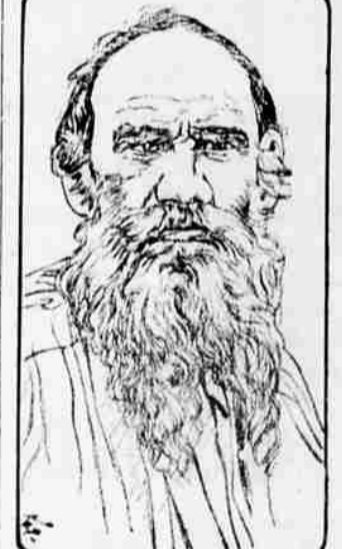
**England Not Ready.**  
London, Sept. 3.—It is learned today that the British government is holding aloof from Mulai Hafid, the new sultan of Morocco, for the present. British officialdom is irritated at the course of Germany, which it regards as an attempt to gain the influence and good will of Mulai Hafid, by stealing a march on the other powers before they recognize him.

## PHYSICIAN SAYS SOMMERVILLE DIED FROM HEMORRHAGE

Los Angeles, Sept. 2.—Fred Somerville, administrator of the estate of his second cousin, M. L. Somerville, who died here suddenly August 13, has asked the police to investigate the case, believing that his relative was foully dealt with. On the other hand, Dr. Newell J. Brown, who attended Somerville, signed a death certificate stating that the man died from shock following gastric hemorrhage, superinduced by alcoholism continued for years.

Somerville was stricken with hemorrhage when he went to his place of business, of which he had been proprietor for more than a year, on the morning of August 13. He died at 3:30 o'clock in the afternoon.

"There is no question but that his hemorrhage was brought on by the continued use of alcohol," said Dr. Brown today. "I was convinced of that when I signed the death certificate."

"We are suspicious about his death," said Fred Somerville today. "I did not know anything of it until the body had been sent to Eugene, Oregon. I had thought somewhat of employing private detectives. My lawyer advised me to do so when I laid the case before him. I have now decided to enlist the aid of the police."
