The Spinners' International union will meet at Boston next Thursday.

The carpenters at Vines, Porto Rico, have formed a very union, recently.

Penal and reformatory institutions have invested \$4,500,000 in machinery used by convicts.

In Alabama, Florida, Mississippi and Virginia convicts are so worked as to be a source of profit to the state.

The German ironmasters threaten to close down all iron works because of the refusal of the skilled workmen to accept wage reductions.

The Marine, Longshoremen and Transport Workers' Association has decided to increase its per capita tax from five to fifteen cents.

The recent Scottish Trade Union Congress passed resolutions in favor of old age pensions and in favor of compulsory intervention in labor disputes.

The eight-hour demonstration in Brisbane, Australia, recently was marked by the participation for the first time in the history of the day of organized women workers.

The semi-annual report for the Bricklayers and Masons International Union for the term ending June 30, 1908, shows a total membership in good standing of 64,557.

The movement for perfecting the amalgamation of the various branches of the lithographers unions into one central body will mean the merging of over 100,000 members of the lithograph trades into one organization, which will have great strength throughout the United States.

hop of the Methodist Episcopal church, was born at Athens, O., September 3, 1838, and received his education at Ohio University. In 1862 he entered the Union army as a private and served till the close of the conflict, rising to the rank of lieutenant-colonel. Re-entering the ministry in Ohio, he filled pulpits in prominent cities, including Columbus and Cincinnati. Then for five years he went to Denver where he organized the University of Denver and served as its chancellor until 1869. In that year he was elected a bishop by the general conference that met in Chicago and was sent to Shanghai, with the special jurisdiction over the Methodist missions in China, Japan and Korea. At the time of the Boxer outbreak in China and later during the war between Russia and Japan Bishop Moore had many exciting experiences. The general conference in 1904 transferred his headquarters to Portland, Oregon.

more than forty factories. All of these are union shops. In them over 200 stogie makers are employed, 251 in addition to 1500, between 400 and 4000, respectively, not a man in the several hundred tobacco workers employed.

With a general resumption of work in the coal mines of Indiana, the district officials of the United Mine Workers are claiming a victory in their fight with the operators, and that too, after rejecting the proposition submitted by national president Lewis at a recent conference.

The printing course established by the Kansas State Agricultural College was favorably commented upon in the current issue of the Typographical Journal, the official magazine of the International Typographical Union. The College is located at Manhattan, Kas., and the newly established course takes four years.

The United Railway Men's organization of the state of New York, which is a legislative body made up of members of the five railroad brotherhoods, will hold a special meeting shortly at which a resolution will be passed demanding an amendment to the law creating the state and city public service boards, providing for the appointment of a representative of labor on both boards.

Every precinct in the city of Chicago will be politically organized in the interest of organized labor at the coming election. If the plans of the political action committee of the Chicago Federation of Labor bears fruition, Reports from union leaders in various sections of the city indicate that there is a strong sentiment among members of labor unions in favor of the policy suggested by President Gorgers, to defeat the opposition of organized labor at the polls and to elect those friendly to it. Several ward organizations have already been perfected.

**ANOTHER BIG FIRE AT PENDLETON YESTERDAY**  
Pendleton, Sept. 3.—In a fire which totally destroyed the Alta House and feed barns early this morning, nine head of horses and \$15,000 worth of property were destroyed. The hotel was a two-story wooden structure with stables in the rear, both largely patronized by farmers. Many teams were in the stables when the fire broke out, but they were all driven from the flames except nine. The East End grocery, which joins the hotel, was saved from serious damage. All the occupants of the hotel escaped.

The fire, like three others which have occurred in the past two weeks, indicates the work of an incendiary. The circumstances surrounding this fire and the Ogs saloon fire a week ago, point strongly to a man seen on the premises. The old Academy building, unoccupied, was set on fire a week ago. The Temple & Wilcox implement house and the Christian church make four fires in the business district in the past two weeks, all having started from unknown sources.
