BIG BALLOON RACE BEGINS IN BERLIN TODAY

Berlin, Oct. 10.—With twenty-three contestants representing eight countries there is every indication that the third international balloon race for the Gordon Bennett Cup will result in the most notable contest of its kind in the history of aeronautics. Success, of course, will depend to a great extent upon the atmospheric conditions. If the conditions are favorable the start of the race will be made this evening from the grounds of the Berlin Aero Club. If the outlook is not regarded as entirely satisfactory the start will be deferred until tomorrow.

The drawing for the start gives America first honors, and J. C. McCoy, has been picked to start first in the America II, of 2200 cubic meters. The other American entries are Nason H. Arnold, with the St. Louis, and A. Holland Forbes, who will pilot the Conqueror. Belgium has two entries, M. de Moor and M. de Bronfrere. Oscar Erbsloh, who won the cup last year with a flight of 872 miles, when the race was held in the United States, is competing again for Germany. Prince Borghese is one of the Italian competitors. England's hopes are centered largely on Hon. Charles Stewart Rolls, who will pilot the big balloon Britannia. Alfred Le Blanc and Jacques Faure, who contested last year, are the leading Frenchmen.

QUAKER CITY FESTIVAL IS OVER

Philadelphia, Oct. 10.—The wildest dreams of the promoters of the "Founders' week" celebration have been surpassed by the realization. No festival, no great gathering held in Philadelphia since the Centennial exposition in 1876 has in any way been the peer of the celebration which concludes tonight with a final grand illumination of the city. Every detail of the week's program has been carried out with clock-like regularity. Every citizen seems to have contributed as far as possible to the success of the affair.

Today was given over almost wholly to the athletic events on the program. These included automobile races in Fairmount Park, track and field events at the Philadelphia ball park, and a national rowing regatta on the Schuylkill. Another feature of the day was a parade and field exercises of the Knights Templar of Pennsylvania.
