### ALBANY EXCURSION PLEASANT AFFAIR

Visitors From Eugene and Portland Were Royally Entertained

About eighty members of the Eugene Commercial Club visited Albany yesterday to help our neighbors defeat their new Southern Pacific depot, and exchange neighborly courtesies. The Eugene band headed the delegation and discoursed excellent music at every station on the way to Albany and throughout the day, the delegation leaving this city on the 12 o'clock train and returning on the Cottage Grove local at 9.25. The few hours occupied by the visit were crowded full of amusement and entertainment, the chief features of which were the new depot, the apple fair, a football game between Albany College and Willamette University and a splendid banquet tendered the Portland and Eugene visitors at the Alco gymnasium early in the evening.

After arriving at Albany the Eugene band played a selection and Mayor Wallace delivered an appropriate address of welcome to the visitors, when Dr. Davis, chairman of the depot committee, took charge of affairs and called upon prominent railroad men present for talks, and like the railroad style they were to the point. Those responding were Manager and Vice-President O'Brien, Hon. J. K. Weatherford of the C. & E., General Counsel Cotton, and C. A. Malbeuf of the freight department.

In explaining the delay in station building Mr. O'Brien told how during the past four years \$5,400,000 has been spent in betterments in Oregon, including \$1,800,000 for new rails, \$1,200,000 for steel bridges, \$210,000 for new sidings, etc.

Among the railroad officials besides those speaking were the passenger agent, Wm. McMurry, Chief Engineer Boscke, Superintendent Fields, Assistant John M. Scott and Mr. Berlin.

Foreman Buley opened the door, Agent Front and Baggage Master Parker were the first in, followed closely by the Democrat man and others. F. M. French had the honor of buying the first ticket, Albany to Eugene, No. 5729.

Apple Display Is Admired.

The visitors were then taken to the apple fair in the Armory and the splendid display called forth admiration and surprise.

The college football field was the next center of attraction and the visitors watched Albany College defeat Willamette University 11 to 4. The game was delayed half an hour by the fact that Willamette refused to play so long as Dunlap, former star at the Oregon Agricultural College, who is now attending Albany College, remained in Albany's line. President Crooks certified that Dunlap is a regular student and entitled to play under the college requirements, but Coach Kirby kept his team in the gymnasium. The Eugene boosters, who added a great deal of life and vim to the afternoon, came to the rescue in the interim, by following their band in a big parade around the field.

After the game the visitors gathered in the big gymnasium annex of the Alco club, where the ladies' auxiliary of the Commercial club served a splendid eight-course dinner. Covers were laid for 400.

This banquet was the crowning event of "Portland day." The spirit of good-fellowship mingled with the spirit of all Oregon and enthusiasm for united effort reigned.

Novel Methods of Introduction.

J. S. Van Winkle, postmaster of Albany, was an unqualified success as toastmaster and presentation of telegrams from well-known men of the state and nation won applause. J. K. Weatherford made the address.

and was followed by W. W. Cotton, Governor Chamberlain was introduced by neat fake telegrams from Taft and Bryan. H. M. Crooks, president of Albany College, and P. L. Campbell, president of the University of Oregon, were the next speakers, the latter being greeted by the Oregon varsity yell.

John H. Hartog, manager of the Eugene Commercial club, was presented as the only Eugene man of whom Albany was jealous, and said when Eugene dedicated its new depot it thought it had eclipsed all records, but that Albany had "out-Eugened Eugene."

Many Other Speakers.

Senator C. W. Hodson spoke for the Portland Commercial club, of which he is president. Tom Richardson made a characteristic talk, and B. I. Dasset, the Albany booster, was introduced and received an ovation. C. C. Chapman, president of the Portland Admen's Club, was presented as the "Portland megaphone," and made good. Fred Miller, secretary of the Portland Board of Trade, and H. H. Hewitt, of Albany, made good talks and then William McMurry, general passenger agent of the Southern Pacific, characterized the banquet as the greatest gathering in Oregon. Ralph W. Hoyt spoke as president of the Portland Rose Festival, and J. W. McDougall, a former Albany minister, now of Portland, made a hit in the closing talk.

The Eugene delegation returned home tired, but fully satisfied with the events of a strenuous day and pleased with the entertainment given by the Albany people.

The University of Washington football team expects to win next Saturday from the University of Oregon team, for the first time on the Eugene field, according to Seattle papers. Yet the feeling at the University is becoming stronger that the local varsity will beat the Washington team, and win back their prestige.

The practice this week has been more fierce than at any time this season. The men are becoming veterans through experience, and are getting together with a co-operative spirit which is expected to sweep the Evergreen team back in their march to victory.

Olen Arnsperger will look after the practice tonight. Coach Forbes is at Corvallis watching the O. A. C. Whitman game. Besides the afternoon practice the team has been running through signals in the gym.

**Football Grades.**

All available statistics seem to indicate that football men of the University are as good in their studies as the general average, says the Oregon Weekly. The only basis of comparison is the number of low grades handed into the office. For the first month of the year there were reported to the University office by the various departments 32 D's and 23 E's against the men of the University who do not turn out for football. The large football squad made six D's and four E's.

### TEXAS PREACHER CAUSES EXCITEMENT

Marshal Snodgrass of Cottage Grove Earns Part of \$200 Reward.

Geo. Clark, a Methodist minister who has been preaching at Gardiner, furnished excitement in town and along the line today in a plenty, says the Cottage Grove Western Oregon. Sheriff Fenton, of Douglas county, got this man at Gardiner, who is wanted in Texas for bigamy and for obtaining money under false pretenses, and upon his request, and payment of necessary expense, took him to Salem to see the governor. He was given the cold shoulder at that place and the sheriff was returning with him to Roseburg, when the ex-preacher gave him the slip at Junction City. Description was wired to Marshal Snodgrass, of this city, who got this man as he came through town. Sheriff Fenton was notified and got his man here, taking him to Roseburg with a pair of steel wristlets for ornaments. There is \$200 reward, a part of which Marshal Snodgrass will receive.

The second annual school board convention for Lane county will be held in the court room at Eugene, Oregon on November 28, 1908. Each district is only entitled to one delegate. However, a cordial invitation is extended to all the school officers, patrons and others interested in education to be present and take part in the meeting, for the primary purpose is to help the educational thought of the county.

J. H. Ackerman, state superintendent of public instruction; L. R. Traver, superintendent of the training school at Monmouth, state normal; D. Sheldon, head of the department of education at the state university; the Lane county delegation in the next legislature, and other speakers will be present.

Recommendations in the changes of the law made by the convention will receive careful consideration by the Lane county delegation in the next session of the legislature, which meets next January. Every district in the county should be vitally interested in what changes in the law are recommended, and the chairman should see that his district is represented at this convention.
