CONTRACT LET FOR THREE HOUSES IN HILL CREST ADDITION

SHIP TWENTY-SEVEN TONS OF TURKEYS FROM DOUGLAS

Roseburg, Oregon, Nov. 22.—About 27 tons of turkeys will be Douglas county's Thanksgiving contribution this year. The prices have ranged from 17 to 21 cents. These figures do not include the 40 turkeys, chickens, ducks and geese, which were also shipped in large numbers. Although not many more birds are expected to be brought in for the Thanksgiving trade, yet enough are expected the first of the week to bring the total to a value of over \$60,000. The 27 tons of birds includes five tons sent by an Oakland firm, the remaining 22 tons being sent from Roseburg. The number sent from the smaller towns in the county is not yet known and is impossible to determine. The price received this year for the turkeys is several cents higher than that received last year, but even at the prevailing prices, which are considered good, the farmers do not bring in the amount of turkeys expected, a great many birds being held for Christmas trade, when prices are generally expected to be even higher.

SHIP TWENTY-SEVEN TONS OF TURKEYS FROM DOUGLAS

Roseburg, Oregon, Nov. 22.—About 27 tons of turkeys will be Douglas county's Thanksgiving contribution this year. The prices have ranged from 17 to 21 cents. These figures do not include the 40 turkeys, chickens, ducks and geese, which were also shipped in large numbers. Although not many more birds are expected to be brought in for the Thanksgiving trade, yet enough are expected the first of the week to bring the total to a value of over \$60,000. The 27 tons of birds includes five tons sent by an Oakland firm, the remaining 22 tons being sent from Roseburg. The number sent from the smaller towns in the county is not yet known and is impossible to determine. The price received this year for the turkeys is several cents higher than that received last year, but even at the prevailing prices, which are considered good, the farmers do not bring in the amount of turkeys expected, a great many birds being held for Christmas trade, when prices are generally expected to be even higher.

BRINGS THANKS OF THE CHINESE EMPIRE

San Francisco, Nov. 23.—Conveying to the American government the gratitude of the Chinese people for the remittance of a debt amounting to nearly \$14,000,000, Tang Shao Yi arrived in San Francisco today on the steamer Mongolia.
