ANOTHER HOTEL PROJECT IS LAUNCHED

Planned to Put Up Four-Story Building At 8th and Olive—Use Dunn-Wilkins Block

Talk of a new hotel in Eugene has been rife for some time past and several projects have been talked of, but the one that seems to have the best prospects for materialization is that of a West Eighth and Olive streets. F. E. Dunn has taken an option on the corner lot owned by William McFarland and it is intended to erect a four-story building there and use the two upper stories of the Dunn-Wilkins three-story block, now in course of construction and which adjoins the McFarland lot, in connection, making a splendid building for a hotel. If the project goes through, it is intended to put up a hotel that is modern in every particular. The plans for the Dunn-Wilkins block show that every room is well lighted and it will be splendidly arranged for a hotel. There will be sixty rooms in that portion of the building and forty in the new structure on the corner.
Mr. Dunn hopes to be able to announce within a very short time a successful consummation of his plans. In that case it is probable that the work of putting up the building on the corner will commence as soon as possible thereafter.

Brick work on the Hovey block is yet at a standstill, the strike not having been settled. It is probable that a new lot of workmen will be brought in to finish up the job.

FATAL HUNTING ACCIDENT NEAR COBURG SATURDAY

Saturday evening about 5 o'clock Lawrence Melvin Bond, son of a merchant of Coburg, aged 14 years, was shot and instantly killed by Lee Smith, a youth of about the same age, as they were out goose hunting. The killing was accidental, and Coroner Gordon, who went to Coburg to investigate the matter, deemed it unnecessary to hold an inquest.

Young Bond and Smith were in company with George Smith, father of Lee, George Drury and Professor Maxwell. They were all along the McKenzie river bottom, a mile west of the railroad bridge. The boys were ahead of the others and suddenly noticed a flock of geese. They crawled up to within shooting distance of the geese and both fired. Bond fired a second shot and suddenly arose, just in time to receive the full charge of shot from young Smith's gun as he, too, fired a second shot. The shot entered the back of the head and death resulted two hours afterward.

Young Bond was a bright lad and was liked by all who knew him. He was a pupil in the eighth grade of the school at Coburg. Young Smith naturally feels very badly over the accident.

The funeral was held today and the body interred in the Coburg I. O. O. F. cemetery.

REBELS MAY LOOT DOMINGO'S CAPITAL CITY

People of Port au Prince Are in Veritable Panic

Port au Prince, Nov. 30—Fear that rebels may enter and loot the city has put the people in a panic. Stores and business houses are closed, with shutters over the windows and doors. Residences are being protected and every foreigner has put up over his property the flag of his nation. The rebels have taken a number of important towns and strategic positions.

NEGRO SHOOTING Baffles Police OF CAPITAL CITY

If Man Dies Legation Quarters Must Be Searched

Washington, Nov. 30.—The police of this city have a shooting mystery on their hands, involving a negro, a supposed diplomat and the alleged wife of an army captain. William Sykes, the negro, who was shot, lies at the hospital in a critical condition. Others involved in the affair have been able to conceal their identity.

The negro approached the couple Saturday night in a fashionable section and asked to be directed to a certain address. A short time afterward, according to the clerk of the Portland apartment house, overlooking Thomas Circle, where the shooting occurred, a man and woman, apparently greatly excited, passed through the lobby and left by another door. The man's nose was bleeding and the woman was heard to advise him to have it attended to. They started for a drug store on the corner, but changed their minds and disappeared.

The negro adheres to his first story, that he simply asked to be directed to an address which was given. Should he die the police will be obliged to canvass all the legations, unless in the meantime the identity of the man is established.
