The regular weekly bulletin of the Portland Chamber of Commerce says: "Today is an extremely important one in the growth and advancement of the state of Oregon. It is the opening day of the lowest-priced one-way tickets to the state sold for years, and calculated on the basis of rate per mile, Oregon has the advantage of every other state in the union. Tickets for Oregon points will be on sale today and continued until April 30, at every ticket office in the United States and Canada, and if the buyer of the ticket is posted in advance he can get a ride from Winnipeg, Canada, to the farthest rail point in Oregon for \$25. This same fare applies to St. Paul, Omaha and Kansas City, while from St. Louis it is \$30.50, Chicago \$33, and New York City \$50, with proportionate rates from every other place. To spread the knowledge of these rates the people of Portland are doing everything in their power, and leaflets are going out in almost every letter that leaves the city, advising the people that they can buy their tickets to any Oregon point just as cheaply as to Portland. Every city, town and village in the state should get busy in its own behalf to tell Eastern people of this fact. There is every indication now that the travel will be heavy. Every reader of this paper should take this article as a personal appeal and do his full share toward adding to the population of the state.

There will be a very important city election next month, in which the citizens are all interested because of the issues that will be presented. The principal point of difference between the candidates will be ownership by the people or by a private corporation of the public utilities, and in this respect it is likely the lines will be sharply drawn. It will not be a question of personality, but one of public interest that the voters will be called upon to decide. Therefore no person should sign the petition of candidates for office, thereby in a measure pledging himself to support that aspirant, until he has clearly decided for himself what policy in the administration of city affairs he feels that he should conscientiously support. The hasty signing of nominating petitions should be avoided.

All the doubt about the new railroad through Central Oregon has been removed by the definite promise of Secretary of the Interior Garfield that the proposed construction maps will be approved by March 4th. Forty million dollars will be expended by the Harriman people in building this line, but its benefits to the people of Oregon will be many times that sum.

"So while I greet you for yourselves, I greet you still more as symbolizing all of you one who leaves public life when I leave it; a man who made a real personal sacrifice when seven years ago he came here to take office at my request; a man who has stood over since as the type of what a good public servant should be; a man who for the last two years has been one of the most useful cabinet ministers who ever sat at the cabinet table—Jim Garfield."

BURGLARS ENTER
HANSON'S STORE
THROUGH SKYLIGHTTraded Their Old Clothing for
Complete Outfits of New—
Old Hands at Business

Two burglars entered E. Hanson's clothing store on East Ninth street last night and stole over \$75 worth of clothing, shoes, underclothes and other articles. The exact amount of goods taken is not known.

Entrance to the store was made through the skylight in the roof. A small cotton rope was used by the men to let themselves down to the floor of the store and the skylight was left half off, the rain coming in and damaging some clothing beneath it.

The burglars were bold at their work and did not seem to fear the officers. They changed their wearing apparel in the store, leaving their old clothing and each taking an entirely new outfit. One of the suits taken was priced at \$23 and the other at \$20. Good shoes, hats and underclothes were taken, besides a number of stick pins, ties, handkerchiefs and other articles. A small telescope grip was taken and it is evident that this was filled up with small articles.

The burglars left the building by way of the front door, leaving it open. The night officers did not notice it and it was first discovered when the store was opened this morning. A light was left burning in the store.

The safe, which is in the front part of the building was opened, the door having been kept unlocked, and the cash drawer broken open and taken to the rear of the store, but no money had been left in it. All the money that was taken was 35 or 40 cents in pennies which had been left in the cash till beneath one of the counters. The burglars evidently intended to fight had they been surprised by the officers in their work, for they placed a heavy nail pulley near the front door, probably intending to hit anyone who should come in over the head with the instrument. No other use was made of it.

The officers are working on the case but so far there seems to be no clew that would lead to the apprehension of the guilty persons. The clothing could easily be identified if the men were caught. The work was evidently that of old hands at the business and it is probable that they left town on the first train.

Patrolman Evans states that the front door of the store was not open at five o'clock this morning when he passed there on his way home. He saw the light in the rear of the store but thought it was a habit of the proprietor to leave it burning. This street is not on his beat.

Mrs. Grace Haskins today filed in the circuit court, through her attorney, I. N. Harbaugh, a petition for divorce against her husband, John G. Haskins, and for the custody of their minor child, Melvin Lee Haskins.

Mrs. Haskins alleges in her complaint that they were married at Cottage Grove on September 10, 1905, and says that her husband has been guilty of cruel and inhuman treatment, in that at one time he kicked her and knocked her against a wall, rendering her unconscious for an hour. At the same time he told her, she alleges, that if she ever spoke to her brother-in-law again he would kill her. He has also frequently cursed her, Mrs. Haskins alleges.
