

REBELLION AGAINST GEN. MADERO FORCES HIM TO RESIGN AS ACTING PRESIDENT

Juarez, May 13.—Rebellion within the ranks of Madero's army today resulted in declaring under arrest Francisco I. Madero, Jr., the provisional president, the demand and acceptance of the demand that Madero's cabinet resign, and for two hours threatened the destruction of the Juarez army as a concrete fighting force.

The excitement about the Madero headquarters was first observed about 11 o'clock, when General Pasqual Orozco and other military chiefs were seen in vehement discussion with Provisional President Madero, which gave rise to the report that insurrecto soldiers had demanded the life of General Navarro. The latter is said to be in disfavor with many insurrectos for alleged acts of cruelty in previous battles in northern Mexico, particularly at Cierro Prieto, where General Navarro is said to have ordered that the wounded be bayoneted.

Juarez, May 12.—The incident rebellion arose in the ranks of the army under General Orozco, one of the fighting leaders of the Madero army and was headed by Orozco himself. A demand was made on the Provisional President, Madero, for food and money for his ragged and hungry soldiers. Madero was unable to satisfy these demands at the time but his explanations were preemptorily thrown aside by the belligerent Orozco and his followers. Madero was declared under arrest. Finally the matter was settled by compromise from Madero that the immediate needs of the soldiers be attended to, and the insurrectos, who had gathered by hundreds around the headquarters, dispersed.

The trouble which has been brewing for some time, culminated today in the demonstration before Madero's headquarters. The insurrectos do not like the composition of Madero's cabinet and assert that favors are being shown various officers and the men of the rebel army.

Orozco demanded the immediate resignation of the Madero cabinet, saying scornfully they were incompetent; that Madero hereafter, must pay more attention to the needs of his soldiers. To this demand Madero acquiesced and finally the provisional president and his general embraced in true Latin fashion and the insurrecto rebellion came to end with the understanding that the cabinet would cease to exist and that the troops would be looked after.

How deeply the rebellion permeated the ranks of the insurrectos outside of Orozco's command is not reported. From the talk of the soldiers who appeared to be dissatisfied with the condition of affairs during the last few days the trouble is widespread and nearly the entire insurrecto fighting force in Juarez is affected.

Navarro in El Paso. General Navarro, leader of the defeated federal forces at Juarez, against whose life threats were made by the angry insurrectos, today was personally conducted across the river shortly before noon by Provisional President Madero, and forced the river to the American side. Navarro was followed into the river at points above Washington park by mounted ranchmen as the only escort, and

they disappeared from view on the American side. It is not known in which part of El Paso the federal leader has taken refuge. Later it was reported the river was too high to ford and Navarro returned to the Mexican side. Brighter Peace Outlook. Prospects for restoring peace in Mexico are brighter today, when the explanation given by Limantour to the Associated Press dispatch from Mexico City last night concerning Diaz' real intention about continuing in power, was read by officials of the provisional government. Most of the leaders were surprised to read that Judge Carbajal, the federal envoy, had sent a message by Minister Limantour after the Diaz manifesto was issued, asking the rebels to state in what terms they wished the Diaz manifesto to be made.

The rebel leaders declared that had such a message reached their ears and that peace negotiations would probably long ago have been resumed. At the rate conditions and prospects have greatly improved in connection with an ultimate peace agreement.

Women Leave Carranca. Naco, May 13.—Throughout last night a score of automobiles, sent from Arizona and other border points conveyed women and children out of Carranca in anticipation of a rebel attack on that camp. No excitement attended the movement, the women appearing to enjoy the adventure.

Conferences were held between the mayor and the rebel general, Carbajal, and the news that Carranca would surrender was not a great surprise here.

Town Will Surrender. Cananea, Sonora, Mexico, May 13.—Jose Carmelo and Tomas Lopez Linarez, representing the federal government, who are in conference with Juan Cabral, the rebel leader, are understood to be negotiating for the surrender of Cananea. It is said only a few minor details remain to be agreed upon, and that Cabral will undoubtedly occupy that town without any resistance tonight.

Later it was announced that the federal army had evacuated the town at 3 p. m.

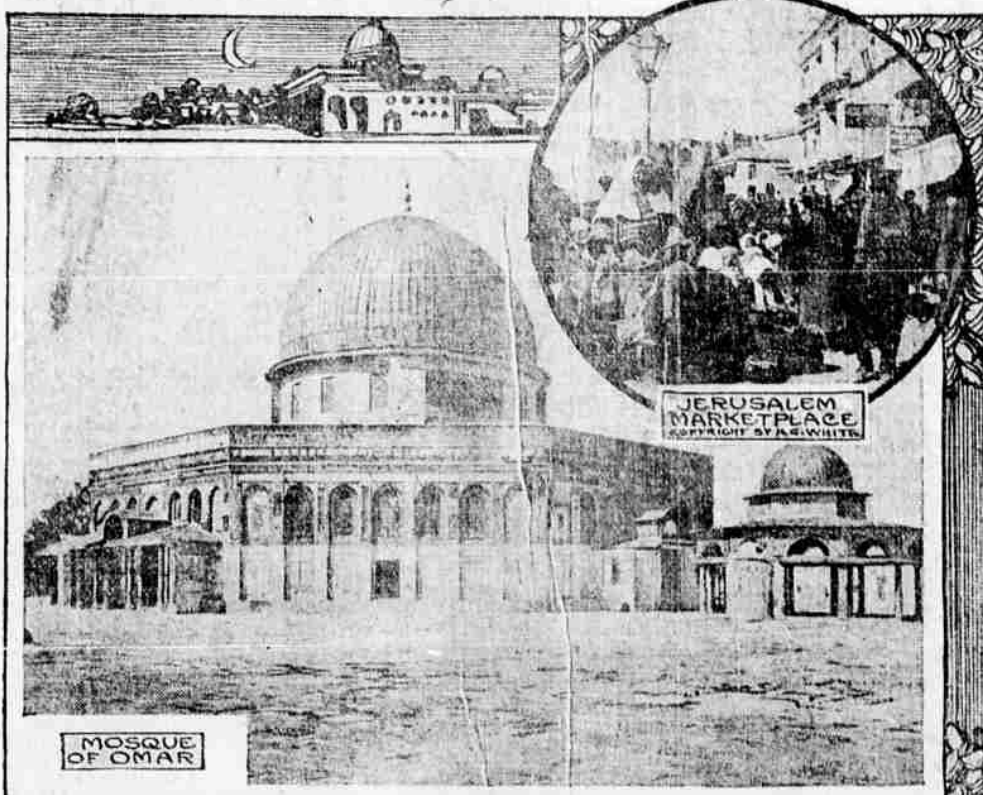
Reunion of New Arrivals on June 17. Big Picnic to be Held in Park Squares in Eugene, With Free Barbecue.

Robbery of the Mosque of Omar at Jerusalem; Articles of Great Antiquarian Value Stolen.



The Turkish government is conducting a vigorous inquiry into the reported robbery of the mosque of Omar at Jerusalem, which was built on the site of Solomon's temple. The objects stolen are said to be an old manuscript of the Bible, the crown, ring and sword of Solomon and numerous other articles of great antiquarian value. An Anglo-American syndicate of excavators is suspected of having had something to do with the depredations. Two years ago they obtained a concession to carry on an excavation work half a mile from the mosque of Omar. The conclusion is that a tunnel was dug, entrance effected from underneath and the treasures removed in this way.

DICKINSON QUILTS DESK OF WAR SECRETARY

Actuated Only By Desire to Retire to Private Life in Quiet Business

Washington, May 13.—Secretary Dickinson is engaged today in closing out his administration of the war department, preparatory to the relinquishing the office to Henry L. Stimson, his successor. The change will occur probably early next week. The new secretary, Henry Stimson was formerly a law partner of Senator Elihu Root, himself at one time secretary of war.

Why He Resigned. Nashville, May 13.—To quit public service when he reached three score years and spend the remainder of his days with his family and in quiet business pursuits, is responsible for the resignation of J. M. Dickinson, secretary of war. This statement was made here today by one of the secretary's close kinsmen.

There was no break in his relations with President Taft and Dickinson inspired his resignation, it is said.

MUCH GOOD WORK IS DONE TODAY BY STUDENTS

University Day Saw Great Activity on Campus—Cement Walk Built

Ideal weather conditions prevailed for "University Day" this morning on the University campus. Four hundred students took part in the effort to improve the campus, and the student laborers accomplished what would have cost several hundred dollars to the state. Under the direction of Louis Pinkham, the junior and seniors laid over 400 feet of cement walk west of Doody hill. The distance of 50 feet that was laid this morning nearly completes the stretch that has been built up year by year, all the way across the campus to Kincaid street. Another force of students labored in the construction of two new tennis courts adjoining the girls' court north of the baseball field. The courts were entirely completed, including the grading and rolling and placing the wire nets. Harold Bean laid a force of student painters that put a red coat on the roof of the forge shops and chemical store rooms, while another crew of painters, under the direction of "Bill" Main, put a brilliant yellow coat of paint over the big concrete "O" on the butte.

At noon all the student workmen were rewarded by the big banquet given by the co-eds in Villard Hall in which 1,000 students and their friends took part.

A wagon load of sandwiches, 1,000 ice cream cones, and gallons of beans, salads, pickles and potatoes were served. A cafeteria plan was followed, and the line, several hundred feet long, lasted for over an hour. After the dinner, songs by the students and the glee club were followed by speeches from President Campbell and members of the alumnus.

FRESHMEN BURN THEIR GREEN CAPS

A precedent was set by the freshmen of the University this afternoon at the track meet, when they marched past a bonfire and east their green caps, which they have worn since September, into the flames. From now until the end of the year they will be permitted to wear any headgear that they choose. This is a custom that has originated in Eugene and will be made an annual event during Junior week end. Up to today every freshman has worn no other head covering but a green felt cap, three inches (more or less) in diameter.

DIETZ GUILTY OF MURDER AND SENTENCED TO LIFE TERM IN STATE PENITENTIARY

Howard, Wis., May 13.—The jury trying John Dietz, Mrs. Dietz and Leslie Dietz on the charge of murder, brought in a verdict of guilty in the first degree against John Dietz and not guilty as regards Mrs. Dietz and Leslie.

Dietz will spend the rest of his life at hard labor for the murder of Deputy Oscar Harp, in the battle at Cameron Dam, October 8 last. The trouble dates back to 1904 when Dietz refused to allow the lumber companies operating in Sawyer county, Wisconsin, to float logs over the Cameron Dam, located on a quarter section bought by Mrs. Dietz, without paying the toll he demanded. In attempts to capture Dietz on various charges and legal processes, Oscar Harp, deputy sheriff, was killed, and several men wounded. Myra Dietz was shot through the body, Clarence Dietz wounded, and John Dietz shot in the hand. It was the tenth armed effort to take Dietz and he became a prisoner.

Before Dietz was sentenced he said it was the fight of a powerful organization, aided by the state, against a lone man. He said he had not been given an opportunity to tell the real facts, and made a motion for a new trial, which was denied, but he was given ten days to file a bill of exception.

Judge Reid advised him to employ an attorney. He has defended himself, saying he could not afford an attorney.

AUTO SPEED LIMIT REDUCED BY CITY COUNCIL OREGON WON FROM WASHINGTON IN TRACK MEET

Eight Miles an Hour on Willamette Street and 12 Miles on Others. Track Team Has Good Lead in the Tri-State Athletic Meet

The city council at an adjourned meeting last night passed an ordinance limiting the speed of automobiles to eight miles an hour on Willamette street, with a speed of six miles when turning corners. Twelve miles an hour is the maximum speed allowed on the other streets. Boys under 18 years of age are prohibited from driving autos on the streets.

A resolution was passed providing for the submission to the voters a proposition to issue \$130,000 refunding bonds and \$57,000 bonds for extension and improvement in the water and proposed lighting systems.

Plank's Bill. The police committee reported the bill of Night Policeman Plank, who was appointed by Mayor Matlock, but the appointment turned down by the council. He has been serving, though, and the bill calls for the sum of \$255. The bill was laid over.

The matter of opening streets in the western part of the city was again brought up by Warnock, chairman of the street committee, and the committee was directed to investigate the petitions.

The council refused to vacate the alley between Fifth and Sixth streets petitioned for by C. H. Hales, Chas. Mayhew and others.

Cement Walk Ordinance. Warnock recommended that the cement sidewalk ordinance be amended so that the line of the district will be changed to extend north westerly along the S. P. right of way from University avenue to Fifth street.

Chairman Ness, of the finance committee, recommended that assessments for street improvements other than paving be levied before April 1, 1911, be paid into the general fund, since the general fund advanced the money for the street work.

The salary of Albert Baker, assistant street commissioner was advanced from \$60 to \$70 a month.

An invitation from the City and Henry paving company for the city council to visit Medford to inspect the pavement there was read and Mayor Berger and the street committee will make the trip some time next week.

New Police Officers. Mayor Berger made his appointment of police officers as follows: Chief of Police—E. A. Farrington. (Reappointed.) Day police—J. O. Bristol. (Reappointed.) Night police—John Blanton, C. W. Sloat and M. J. Thompson. Blanton designated as night chief, subordinate only to day chief.

Fairmount police—J. D. McDonald. Health officer—Dr. Wall. Sewer Inspector Zell is given police authority, but will not draw salary as such except when serving as a special officer on different occasions.
