Hundred Men Will Go to Work Within a Week, Says Welch

Manager A. Welch of the Portland, Eugene & Eastern, arrived at noon from Salem, accompanied by Corvallis manager, Geo. D. O'Connor, and after eating a hurried lunch, left for Corvallis. Mr. Welch stated to a Herald representative that the work on the extension of the Corvallis and Alsea line from Monroe to Eugene would begin within the next week. He said that they would have a crew of 100 men at work with teams and scrapers in a very few days, and the work would progress as rapidly as the weather would permit.—Albany Herald.
