

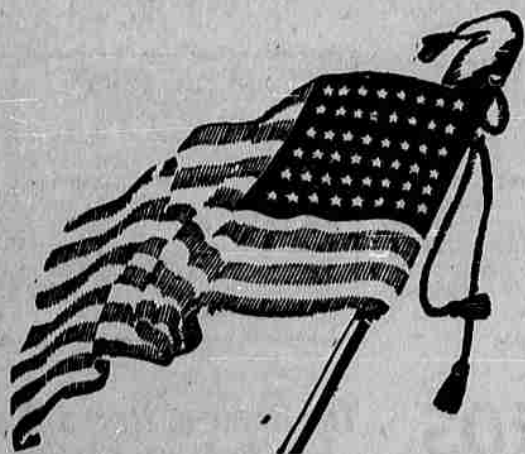

A LIBERTY BOND WILL HELP YOU

INTERESTING fact regarding the Liberty loan was brought out at the "Prosperity Banquet" last night, when it was stated that the money subscribed for bonds in Oregon would be spent in Oregon. Already the government has placed orders for lumber for 100 wooden ships and the money that is loaned by the people will be returned to them for the chief commodity of the state.

Many people have been laboring under the impression that the money derived from the sale of the Liberty bonds would go to Europe to be spent there, or that it would be loaned to the allied nations. These are mistaken ideas. We are to spend the money we loan the government. In other words we are to furnish the money to buy our own lumber, keep the money and let the government pay the interest. That means prosperity for Oregon.

But there was another interesting fact brought out at the banquet Oregon has not done her share. The Liberty bonds are not being taken as rapidly as had been expected, consequently the eyes of the world are on Oregon, the shame rests upon the people of this state for failing to do their patriotic duty. An opportunity has been given us to help ourselves and we have failed to grasp the idea, failed in upholding the nation in its direct hour of need.

"Come across, or Germany will," said A. L. Mills, president of the First National Bank of Portland, and no man is better qualified to speak on this subject. To allow the Liberty loan to become a fiasco means surrender to Prussia. What are you going to do about it?

THE WHY OF IT

THE OREGONIAN says that Linn, Lane and Clackamas counties have by their votes, announced that they do not want good roads, least of all a good trunk line through the state, and hints that we are likely to get what we voted for.

What mistake for a great newspaper like the Oregonian to make. AIRCRAFT MUST WIN WAR

GERMANY'S hope of winning the war through the use of the submarine has vanished, but she still has the most gigantic and complete war machine the world has ever known, and though the French and British may continue to make gains it will take years at the present rate to force the Prussians to their knees. Hope of victory lies not on land or sea, but in the air. And this is to be America's contribution to the success of the war. We are going to send airmen and aircraft to France as rapidly as possible.

The was never reasonable expectation that our flying squadrons would at once enter upon war duties; our men have much to learn and practice here and in the French aviation fields, and our manufacturers have had no experience with the sort of machines the French and British have developed in two and a half years of warfare. The difficulties the manufacturers have to deal with are of a more or less technical character, not easily overcome. But it is impossible to accept the statement that we are unequal to the full task. Precisely what is under way there is no sound reason perhaps for disclosing. There can be no harm in affirming, however, that we shall do better than current reports from Washington indicate.

Some 6,000 young men are ready for preliminary instruction in the art of flying. Before very long there will be groups of them in France undergoing training in the real business in hand. The advantages of helping our allies to obtain a secure ascendancy in the air is well understood in Washington, and no effort will be spared to accomplish this.

Land forces must hold the enemy in check, but the air forces must by the means of striking terror to the souls of the autocratic rulers of Germany.

At last the northwest has begun to feel the wave of prosperity and the indications are there will be more than we can take care of unless we "get a move on."
