

NAVY IS GREAT LIFE DECLARES STUDENT

George C. Colton Visits Eugene After 20,000-Mile Trip and Nine Months of Service.

After nine months in the navy and a trip of 20,000 miles, George C. Colton, University student, says that the navy service is about as good as anyone can get, and that the Friday the thirteenth on which he enlisted was a lucky day for him. "It's a great life," he declares.

Colton, who has just returned from South America, where he has been for some time, going as far south as Peru, spent the day here Saturday visiting with his fraternity brothers at the Sigma Nu house and with his many other Eugene friends. He is on his way home to Portland to enjoy a two weeks' furlough with his parents while waiting to be transferred to the aviation branch of the sea service, in which he says "There is more chance to get ahead."

He was among the first of the Jackies

to arrive in South America after war was declared, and the people there were very glad to see the boys from the United States and made them their guests, he said.

Colton enlisted last spring just before graduation, being a member of the class of 1917. While in college, he was prominent in dramatics, and was associated with the student publications, the Oregonian and the Emerald. He is now second class machinist's mate in the United States navy.

neglected his wife while they were touring England.

Mrs. Mooney, according to witnesses for the defense, was the nurse retained by De Saulles, through whom he is alleged to have tried to alienate his son's affections for his mother.

Regarding the automobile accident during a visit to Chile in which Mrs. De Saulles claims she sustained severe injuries to her head, Mrs. Mooney said a doctor took "three stitches" in Mrs. De Saulles' chin following the accident and that her mistress attended a concert the same night the accident occurred.

The defense maintains Mrs. De Saulles was confined to bed for several days following the mishap.

Mrs. Mooney said she had never seen Mrs. De Saulles cry "all the time I was with them." She told of many of the late and dinner parties which she said Mrs. De Saulles attended, escorted by her husband.

The witness said Mrs. De Saulles never complained to her of having severe headaches or periods of nervous exhaustion.

Countess Otto H. Salm, a cousin of John I. De Saulles, testified that when she visited Mrs. De Saulles in jail just after the shooting, Mrs. De Saulles cautioned her to be careful what she said "that there might be disfigurements about the jail."

"It's awfully nice for you to come to visit a murderer," the Countess said Mrs. De Saulles told her.

At 10:50 o'clock Charles I. Wood of counsel for the prosecution, began reading the state's hypothetical question. Dr. Isham Harris, superintendent of the Brooklyn state hospital, was on the witness stand while the lengthy interrogation was read.

It required twenty-eight minutes to read the question. Dr. Harris answered that he believed the defendant "knew the nature and quality of the act"; that "she knew it was wrong" and that she was mentally sound when she shot her former husband.

Dr. Charles M. Pilgrim, chairman of the New York state hospital commission, was next called to answer the district attorney's hypothetical question. His answers were identical with those made by Dr. Harris.

With the completion of Dr. Pilgrim's examination, both sides rested. Justice Manning then said or appeared certain the case would be submitted to the jury by tonight.

He recessed court at this point until one o'clock.

Both sides rested at 11:36 o'clock.

NEW WAR STAMP TAX IS EFFECTIVE TODAY

Brokers and Men Engaged in Similar Lines of Business Must Contribute Revenue.

Washington, Dec. 1.—The war stamp taxes counted upon by treasury officials to produce \$100,000,000 annually as part of the great revenue measure enacted by congress last October, became effective today.

From the beginning of today's business hours, every broker, exchange, clearing house and person engaged in stock, produce or merchandise transactions must keep strict account of the taxable dealings. The trial revenue bureau has issued comprehensive regulations to govern the collections. The taxes do not apply to bonds, notes or other instruments issued by the United States, by any foreign government, or by any state or similar governmental sub-division or to stocks and bonds of co-operative building and loan associations, operated exclusively for their members and loaning only to their shareholders or to mutual ditch or irrigating companies. The taxes include: Indemnity and surety bonds, fifty cents, except where premium is charged for execution of the bond the tax will be one per cent on each dollar of the premium and re-insurance policies are exempt.

Capital stock issue, five cents on each \$100 of face value; sales or transfers, two cents per \$100; produce sales on exchange or agreement, "for future delivery," two cents per \$100 or fraction over \$100.

Drafts or checks "payable otherwise than at sight or on demand, promissory notes except bank notes issued for circulation and for each renewal "two cents per \$100; deeds and conveyances fifty cents per \$100-500 and fifty cents each additional \$500, with all debt papers exempt.

Custom-house entries 25 cents per \$100 to \$1 per \$500; withdrawals fifty cents; steamship tickets \$1 to \$5; election proxies ten cents; power of attorney 25 cents.

Playing cards, five cents per pack, in addition to present two cent taxes; parcels post packages one cent for each 25 cents charged.

New York, Dec. 1.—The actual condition of clearing house banks and trust companies for the week (five days) shows that they hold \$152,122,450 reserve in excess of legal requirements. This is an increase of \$38,738,760 from last week.

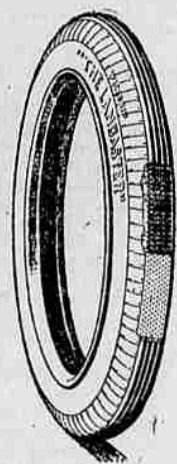
