

LANE MUST FURNISH 37 MORE SOLDIERS FOR NATIONAL ARMY

Nine Hundred Twenty-three Are Called to the Colors to Entrain for Camp Lewis Between April 25 and May 1.

The local exemption board received a telegram Saturday night calling upon Lane county for 39 more men for the national army. They must be entrained for Camp Lewis in the five-day period commencing April 25.

The quota of Oregon is 923 men and they are in addition to the 369 who were called into service March 29.

The 923 men comprise 12.5 per cent of Oregon's gross quota in the first draft. No county in the state will be exempted from furnishing its proportionate quota of men to meet this call.

At the same time it is announced by the war department that each county will receive full credit on the next draft quota for the men sent now.

Though men from class one are to be inducted into service in the sequence of their order numbers, the calling of men actively, completely and assiduously engaged in the planting and cultivating of farm crops, by direction of the president, will be deferred until the end of the new quota.

SOUTHERN PACIFIC WILL ADVANCE MONEY

A. J. Gillette, local agent of the Southern Pacific Railway has received a telegram from John M. Scott, general passenger agent at Portland, instructing him to take subscriptions to the third Liberty Loan from the employees of the road on the basis of the payment of ten per cent of the face of the bond for ten months. The employees invested \$3,702,500 in the bonds of the first two series, and it is expected by the officials that the record will be raised in the third drive. The telegram follows:

"Confidence is expressed that the response of Southern Pacific employees will be as prompt and unanimous as ever." The message wired to the officials of the line from San Francisco today reads: "Campaign for subscriptions to third Liberty Loan opens tomorrow sixth. Bonds will be issued in same denominations as before and bear four and one-fourth per cent interest. Where employees wish time on a subscription we will buy their bonds and allow them to repay in monthly installments extending over ten months if desired. Make active canvass for subscriptions and organize thoroughly for campaign in order to improve on our previous good record. Success of loan is needful for victory. Impress this upon every employee. Company and government alike look forward with certainty to final result of this loan campaign for us."

"The machinery of the Southern Pacific system was put into motion today in support of the third Liberty Loan. President William Sproule announced to the 45,000 employees of the Pacific system that the company will again care for the bonds for these employees who desire to participate in the loan. At the same time, telegraphic instructions were issued along the line to begin taking subscriptions at once. It is expected that the same good national rivalry will be shown by the various divisions as characterized the previous campaigns.

"According to the announcement the company will purchase bonds on the new loan for those of its employees who desire to subscribe and will permit these bonds to be paid for in installments over a period of ten months. This would be at the rate of \$10 a month for a \$100 bond. In the first Liberty loan employees of the Southern Pacific lines purchased bonds to the extent of \$1,918,800 in the second loan they participated to the extent of \$1,843,700. This made a total of \$3,762,500, subscribed already by the employees of this one railroad system."

ask that you give this matter your immediate and favorable consideration."

The committee report states that both the Agricultural college and the normal school replied assuring them that no alien enemies were employed in those schools. The report also cites the correspondence with the board of regents of the University of Oregon in the matter. Herman Swartz, an alien enemy was at that time employed as an instructor in German, but he has since left the University. Continuing, the report says:

"Governor Withycombe, upon receipt of our protest against the employment of alien enemies, assured us that he was heartily in sympathy with the sentiments expressed in our petition. His letter is as follows:

"This is to acknowledge and thank you for the communication signed by yourself and other representative citizens of Lane county in which you express objection to the employment of alien enemies in positions of trust and responsibility. I assure you that I am heartily in sympathy with the sentiments expressed in your petition and that I share with you the belief that this is a time to guard our institutions most zealously."

"On the 6th of March we received from the board of control the following communication:

"The Oregon state board of control met on the 4th instant, and your committee's protest against the employment of alien enemies was taken up."

"The board does not know of any persons in the employ of the state institutions governed by this board who would come under the purview of your petition. If anything of that nature should arise in the future, our body no doubt will take proper action to eliminate such employees."

"It will be seen by this letter that if they find any alien enemies in their employment they will eliminate them."

"We call your attention to the inconsistency of the letters from the governor and the board of control and the interview given out by the governor and the secretary of state on March 4th, which was published in the Oregonian of March 5th, and which interview is as follows:

"As long as alien enemies do their work and keep their mouths shut 'they will not be discharged.'"

"This was the ultimatum of the state board of control today after a petition was received from a committee of Eugene citizens asking that all alien enemies employed by the state be discharged. A similar petition has been sent to the various state schools. Signers of the document are J. S. Workman, Charles A. Burden, Edward Immel, Fred Fisk and F. M. Wilkins.

"If a man gives faithful service to the state and keeps his mouth closed I think it is right that he be retained in his position," was the comment of Governor Withycombe, after hearing the petition read.

"I believe it is up to the superintendents of the various institutions to handle their employees," said Secretary Olcott. "If the superintendent of any institution thinks he has a man in his employ who is not a fit person for the service he can discharge him."

"Secretary Godlin inquired whether an investigation should be held to determine whether the alien enemies should not be retained. The board declared that such an investigation was unnecessary."

"Therefore, we recommend to this league that all of these facts be given to the public press and that this undersigned committee be discharged."

FLAG IS DEDICATED AT COTTAGE GROVE

Large Crowd Assembles to Do Honor to Soldiers from that Community.

Cottage Grove, Or., April 8.—At least 3500 people assembled in Cottage Grove Saturday to witness the unfurling of the service flag, see the parade and hear the speaking. The parade started from the armory headed by the band and led by the home guard, the Boy Scouts, the bandage class and the Red Cross ladies of the town and auxiliaries. They marched through the principal streets back to the speaker's stand where they disbanded. The choir of 40 voices led by Mrs. Ray W. Glass, sang America, the Rev. Joseph Knotts led in prayer, after which the service flag with 158 stars and one gold star was unfurled and hung across the main street. Judge Shinn then introduced Lieutenant Simpson who gave a short talk, then Rev. D. A. McLeod gave a splendid patriotic address in which he lauded Major Harry Metcalf whose health would not permit him to go to the front. The other speaker, Mr. McColliey, of Portland then made a fine talk on why we should buy Liberty Bonds. The crowd sang "The Star Spangled Banner" and was dismissed, Saturday morning before the First National bank had opened its doors a gentleman was there to buy \$1500 worth of Liberty Bonds. switching tired troops to quiet sectors. The prisoners include boys and over-aged men. Hindenburg has hurriedly recalled recently exempted men. Prisoners agree that Austrian-German internal conditions are frightful, weakenings and the scrapings of humanity serving in some capacity in the ranks.

Jockeying continues on the battle front. Wherever the Germans occupy low ground, they make local attacks to win the ridges and other advantageous "kick-off" positions. Such was the motive for the Arras-Vimy drive and the drive for Bucquoy, where they wanted the high ground around Bucquoy, Hebuterne and Auchonvillers.

The enemy is striving for the high west of the Aisne valley, back of Albert and among the rivers converging on Amiens. The fighting hereabouts and to the southward is "on the cards."

In all this the cavalry, who have been waiting two years had their longed for chance with their sabres, galloping down upon advancing infantry, cutting up panic-stricken columns and holding bridge-heads. Further chances for the horsemen probably are coming.

The anniversary of America's entrance into the war was toasted throughout the British army, with generous speeches commending the material and historical importance of the event.
