

GIANTS WIN WORLD SERIES

MAPLETON-CUSHMAN ROAD CONTRACT SIGNED

BATTLE OF EIGHT YEARS ENDS WITH SIGNING OF PACT

Only Southern Pacific Endorsement Needed. Construction is to Start at Once, According to Contract.

The people of western Lane county won their fight of eight years' duration for a road to the valley, this afternoon when the county court and the Southern Pacific railroad company signed the contract for the Mapleton-Cushman road. This is the road the company agreed to build to take the place of the one used for the Coos Bay branch tracks in 1913.

Negotiations which have been going on between the county court and Ben Day, chief attorney of the Southern Pacific, for the last two weeks have gradually eliminated the points in conflict and yesterday Mr. Day returned the county court's contract declaring it satisfactory. Today the court signed the contract and sent it to Mr. Day, who will sign for the railroad.

Will Cost \$70,000
The new road will be about 13 1/2 miles long and will cost about \$70,000. It is said. This particular stretch of road is generally believed to be one of the most important in the country as it relieves and makes tributary to Eugene one of the richest sections of the valley.

Negotiations, lawsuits, public service and supreme court rulings have all figured in the dispute of the previous county courts and the railway company and have tended to divide sentiment in the county. It remained for Commissioner Emmett Sharp to champion the measure in the present court and start the negotiations which have led to the signing of the contract today.

Construction Starts at Once.
Construction of the road will start at once, according to the contract, and the county will accept the road in sections allowing people in the district to use parts of the road before the whole is completed. The county is to pay the railroad company \$10,000 when the road is completed as its share in building a much better road than the one used for the Coos Bay branch tracks. The new road will be eight feet wide on solid earth, plus whatever width results from the grading and excavations. Less than half a mile of the new road will go over five per cent grade and none of it will exceed eight per cent.

Western Lane People Jubilant.
Western Lane people in the city today were jubilant over the signing and declare it will be a splendid highway. They also praise the local business men for supporting them by the signing of the petition representing their sentiments, to the court.

The opposition to the contract and the \$10,000 clause seems to have vanished. The new contract signed is essentially the same as the old except it sets out in detail some of the engineering plans. All members of the county court signed the document.

PAVEMENT CUTTING ORDINANCE CHANGED

Prohibiting the cutting, digging or tunneling under in any way of any of the pavements or curbs of the city without first getting a proper permit, an ordinance was passed at last night's session of the city council. The new ordinance repeals one enacted in 1914.

Any plumber or other person who would cut the pavement must first get the approval of the city engineer and then a permit from the city recorder. A deposit is required to be made to force the person cutting the pavement to back in as good condition as it was found before.

A permit to improve the Campbell building near Seventh avenue on Williams street which has recently been vacated by a meat market, was refused by the city council.

The council authorized the finance committee to hire an accountant to compile estimates for the budget board as required by law.

BRUMFIELD PALE AND FRIGHTENED IN CAR, IS WOMAN'S STORY

Mrs. Bowman Thought She Saw Feet Protruding from Dentist's Automobile. Other Witnesses Tell of Trip Through Roseburg.

Roseburg, Ore., Oct. 13.—Dr. Richard M. Brumfield sat in court today discussing the world series baseball contest while witnesses for the prosecution in almost endless parade, it seemed, added bit by bit to the pyramid of evidence District Attorney Neuner is erecting.

Mrs. J. R. Bowman testified that when she and her husband passed the Brumfield car south of the Russell cabin. Brumfield looked pale and frightened. He tried to close the door of his roadster, she testified but could not because of the protruding of what she thought at the time was a pair of feet. William Moore, a friend of Russell, the alleged murdered man, identified a pair of shoes and the bit of scalp, which he testified had belonged to Russell.

Ed Weaver and Ed Kohlhaugen testified they saw Brumfield the night of July 13 in the vicinity of Russell's cabin. Weaver said he had noticed blood on the pavement the next day near where he had seen the red roadster standing, with Brumfield apparently tinkering with the mechanism, the night of July 13.

Kohlhaugen also testified that later in the evening, about 10 o'clock, he saw Brumfield driving down the main street of Roseburg at 30 miles an hour. Vigil McMillen testified that 30 minutes later he saw Brumfield crossing the Oak street bridge headed toward Melrose, near where the car was later found wrecked with a headless corpse, later identified as Russell's, lying beneath it.

M. M. Meredith testified that the rifle found near Brumfield's wrecked roadster was Brumfield's. He told the court that Brumfield had visited his ranch June 26 and there had met Dennis Russell. The third planned a hunting trip but the plan was never carried out.

June Brown testified that the pocket knife found near the corpse was Brumfield's.

Defense Would Raise Objections.
Roseburg, Ore., Oct. 13.—Attorneys defending Dr. Richard Brumfield, on trial here under a charge of first degree murder for the alleged killing of Dennis Russell, today prepared to raise further objections to the absolute acceptance of the dead man as the vanished hermit sheep herder.

District Attorney Neuner yesterday brought witnesses up to the stand to testify to various incidents connected with the alleged murder.

Russell's sister testified as to the identity of the body found headless and charred under the wreck of Brumfield's roadster.

She tearfully fondled a bit of scalp with strands of hair clinging to it and between sons informed the court that no doubt existed in her mind but that the gruesome relic had once belonged to her brother Dennis.

Bowman Fails to Help State.
J. R. Bowman, who claimed to have seen Brumfield carrying a large bundle in his car the night of the alleged murder, failed in his effort to help the state's case. Several details of his story yesterday differed widely from his story to the grand jury.

C. A. Steltzer gave the state the greatest boost when skillful cross-examination by Attorney Rice failed to shake his story that he had been on the highway at a point on the route the alleged murderer is supposed to have taken on its terrible course that night.

Time and time again the defense yesterday pointed out the impossibility of the testimony brought on through state's witness testimony. The show of strength evinced by Rice and Orent in what was considered masterly grilling of the first battalion of Neuner's "invisible sixty" witnesses gave rise to the belief that Brumfield's case is far from hopeless.

It was freely predicted today that the state would complete its submission of testimony Friday noon.

GERMAN GETS DECISION
Portland, Ore., Oct. 13.—A. B. Mishkin, Salt Lake batter, fought a toe-to-toe slugger with Joe Gorman at the armory here last night, but lost the ten round decision to his heavier-hitting opponent.

Mishkin refused to stay down under Gorman's avil chorus. Aside from a knock-down in the first round and a few saggy moments here and there, the Salt Lake fighter fought back at the local boy like a tiger.

BRUMFIELD AVID BASEBALL FAN; FAVORS GIANTS

Roseburg, Ore., Oct. 13.—Dr. Richard M. Brumfield, alleged arch-murderer, whether innocent or guilty, has nerves of tungsten steel hardness, according to Sheriff Sam Starmer and his fellow jailers.

Brumfield is betraying the greatest amount of interest in the world series and is a strong "puller" for the Giants to win.

This morning he was still avidly devouring details of yesterday's close contest from sport pages furnished him by Sheriff Starmer.

A popular fiction magazine lay upon his bunk, opened at the place where the first installment of a serial story appears. Apparently Brumfield is the last person in the world to believe he will not be able to pursue his subsequent installments.

Mrs. Brumfield is second only to her husband in her mastery of herself. Faced with complete collapse in court yesterday, she took a firm grip on herself and this morning was said to be in excellent spirits.

CONGRESSMAN SAYS PEOPLE WANT RELIEF FROM WAR TAXATION

"The people of this country want immediate relief from the tax burdens of wartime and a speedy refunding of the war debt," Representative C. N. McArthur told 79 members of the Chamber of Commerce in his talk at the regular weekly luncheon at noon today. The congressman summed up some of the important measures now before congress and criticized the slow functioning of the senate.

Mr. McArthur declared that the house passed many bills aimed at relief from burdens of taxation, the elimination of waste and duplication but that the senate talked and talked, and consequently few bills had become laws as yet. The time is coming when the people of the United States will demand that the senate put a reasonable limit on the length of debate in the same manner as the house has done, the speaker said. At the present time all western senators favored limiting debate.

Debt Interest Great.
The interest on the debt of this country is greater than the debt was itself before the war, said Mr. McArthur. The speaker said in his opinion the revenue bill should be passed at once by the senate in order that business men of the country would know how to proceed and the burdens of taxation would shift to where they are felt the least.

The congressman paid a compliment to Colonel Forbes, new head of the veterans aid bureau, whom he said was one of the big men of the administration. He declared Colonel Forbes had discharged several thousand surplus checks in the different bureaus and had consolidated the management under one head. This he said was not only saving the government much money but was insuring more speedy relief to those whom the nation has obligations. He characterized the recent bill under which the new veterans' bureau works as one of the most constructive pieces of legislation passed in many years.

McArthur Sees Savings Ahead.
Mr. McArthur declared that he believed that \$900,000,000 would be saved by the passage of bills aiming at readjustment now in congress, and the functioning of those measures that are now laws. He particularly lauded the new budget bill and declared that the best feature about it was the appointment of General Daves as budget director. He said that Daves was accomplishing wonders in eliminating waste and duplication. The budget director has already saved \$15,000,000 in the department of public printing alone, said the congressman, and he is making similar slashes in other departments.

JERSEYS SELL HIGH.
Salem, Ore., Oct. 13.—At the sale of purebred Jerseys held yesterday from the McArthur & Stauff herd, 10 miles west of Salem, the average price of female cows was \$995.

There was a large attendance of buyers from all parts of the Willamette valley. One telegraphic bid came from Port Triakley, Wash., and another from Hood River. Allan Bellinger of Scotts Mills was one of the heavy buyers. He paid \$1970 for four of the purebred Jerseys.

The McArthur & Stauff herd is officially recognized as one of the leaders in the world in record production in the 30, 90, 90 and 120 days records.

A total of \$110 in cash, \$80 in merchandise and a silver trophy cup will be awarded to exhibitors at the Rogue River Apple exposition at Medford October 29.

PRESIDENT, LEADERS OF CONGRESS, WILL BE AT KNOX FUNERAL

Senate Pays Tribute to Illustrious Pennsylvania Solon, Who Died Last Night After Sharp Attack of Apoplexy. Last Rites Will Be Friday.

Washington, Oct. 13.—The senate today paid sorrowful tribute to Senator Philander Chase Knox of Pennsylvania. As soon as the senate met, Senator Penrose announced formally the death of his colleague and proposed a resolution providing for a committee of 7 senators to take charge of the funeral.

The resolution was adopted and as a further mark of respect the senate at once adjourned until tomorrow.

Washington, Oct. 13.—President Harding and all high officials in the government, with leaders in congress, will attend the funeral services of Senator Philander C. Knox, which will be held here tomorrow morning.

The burial will be near Knox's summer home at Valley Forge, Pa.

Senator Knox died suddenly when he was stricken with apoplexy at his home here just at the dinner hour last evening.

He collapsed and died within less than half an hour.

The shock of Knox's death came with even greater force because he had just returned this week from a vacation in England.

He told his friends and colleagues in the senate that he felt much rested and that this vacation had done him great good.

The senate will adjourn today upon convening and will appoint, together with the house, a committee to have charge of the funeral.

Services here will be held at 11 o'clock in St. John's Episcopal church, "the president's church," near the White House, after which the body will be sent to Valley Forge.

LANE WOMEN HURT IN AUTOMOBILE MISHAP

One Eugene woman, Mrs. D. E. Daniels of 677 Pearl street, and her small son, fortunately escaped serious injuries yesterday morning when a car in which they were riding capsized over a 12-foot bank near Salem, turned turtle and pinned them underneath. The three women occupants and a baby are in a Salem hospital recovering today. The accident occurred about eight miles south of Salem on the Jefferson road.

Mrs. R. G. Ashby, of route 3, Salem, is suffering from a dislocated shoulder and bruises; Mrs. W. H. Nearinghoff, of Creswell, who was driving, received a fractured collarbone, and Mrs. D. E. Daniels of this city sustained bruises. Mrs. Nearinghoff's infant child is suffering from lacerations near its mouth and bruises, while Mrs. Daniels' small son escaped unscathed.

An unexpected tug at her arm by the baby whom she was holding as she drove, caused the car to swerve and fall over the embankment, according to Mrs. Nearinghoff's statement.

Dr. E. E. Fisher and Charles Niemeyer both of Salem, rescued the party from the wreckage and gave first aid. All of the party will recover, although the automobile is practically demolished.

THREE EUROPEAN POWERS NAMING MEN FOR PARLEY

Briand Will Attend Armament Conference. It is Officially Stated. Lloyd George Will Also Come.

From Great Britain, France and Italy today came either official or authoritative announcements regarding their delegations to the limitation of armaments conference in Washington next month.

Evidence of increased European interest in the conference and of the importance attached to its discussions was seen in the decision, contrary to expectations, personally attended, contrary to expectations, and in the official French announcement that Premier Briand would head France's delegation. Italy named three of its most prominent statesmen and announced plans for the sending of army, navy, and aerial advisors. Britain was cheered by the report that Lloyd George had influenced the premier to reach this decision. The appointment of Lord Lee as another of the British delegates was also confirmed.

YANKEES, WITH BASES LOADED IN 4TH INNING, FAIL TO PRODUCE RUNS

Final Score is 1-0—Roger Peckinbaugh and Waite Hoyt Jointly Responsible for Their Team's Defeat—Art Nehf Pitches Brilliant Game—Babe Ruth, with Infected Arm Swollen Twice Normal Size, Tries Pinch Hitter Role in Ninth Inning, but is Out on Easy Ground.

Polo Grounds, New York, Oct. 13.—John McGraw's Giants became the baseball monarchs of the universe here this afternoon when they defeated the New York Yanks, 1 to 0, in the eighth and decisive game of the world series.

Roger Peckinbaugh, the Gibraltar of the Yank infield, fell down in the first inning and paved the way for the Giants' only run. Waite Hoyt, the Brooklyn youth, was jointly responsible for the victory of the Giants. Hoyt put the winning run on the bases when he walked Bancroft.

Peck then muffed up Kelly's grounder and Bancroft was over the plate with the run.

Arthur Nehf, twice defeated in the series, came back and pitched a brilliant game.

He wobbled several times, but was saved by the brilliant work of his inner defense.

The great Babe Ruth, with his arm swollen to twice its normal size, disobeyed orders of his physicians and went in as a pinch hitter in the 9th inning, trying to ward off what then looked like certain defeat. The sweat king failed and went out on an easy grounder.

The Yanks had their big chance in the fourth. With two down Pipp and Ward singled and Nehf, losing control momentarily, walked Baker, filling the bases. Schang came up and drove a long fly which Burns pulled in for a fine catch.

Rawlings' great work at second base and at bat, and the work of George Burns, were features of the Giants play.

Cold weather made the crowd a big disappointment, as there were not more than 20,000 in the stands.
