CHARRED CORPSE IS DISCOVERED HERE WOBBLIES ARE EJECTED FROM PORTLAND

STRANGE BODY FOUND BURNED IN HOBO CAMP

Remains of Mysterious Derelict Discovered By Workman Across River From City; Identity Is Unknown.

Burned to death by his camp fire an elderly man, whose name is said to be Young, was found this morning near a little shack across the river from Eugene. How he came to burn to death is a mystery of the hobo camps. As the body was found in a hobo camp, it is probably never to be known as the man's clothes were practically burned off him and his body blackened beyond any recognition.

Body Found by Workman

The old man's body was found this morning by a workman passing along the road who notified E. B. Chase of the Chase Gardens. Mr. Chase reported it to the sheriff's office and Coroner W. W. Brunstetter took charge of the body. The old man was first seen near the shack last Sunday. He told Mrs. Homer Hays, who lives nearby, that his name was Young and that he was 70 years old. His first name or from whence he came was not learned.

THREE SPEAKERS TO OPPOSE SCHOOL BILL

Three prominent speakers will stump Lane county next week in opposition to the compulsory school attendance bill, speaking at all the larger places. The men are appearing here under the auspices of the non-sectarian and Protestant religious community. They are appearing at the meetings in the county. J. D. Stevens, 75 years old, veteran of the civil war, will speak at the first meeting at 3 o'clock Sunday afternoon at the high school auditorium. Mr. Stevens, wounded at Gettysburg, walks on crutches. He is a strong speaker and student. He has lectured at the University of Oregon on Shakespeare. He speaks at Springfield Monday evening, at Wallerille Tuesday evening and at Creswell Wednesday evening. W. D. Wheelwright, of Portland, will speak at the court house in Eugene on Thursday evening. Mr. Wheelwright is a lumberman and shipping man of Portland and is regarded as one of the county's biggest business men. Dr. Will F. Martin of Washington, D. C., field secretary of the Religious Liberty Association of America, will speak at the meeting at the armory Thursday evening. The three speakers who are appearing here next week are said to be exceptionally strong orators. All are national in reputation and will undoubtedly draw big crowds.

Sid Marks Loses Chance For Title

New York, Oct. 21.—One round and 20 seconds of another, and a left hook effectively dispelled any championship hopes of one Sid Marks and established Charlie White as a formidable contender for the lightweight belt. In the true sense, it was not a fight. The first round found both men feeling at least one another. As the second round opened, both seemed to have learned what they wanted to know and the news was anything but encouraging to Marks who appeared decidedly uneasy and was practically beaten before White snipped a savage left hook over Marks' guard and ended the bout.

25 Animals Burned to Death In Fire In Zoo

Indianapolis, Mo., Oct. 21.—Twenty-five wild animals were burned to death, while terrifying jungle cries awakened the town, when the zoo here was destroyed by fire today. Caged bears, and other animals were consumed in the flames, which destroyed three wooden animal houses. Keepers saved two bears. The fire was believed of incendiary origin.

Seventy-five Industrial Workers of the World, announced Chief of Police Christensen, entered the city this morning at 7 o'clock and he warns householders to leave nothing loose around premises, in order that there be no petty thieving. No violence is reported, however, and it is doubtful whether any will be attempted, for if reports from Portland are true the wobblies are a pretty well behaved bunch. Notwithstanding, Chief Christensen believes it will be good policy for Eugeneans to leave nothing loose in automobiles parked on downtown streets, to keep doors and windows locked and no washings on the clothes lines. Should any of the visitors be found vicious, or in any other circumstances that demand police action, he urges hurried telephone calls to police headquarters.

COTTAGE GROVE HAS NO CITY CANDIDATES

Cottage Grove, Oct. 21.—The campaign for city offices at the approaching election lacks much of the pep which characterized it two years ago, at which time the so-called progressives put together into the campaign. With election but slightly more than two weeks away not a candidate has come forward for any office. The terms of George O. Knowles, mayor; Herbert Eakin, treasurer; Homer Galloway, recorder, and Cornelius McKinstry and Markin, expiring in addition to these, the alternate position of S. V. Allison is to be filled, because Mr. Allison has moved into another ward. Mayor Knowles, who is a candidate for democratic representative from Lane county, is so busy with his legislative campaign that he declines to take part in city politics. Galloway will be a candidate for re-election as recorder and Herbert Eakin will also likely run again. Cornelius McKinstry and Veatch have both announced that they are through. A citizens' caucus will be held Wednesday night in the armory.

WALLIE REID SUFFERS NERVOUS COLLAPSE

Los Angeles, Cal., Oct. 21.—Wallace Reid, frontispiece film star of the flappers' scrap books, has suffered a nervous collapse and will be off the screen for at least a month, reports that he was critically ill, however, were denied at the Lasky studios where it was said that Reid had been given a few weeks vacation to recuperate thoroughly. Reid, it was said, is suffering from a malady peculiar to the movies, as "Klieg Eyes" due to the use of blinding "Klieg" lights in the filming of motion pictures. He was forced to stop work for a time, but returned before he had been fully recovered and again obliged to stop. This illness added to the fact that the star was extremely worn out from long continued work, caused him to ask for a temporary leave. Dorothy Davenport, his wife, accompanied Reid to a mountain cottage where they will remain for several weeks while he becomes rested. In the meantime Jack Holt has substituted for Reid in the picture in which he was working and Reid will start a new picture when he returns, it was said.

Petition Road to Be Located On Siuslaw

Asking that the Glendora-Ada road bond project No. 24, be located along the south bank of the Siuslaw river to the south end of the South slough, a petition was received by the county court today signed by 23 residents of the coast section. From the South slough the road will join the old road, according to the desire of the petitioners. Many of the signers of the petitions do not live in the vicinity of the road and as the other route leading southeast from Glendora would serve many farmers, a decision has not been reached by the court. The routes will likely be checked over by the engineers before the road is located.

Offers Tiny Tot for One He Ran Over

San Francisco, Cal., Oct. 21.—Frantically striving in vain to restore a life they are accused of having taken, Charles Buckley and his wife today offered their five-year-old boy as a tiny tot to fill the vacant place in the home of Frederick Newton and wife. Two days ago Buckley was arrested charged with having killed four-year-old Marion Newton when he drove his automobile into a crowd at a safety station. For 36 hours he seemed forgetful of what he was accused of doing. Then, suddenly, both Buckley and his wife, seemed to sense the tragedy in the Newton home. "We will give them our own child," Buckley said, calling an officer to his jail cell. "Yes, we will," slowly spoke Mrs. Buckley. "We'll do it if it kills me." "Would to God I could take Marion Newton's place in the home of the Rev. Newton's place," prayed Buckley. But Marion's place was still vacant today and her dolls waited in vain for the touch of a tiny hand. "No child can fill the place of my little Marion," sobbed Mrs. Newton.

WIFE'S CHARGES OF MURDER HELD FALSE

San Francisco, Oct. 21.—Authorities today characterized as "without substantiation" charges made by a woman ascribing divorce that her husband was connected with the murder of the Rev. Father Heslin, Colton, Cal., priest, more than a year ago. The charge, made through William P. Herron, local attorney, who was interested in the defense of William Hightower, now serving life for Father Heslin's murder, was to the effect that the husband was the "small dark foreigner" once described by Hightower in his remarkable accounts of the crime. Hightower, when he led police to the spot where Father Heslin's body was found, told them a "small dark stranger" having given them "Dolly Mank" a woman whom he knew, the information which led him to the discovery of the body. The woman claimed her husband had told her he and Hightower had kidnaped the priest and murdered him. Hightower, at the penitentiary, was confronted by the woman and declared he knew nothing of her or her husband.

MONARCHIST REVOLT IMMINENT IN BERLIN

Berlin, Oct. 21.—Police in Berlin are under orders to be on the alert to crush a new monarchist revolt which is being plotted, according to documents seized by the government agents in raids. The plot was to include assassination of "chancellor Wirth." The police came into possession of letters showing there were two plots against Wirth. The chancellor mentioned these designs on his life in a speech to the Reichstag, but said he would "carry on" as usual. His personal guard has been strengthened. One of the men planning Wirth's murder is said to have confessed at Leipzig. He gave the name of Schultz. Another man was arrested in the Rhineland. The chancellor is receiving large numbers of threatening letters, especially from Leipzig.

Garnishee Verdict Given to Defendant

A verdict in favor of the defendant was returned in the case of the Bank of Commerce against D. C. Dudley in circuit court this afternoon. The suit was to garnishee the defendant and involved an automobile. The jury consisted of James Campbell, W. A. Heck, George J. Gormack, Alfred Wayne, Mand Brown, Emma Wiley, Claud Holcomb, Nettie McKinley, Harold Edwards, Lizzie A. Daniels, James Roberts and John Hubbard. The jury was dismissed until Monday morning when it will take up the case of the state against Katherine Estol Easons, indicted on four counts for larceny and burglary.

BRITISH PREMIER OPENS FIGHT TO GET BACK POWER

Lloyd George Greeted Enthusiastically By English Public and Is Encouraged In Contest For Premiership.

Leeds, England, Oct. 21.—"The banner of party strife has been hoisted at the Carlton club. The people must decide whether the party or the nation comes first, I stand for the people." With these words Lloyd George today opened his campaign for restoration to the premiership, in a speech delivered to a crowd of 5,000 here. The former prime minister who is fighting to form a new party and stage a "reshuffle" when he places himself in power again, was greeted with enthusiastic applause wherever he appeared in public. The Welsh wizard is known to be tremendously encouraged by the rousing reception he has been accorded. He believes he is gaining votes every hour for his battle with the Tories, upon whom he has declared war.

Dons Fighting Togs

"My sword is in my hand and they shall feel its weight," declared, in one of his speeches from his railway carriage on the trip to Leeds. With the coalition broken up and Bonar Law endeavoring to form a conservative ministry, Lloyd George is concentrating all his efforts on forming a strong and dangerous Georgian party which he expected to see enter the house of parliament after the next election. Lloyd George is happy, eager and full of his old fire. His eyes twinkled with pleasure as he shouted every hour around his railway carriage and pressed against police lines to cheer him as he rode through the streets. He seemed to enjoy being "on the outside looking in" for a change and displayed his usual energy as in his younger campaigning days. "The manner in which he addressed the crowds, was breezy and bantering. I think you for coming out to greet one of the unemployed," he said to the assembly at Bedford. Mrs. Lloyd George was at his side whenever he appeared and came in for her share of the cheers. Both Lloyd (Continued on page eight)

Pastor Quits Jail, Haggard, Broken Man

San Quentin Penitentiary, Cal., Oct. 21.—Gates of San Quentin penitentiary opened today for the Rev. Madison Slaughter of Chico. Shortly before 8 a. m. the minister, who was serving 15 years for an alleged statutory offense against Gertrude Lamson, of Chico, left the prison after serving approximately seven years of his sentence remaining in effect for three years after today. The Rev. Slaughter was greeted at the prison gates by a group of old friends. It was understood that he would hurry to Porterville, Cal., where his wife is living and where it was said former parishioners of Chico had financed for him the purchase of a small ranch on which he intends to reside. Paid Society's Price. There was little of the dramatic attacks to the deputies of the former minister from the prison—unless, perhaps, a touch of it came from the bare prison routine. At six in the morning he was awakened and told by a trustee that this was the day on which he was to step into the world again. "Ah, at last I've paid the price to society," Slaughter was quoted as saying. In the office of the prison he was greeted by Myron Clark, captain of the guards, and given his civilian suit, together with hat, shoes, shirt and necktie—all made in the prison. Then Captain Clark handed him the \$3.40 with which a prisoner faces the world under the law of California. "Thank you," said Rev. Slaughter. He shook hands all around and wished all "good luck." Takes Tattered Bible. Then he shouldered a little bundle of personal belongings including his tattered Bible and started to the prison gates. "Here's a buttonhole for you, Doc," whispered a convict who stepped up and placed a flower in the minister's coat lapel. "Thanks, old man," said Rev. Slaughter, a ghost of a smile playing around his lips—which seemed to be a little forced. Slaughter breathed deeply of the fresh morning air—as if eager to drink in all of the regained freedom. "My debt to society is paid," he repeated to newspapermen as he turned to the outer gate of the prison. "My slate is clean. I start my life anew."

Municipal Utilities Pay Tacoma Large Dividends

Tacoma, Wash., Oct. 21.—The net earnings of the Tacoma municipal light department for 1922 passed the \$600,000 mark in September, according to the monthly report of the department presented to the city council today. September's contribution in net income was \$65,405.50. The month's gross earnings were \$80,904.10 and the operating expenses were \$337,358.88. After payment of other charges outside of bond redemption the net was \$600,961.42. The water department's earnings for September were \$47,479.65 and the operating expenses were \$20,255.52, leaving \$27,224.13 of operating profit further reduced by tax and other charges to \$7047.06.

CAMPAIN TO UNITE ALL WOMEN OF COUNTRY INTO THIRD PARTY IS TO BE STARTED BY LEADERS

She expects the result of the congressional campaign, in which 15 women are seeking office to demonstrate to the women voters just how far they are segregated in the men's parties. BAKER DEMANDS RADICALS STAY CLEAR OF CITY

Gov. Olcott Asked to Send Adjutant General White So Troops May Be Called For Duty If Crisis Grows Acute.

Portland, Ore., Oct. 21.—Portland authorities have served notice to the so-called "radical element" that it must steer clear of Portland. Preliminary steps toward the calling of troops for duty here have been taken. Developments during the night, it became known today, were as follows: 1—Mayor George L. Baker, issued a statement to the public explaining the waterfront strike situation as the authorities view it, and declared the existence of an emergency. 2—Mayor Baker wired Governor Ben W. Olcott requesting that Adjutant General White be detailed for duty here to watch the situation so that if need be, state troops may be summoned for duty in preserving order. 3—Mayor Baker wired the headquarters of the I. W. W. in Chicago, notifying officials there of action already taken here, and urged that the organization keep its members away from Portland. 4—More than 100 alleged vagrants rounded up during the night and the majority held on technical charges of vagrancy for arrest of court action today. Situation is Serious. Despite the warnings issued by the mayor that the situation in Portland is serious, police have discovered no signs of lawlessness, and in making arrests of alleged vagrants, have experienced no trouble in bringing the men to jail. No regular union pickets, patrolling the waterfront during the "lockout" of the International Longshoremen's union, have been included or included in the roundup of men from the I. W. W. hall and its vicinity, according to police and union reports.

Oblot to Give Aid

Portland, Ore., Oct. 21.—The executive office will go the limit. Governor Ben W. Olcott this morning proclaimed in answer to Mayor George L. Baker's appeal for co-operation in handling the problem of crediting I. W. W. involved in Portland's waterfront labor trouble.
