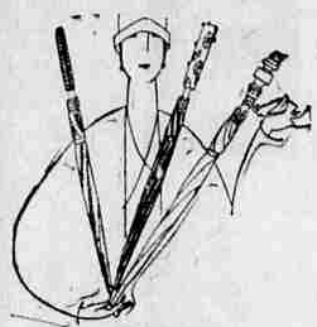

PORTLAND JURY INDICTS CLEAVER ON TWO COUNTS

PORTLAND, Ore., Feb. 3.—George L. Cleaver, state prohibition commissioner, was indicted today by the federal grand jury here on two counts on charges growing out of Cleaver's raid on the British steamship London Merchant in Portland harbor, December 17, 1924. The first count charges unlawfully entering the vessel, and the second charges unlawful seizure of a quantity of liquor on board the vessel. United States District Attorney Coke said the raid by the state dry officers on the vessel was a violation of the treaty between the United States and Great Britain. Cleaver was arrested by federal officers following the raid, but was released on \$15,000 bond.

INSTITUTIONS TO BE INVESTIGATED

STATE HOUSE, SALEM, Ore., Feb. 3.—Farming operations at some of the state institutions will be investigated by the ways and means committee it has been decided. The farm at the school for the deaf is said to be losing about \$6,000 a year, and some other losses have been ascertained. The farms at the training school for boys, the state hospital for the insane and the feeble minded institution are said to be making a profit. The ways and means committee has made cuts totalling about \$50,000 in estimated requirements of various activities, the main one being a slash of \$16,280 from the attorney general's department, where \$66,280 was requested and only \$50,000 tentatively allowed. For irrigation district interest bonds \$75,000 was asked and \$50,000 allowed.

CASCADE FOREST GETS RELIEF MAP

A relief map of the Cascade national forest is being completed today by Arthur Moses, chief clerk, and C. R. Lockard, junior forester, in the local forest office. This is the first relief map of the national forest ever made, and will be used in connection with forest protection work, to be celebrated here this spring. Lookout stations, road and trail work, telephone lines, right-of-way clearing on the Nathron cut-off, and other features are shown on the map. The elevations are accurate, and are based on statistical data compiled from other maps of the forest. The base of the map is of thick cardboard and modeling clay, and it is finished with plaster-of-paris.

STATE HOUSE, SALEM, Ore., Feb. 3.—House bill 499 introduced by Carlin, Jackson county, today, would repeal the quarter mill state road tax as provided for under section 4443 of the present code. The bill was the only new measure introduced in the house today. It followed a flood of 102 bills introduced yesterday, the last day for introducing bills without sending them through the legislative committee or by obtaining permission on the floor.

The mill was recently sold to Washington interests and it is expected that operations will be resumed and new mechanical equipment added starting in about 30 days.

Resigned Regrets

Major Gjedsted asserts in his letter to White and his letter to the officers of the guard that "when on July 28, last, after a heated session during which I tendered my resignation you requested that I withdraw my resignation and asked me to 'forget' the circumstances in connection therewith, and I in good faith gave you my promise, a promise I have kept to this day, to do so, and when you proffered your hand to bind the compact, I did not believe that you would so far demean yourself as to break that faith. However, just as soon as you deemed it expedient to do so, you not only broke faith and repudiated other promises you had made besides, but went to further extremes in an endeavor to justify your actions. In view of the circumstances, I must ask you to release me from any promise I have made with regard to yourself and, in event of your failure to advise me to the contrary, I will of course consider myself so released and free to do as I may deem expedient."

Author of School Tax Bill Withdraws

STATE HOUSE, SALEM, Ore., Feb. 3.—Following a sharp attack by Representative Woodward of Multnomah county, and Graham of Washington county, on house bill 196 by Hercher of Douglas county, providing for a property tax qualification for school district voters, the author withdrew it. Woodward and Graham pointed out that the measure would bar people from voting on tax measures and bond measures even though they were buying property on contract and in reality been owners for years. Six bills were passed today including house bill 266 cutting down the boundary limits of the game refuge along the upper Columbia river.

Pate Found Guilty By Klamath Jury

KLAMATH FALLS, Feb. 3.—W. A. (Sim) Pate, co-plotter of the robbery of a local gambling house here last month which terminated in the murder of Oscar Erickson, was convicted of first degree murder today. The jury recommended life imprisonment. The verdict was returned to Circuit Judge C. M. Thomas shortly before 11 o'clock this morning, after 19 hours of deliberating. John O'Shea, reputed driver of the auto which took the robbers to and from the scene of the crime, went on trial on the same charge this morning. Healing Measure Filed in House

STATE HOUSE, SALEM, Ore., Feb. 3.—Strict qualification of all persons seeking to practice healing arts in Oregon would be required under house bill 391 introduced by McCallister, Marion county, yesterday afternoon. It would put a definite educational requirement on all persons practicing healing arts, excepting dentists, opticians and Christian Science practitioners.

Post Primary Bill Passed by House

STATE HOUSE, SALEM, Ore., Feb. 3.—The house passed the Mills post primary measure on to the senate for final disposition when the bill came up for third reading yesterday afternoon. Verbal pyrotechnics marked the bills two hours tarrying during debate in the house. The vote was 32 to 27.

House bill 102, which would provide for a pre-primary convention, has been held back until house bill 85, the Mills measure is finally disposed of. The indication is that it will go the same route, the house passing it to the senate.
