

# VIOLATORS OF DRY LAWS ARE RAPPED IN HOUSE MEASURE

STATE HOUSE, SALEM, Ore., Feb. 18.—Prohibition law violators may be put to work on rockpiles by a bill passed by the house today. The measure is known as house bill 284, which has passed the senate and signed by the governor.

The use of mines on coast streams entering the Pacific south of the Columbia is prohibited by house bill 284, which has passed the house today. The senate has passed house bill 200 providing for creation of the Warner game refuge in Lane county.

The senate passed house bill 200 authorizing irrigation districts to enter into contracts with the United States government according to "fact finders" bill.

The house defeated the Banks bill providing for appeal from council license revocations.

Senate bill 173 requiring adjustment of claims under the Cary irrigation act passed the house.

The house passed senate bill 177, setting a speed limit of five miles an hour for entering a highway from a cross-road.

The veto of Governor Pierce was sustained by the senate yesterday on house bill number 91, which had for its purpose the authorizing of the state textbook commission to obtain the lowest possible price text books for the purchase of which the publishing companies refused to extend contracts.

A strong fight was made in the senate yesterday afternoon against house bill number 215, increasing the salaries of the district attorneys of Oregon, but not quite strong enough to keep the bill from passing.

# MINISTERS BACK Y. M. C. A. DRIVE

Eugene ministers are giving their unqualified support to the annual Y. M. C. A. budget week campaign being held this week to raise \$12,500 necessary to carry out the work of the association for the ensuing year.

Interviews with practically every Eugene pastor indicated that the Eugene churches are heartily in accord with the work being conducted by the Y. M. C. A. The influence upon the younger men is held in particularly high esteem by several of the pastors.

Rev. E. V. Stivers, pastor of the Christian church believes the Y. M. C. A. exerts its influence at a time when the young man needs it most.

"I believe the greatest benefit from the Y. M. C. A. are derived by the boys reaching the high school age. Right at present there seems to be a great tendency towards juvenile delinquency, and the need for curbing this delinquency is great. The 'Y' has a strong effect in the right direction and the work should be continued. It is a fine asset to the moral and religious life of the community."

Rev. Charles E. Dunham, pastor of the first Baptist church, is heartily in sympathy with the work of the Y. M. C. A. and is particularly interested in the help given to boys of high school age.

"I'm willing, not only to give my moral support to the 'Y' campaign for funds, but I'm willing to give material support as well," Rev. Dunham declared.

Rev. A. H. Saunders of the First Presbyterian church expressed appreciation of the work of the local association.

"I have been in cities where there were no Y. M. C. A. and I have seen in others, like Eugene, where a Y. M. C. A. makes it makes in the church work. Here in Eugene we are getting particularly fine cooperation with the secretarial force in the church activities. It's work I commend very highly."

Rev. E. L. Winterberger, pastor of the Fairmount Presbyterian church is heartily in sympathy with the work of the Y. M. C. A.

"The activities are a splendid demonstration of what is needed in Eugene," said Mr. Winterberger. "I would like to see the campaign highly successful. I have been particularly impressed with the work among the younger boys, and I am only sorry that I cannot do more personally to help the campaign."

She was a member of the Methodist church for many years, and the mother of eight children of all whom survive: William H. Widner of Eugene; Theodore Widner of Portland; George Widner and Mrs. J. W. Donovan of Junction City; Mrs. Chas. Lamber of Marshfield; Mrs. Myrtle Endicott and Mrs. Grace Vales of Portland; and Mrs. Daniel Barker of Harrisburg. Twenty-five grandchildren and 15 great-grandchildren also survive.

# SENATOR JOSEPH MAKES PLEA FOR POWER MEASURE

STATE HOUSE, SALEM, Ore., Feb. 18.—Senator George W. Joseph made a plea before the senate judiciary committee last night in behalf of his resolution submitting a joint vote of the people a constitutional amendment authorizing the state to develop water power. The amendment authorizes the state to engage in water power development either independently or cooperatively with adjoining states or the federal government.

Senator Joseph declared that if Oregon is to progress industrially and commercially cheap power must be made available.

Oregon, he declared, has two projects at which cheap power could be developed—Cello Falls, and Unamutia rapids. The power companies, he charged, are failing to furnish power sufficiently low to attract industries. They are proceeding on the theory, he affirmed, that the demand must precede the development. The state, he contended, can develop power much cheaper than private concerns, and in support of this he pointed to the Ontario power project.

Franklin E. Griffith, president of the Portland Electric Power company, spoke against the amendment. He contended that municipal ownership was not feasible in power development. The private power companies, he asserted have now a surplus of power, and can furnish it as cheaply as the state. The private power companies, he stated, are as interested in the development of the state industrially as any one else and are doing everything they can do to that end.

# EUGENE SCOUTS TO DEVELOP PROGRAM

Organization of a first-class council for the administration of Boy Scout activity in Eugene is contemplated here. A meeting will be held some time next month at which time H. G. Oberbauer of Spokane, regional director of the Boy Scouts, will be here to advise on arrangements.

Lynn S. McCready and James Carr who have been active in the Scout program here representing the American legion will endeavor to have representatives of various civic and religious organizations have representatives at the scheduled Scout meeting. The first-class council consists of 12 members representing different organizations taking an active interest in the work.

It is expected that a plan will develop whereby there will be a full-time paid executive to administer the scout work in Eugene. At present three troops have obtained charters and four others have been organized and it is expected that they will soon be officially recognized, is the announcement.

# PEDDLER SYSTEMS IN SELLING RAPPED

"The peddler system is a great menace to retail merchants," said H. W. Schnell, of Seattle, in a speech before the convention this morning. This system is on the increase, judging from the vast sums of money spent for advertising and the number of magazines that are dedicated entirely to the system, Mr. Schnell pointed out.

"Simple justice would be that a peddler should pay a premium for the privilege of selling in towns which are built by retailers," declared the speaker.

The interstate commerce commission cannot regulate the specialty salesman, Mr. Schnell pointed out. No tax can be collected from him or the company he represents except in the state where the goods are manufactured. The constitution will not allow the peddler to be taxed. The big hope for better conditions is in the fact that the courts are allowing cities to make regulations to protect retailers just as they protect other citizens and property.

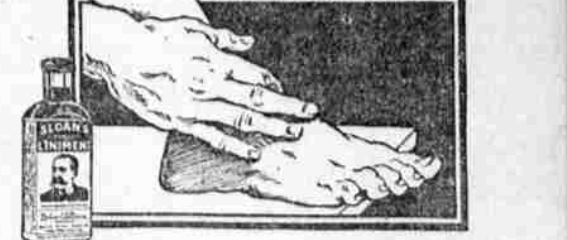
