TALE IS TOLD OF TORNADO'S ACTION

In fire flashed in great puffs from the stove.

"I tried to get away from it. I was afraid I would be burned to death. But the wind blew me back against it. Then the walls fell in. The roof fell. Something hit me on the head.

"How long I was unconscious I don't know. When I came to I was buried under boards and timber. Near me was a red cow which seemed to be holding some of the weight off me.

Help Arrives

"Then came Joe Moschenrode, the butcher, looking for his sister. He saw me, lifted some of the heavy boards, helped the cow up and pulled me out. I got up and looked around. There on the floor, white in death, was Lulu, with a great gash in her head.

"I started for the school. I found my own rain coat down the street hanging on a twisted pile of planking. I was wearing it before the storm struck. I put my hand in the pocket. There was my husband's paycheck—safe. There was a great crowd about the school. Children were screaming and crying. Mothers and fathers were weeping silently. But everybody was trying to dig out their own children. I found mine. They were both hurt but thank God they were alive."

FAMILY FLOATS ALOFT

DESOTO, Ill., March 20.—(AP)—Jesse Pankey of Harco, who was returning to his home from St. Louis with his wife and two small children in an automobile when Wednesday's tornado approached, today related his attempt to seek shelter and described a fantasy of the winds. He swung into a garage to escape, Pankey said, and as he stepped from the automobile, the roof of the garage was whirled away. Next, he asserted, his car was tossed into the air and carried off with his wife and children in it. He also was lifted and blown five blocks, slighting uninjured on the Illinois Central railroad tracks.

marks were as plain as the intaglio design on a steel engraving, and read: "533, 1856 R3E 11T."

Interpretation of the inscription was that the tree was on the corner of section 35, township 29 south, range 3 east of the Willamette meridian, and that it was a "bearing tree."

Discovery is Rare "This discovery is rare because fires have destroyed many of the old witness trees, and loggers have accidentally cut down many others," commented Mr. Maccliff.

"They were not always accurate in their surveys, but they did their work conscientiously, and intended that it should last."

WASHINGTON, March 20.—Presentation of the case of the Northern Pacific railway in a dispute with the government over some 3,900,000 acres of land, which it contends are due under land grants of 1864 and 1870 was continued today by James B.

Keer of Portland, Oregon, special attorney for the railroad, before the congressional commission.

Keer's testimony supplemented that of Charles Donnelly, president of the railroad, who denied the charge of the department of agriculture that the railroad has "erroneously classified" as mineral land "hundreds of thousands of acres of poor land," and

subsequently had turned back this "poor land" in exchange for mineral indemnity rights which "were applied on the part of more valuable lands."
