Three-day Affair to be Run Off Here May 29-31, At Trapsites Winner of Event Here Will Participate in National Trapshoot

Shoot schedules for the three-day state championship trap event to be held in Eugene Friday, Saturday and Sunday, May 29 to 31 have been completed and were announced today by the committee in charge of the arrangements composed of J. W. Seavey, L. E. Simmons and R. A. Babb.

Friday, May 29, forenoon—Shoot at 100 registered targets. Afternoon—One hundred targets, first half of the annual state championship. Fifty targets handicap match for the Honeyman diamond trophy.

Saturday, May 30, forenoon—Shoot for the Pendleton Round-up trophy, 50 targets. Oregon state association event for trophy, 50 targets.

Afternoon—One hundred target match at 16 yards, Oregon state handicap. Five-man team contests with teams from all gun clubs of the state participating. Suitable trophies for each member of the winning team.

Sunday, May 31, forenoon—Second half of state championship shoot. Afternoon—Fifty target match for A. F. Larson cup. Twenty-five pair of doubles for state championship.

Miss and Out match. Three Divisions. All gunners will be classified in three divisions. The first division will be for gunners with a percentage of 93 and up, the second class

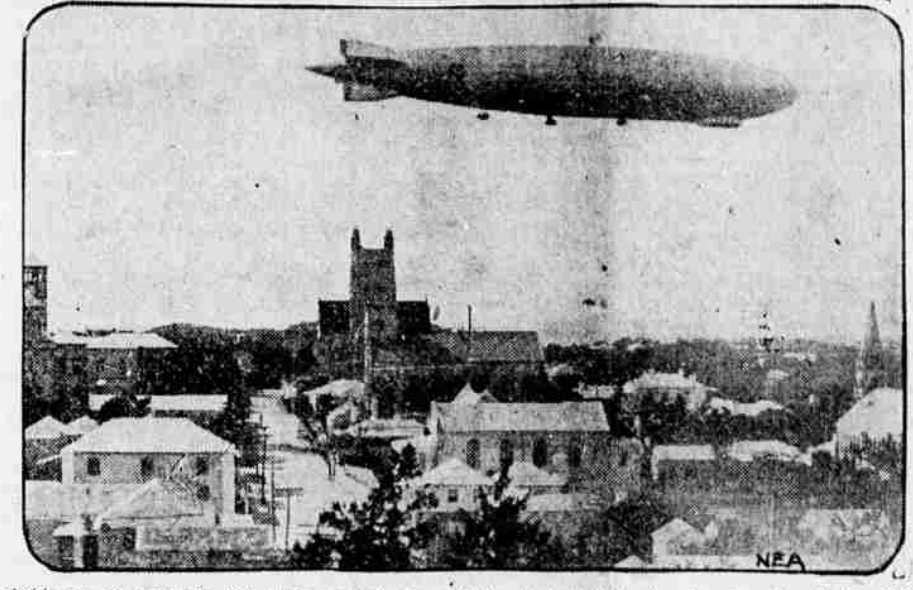

SPORTSMEN VOICE THREAT OF RECALL

KLAMATH FALLS, Ore., April 22.—Failure of Governor Walter M. Pierce to reappoint Ben Derris of Eugene to the state game commission will result in recall proceedings against the state executive, it was announced here yesterday by R. J. Kirkwood, president of the State Sportsmen's association. Kirkwood asserted that the Sportsmen's association and other allied groups were ready to start the recall before the governor and insist upon the reinstatement of Derris. If he refuses, recall petitions will be started at once.

If Governor Pierce follows out his present plan of building up a political machine through the game department and game work will be set back for 10 years," charged Kirkwood.

TILLAMOOK CHILD BEATEN TO DEATH BY GRANDMOTHER

TILLAMOOK, Ore., April 22.—The death yesterday of Sylvia Louise Desamps, aged 4, at the farm home of her grandmother, Mrs. M. C. Paton, 35 miles south of Tillamook, following a beating which the grandmother admitted to District Attorney Barrick she had given the child will be investigated tomorrow by the county grand jury, Barrick added today. The nature of charges, if any, will be determined by the findings of the grand jury, he added. Mrs. Paton is in jail here.

Beaten With Strap The girl's body was taken in charge late yesterday by Coroner Henkle after investigation by Barrick and Deputy Sheriff Lucas of reports that the child had died after receiving a beating with a strap at the hands of the grandmother, Mrs. Paton, the authorities declared, said she had corrected the child for a minor fault, and that the beating followed an attempt by the child to strike back.

Mrs. Paton said she did not intend to harm the child and did not realize she was striking the child hard. Played Afterward The child went out to play after the whipping and later came in complaining of feeling ill. Mrs. Paton put her in a chair, and later to bed. She said she sent for aid to a neighbor's home.

Sylvia was the daughter of Mrs. Cora M. Desamps, of Portland and Peter C. Desamps, of Washougal, Wash. The parents were separated and the mother had sent Sylvia and three other children to the grandmother's home last year.

Driving Snowstorm Swirls on Klamath KLAMATH FALLS, Ore., April 22.—A driving snowstorm, far more severe than the others which have descended upon Klamath since the close of winter, blew in from the northwest this morning and was still raging late this morning. The surrounding hills were blanketed with white, while the snow was remaining even inside the city except on the heavily traveled streets.

Medford Acts on Street Carnivals MEDFORD, Ore., April 22.—At a meeting last night the Medford council in an effort to discourage street carnivals and peddlers from entering the city, passed an ordinance increasing the tax on carnivals from \$50 to \$100 a day, and adopted a peddler's license ranging from \$7.50 to \$300 annually, outside solicitors are also required to put up a bond of \$500.

Bermuda is Host To Dirigible for Her Second Time

HAMILTON, Bermuda, April 22.—The dirigible Los Angeles, visiting Bermuda for the second time, made fast to the tender ship Patoka early this morning. It was first sighted off Bermuda at 2:30 a. m. She then cruised seaward again and was lost to view until about 5:30. She cruised leisurely about the island and at 6:30 took her position over the Patoka. She made fast in a little less than an hour. A strong north wind made anchoring somewhat difficult.

TRIP IS SUCCESS ESCAPED ROBBER STEALS OVERCOAT

WASHINGTON, April 22.—The airship Los Angeles moored to the tender Patoka, in the harbor at Hamilton, Bermuda, this morning. The airship, which left Lakehurst at 2:35 p. m., yesterday arrived over Bermuda at 2:10 a. m. News of the successful mooring of the ship was received with enthusiasm in navy aeronautical circles here, a former trial at Bermuda having been frustrated by unfavorable weather.

ROSEBURG, Ore., April 22.—Lee Duncan, alias R. G. Harper, who escaped from the county jail, yesterday, after slugging Deputy Sheriff Sewell, stole an overcoat and food at the Fred Fisher, Roberts creek ranch, according to word received this morning by Sheriff Starmer. Mrs. A. L. Johnson, who resides at the ranch telephoned in this morning that an army overcoat had been stolen off the porch where it was used for covering flowers, and that a half gallon of milk, and several pounds of dried prunes had also been taken. Duncan escaped without hat or coat so officers are sure that he was responsible for the theft of the overcoat. Duncan was last seen yesterday in the vicinity of Glengary, and the ranch where the thefts were reported is in a direct line south from that point. Trails leading into Dole and Mertie creeks are being closely guarded by officers in an effort to apprehend the escaped prisoner.

ENGLAND NEEDS STABILIZATION, AVERS SPEAKER

That the recent swing to the Conservative party in England in the last elections is not due to a conservative reaction of the people as is commonly supposed, but to the need of stabilizing the government during the next five years, was the opinion expressed by Rev. Lawrence Redfern, pastor of the Willet Road Unitarian church and member of the faculty of the University of Liverpool, in an address this morning in the Journalism assembly room at the University of Oregon. The Rev. Mr. Redfern spoke especially of the political and economic conditions of England at the present time.

Situation Interesting "The general political situation is far more interesting in England at the present time than it has been for years," Rev. Mr. Redfern said. He attributed the new situation to the rise of the new Labor party, making three parties instead of the old Conservative-Liberal two-party regime. Under the present situation no one of the three has a majority in parliament independent of the other two, making almost annual elections, as a result. Rev. Mr. Redfern declared that the primary need of the country is establishing a government to outlast the full period of five years, and he prophesied that the present ministry will do so, probably with a mildly progressive policy.

Unemployment Pressing The unemployment problem was declared to be the pressing problem of the moment in England. The situation is especially acute in Liverpool, Rev. Mr. Redfern said. "What impresses one, however," he said, "is the indomitable patience of these men."

Joined to the unemployment is the lack of adequate housing facilities. "In one small section of Liverpool there are nearly 2,000 more people than there were in 1914, and not

MAYOR ISSUES FOREST WEEK PROCLAMATION

Dates of April 27 to May 3 Are Set Aside by Document National Forest Plans to Aid in Observance of Programs

Mayor E. B. Parks today issued a proclamation calling upon all citizens and civic organizations of Eugene to observe the week of Monday, April 27, to Sunday, May 3, as American Forest Week.

The proclamation is as follows: "Whereas, Honorable Calvin Coolidge, President of the United States, and Honorable Walter M. Pierce, Governor of Oregon, have issued proclamations designating April 27 to May 3, 1925, as American Forest Week, and "Whereas, the city of Eugene is located in the center of Lane county, which county contains more standing timber than any other county in the United States, and "Whereas, the protection from fire of both the standing timber and the young growth coming in to take its place, is essential to the permanent prosperity of the community, and "Whereas, notwithstanding the protection given by federal, state and private agencies the annual loss from forest fires is far in excess of what it should be, "Therefore, I, E. B. Parks, mayor of Eugene, designate and set aside the week of April 27 to May 3 as American Forest Week and urge that all schools, churches, civic organizations, the press and public utility in thought and action, bringing before the citizens of Eugene the importance of protection of our forests."

MR. WHEELER ON WITNESS STAND

GREAT FALLS, Mont., April 22.—Senator Burton K. Wheeler took the witness stand in his own defense today at his trial here on charges of illegally appearing before the department of the interior for Gordon Campbell, Montana oil operator.

MR. HASTE CALLED GREAT FALLS, Mont., April 22.—Richard A. Haste, former secretary to Senator Burton K. Wheeler, testified today at the Montana senator's trial here that he did not believe that a telegram signed by Wheeler and sent to Gordon Campbell, Montana oil operator, on March 14, 1923, was sent by his employer.

The telegram read "Have already discussed permit with solicitor." (Eliwin B. Booth of the interior department). The senator is charged with appearing illegally before the department to prosecute Campbell's oil prospecting permits.

Haste said he took up the matter, which had to do with a permit originally granted to L. E. Lincoln, with Booth himself on the same day. The Lincoln permit is one of those invalid in its inception under which Wheeler is being tried.

Trainmen Die As Cars Drop Into Dry Run

MILES CITY, Mont., April 22.—Both the engineer and fireman of the Columbian, crack passenger train on the Chicago, Milwaukee and St. Paul railroad were killed this morning at 10:15 o'clock, when the train hit a burned out bridge and the engine dropped ten feet into a dry run three miles west of Railway, Mont. As the engine plunged, the air lines burst, automatically setting the brakes on the passenger coaches behind and stopping the train, all of the coaches except the mail car remaining on the tracks. Some of the passengers were badly shaken, but none seriously injured, according to the announcement of railroad officials here.

STATE BOARD OF CONTROL IN ROW OVER CONTRACTS

SALEM, Ore., April 22.—A heated argument took place at a meeting of the state board of control today over the question of whether the state, in its contract for construction of the new state training school, should enforce a contract which has been signed and which provides that the contractor must come under the workmen's compensation act while on that work. Governor Pierce held that the contract should be enforced, but he was voted down by State Treasurer Kay and Secretary of State Koser and the contract will be altered accordingly.

Argument Heated The contractor, it appears, is insured with the Aetna Casualty and Surety company and Karl Lively, a representative of that firm, participated in the discussion. It was claimed that the policy furnished by the company provides for practically the same benefits as provided by the state department. W. A. Marshall, of the accident commission, sided with the governor in the argument, which became tropical at times.

The governor asserted that the insurance companies "hold a knife at the heart of state compensation and will kill it." Kay declared that the governor had done more than anyone else to kill it by urging withdrawal of state aid for the department. Both the governor and Kay said they were in favor of state compensation, but the governor said he favored compulsory insurance under the state commission, while Kay said he opposed it.

Mr. Koser Vates Koser's vote was on the basis of a precedent set when the same contractor built a wing on the eastern Oregon insane hospital at Pendleton. The contract at that time provided for state compensation, but this provision was not enforced by the state, and it is said the contractor signed a similar contract for the training school in the supposition that again it would not be enforced.

The action taken today does not establish a policy with respect to future contracts. This is to be taken up later.

BLOWS DEALT FREELY DURING ELECTION ROW

Former Premier Edouard Herriot Elected President of Chamber Only One Vote Cast Against Him; Premier is Given Confidence

PARIS, April 22.—(AP)—Fist fights occurred on the president's rostrum of the chamber of deputies this afternoon during the second balloting for the presidency of the body. When a member of the opposition, Deputy Balanat, charged that "ten deputies voted twice," two socialist broke through the protection offered by the sergeant at arms. There was much wild swinging of arms.

One straight-arm punch staggered Balanat, whose friends mixed in making the fight general on the rostrum. Suspension of the session was necessary before order could be restored.

M. HERIOT ELECTED PARIS, April 22.—(AP)—Former Premier Edouard Herriot, was elected president of the chamber of deputies this evening. He received 270 votes but with a single vote against him, the opposition abstaining from voting. The members of the Cartel, or group supporting to the government, arose and cheered when the result was announced. The new president of the lower house bowed his thanks in a rapture and the chamber adjourned. He will preside over the session tomorrow.

There was some speculation as to whether the ex-premier had voted for himself or whether he was the lone deputy who voted the other way.

PREMIER IS FAVORED PARIS, April 22.—(AP)—Nine hours of debate featured by bitter personal attacks of Joseph Caillaux, lately returned from exile and now minister of finance, proceeded the vote in the chamber of deputies last night on the declaration of policy of the new cabinet.

At the conclusion of the verbal fireworks, Premier Painleve and his colleagues were voted confidence 304 to 218.
