

EUGENE GOLFERS WILL SEEK STATE HONOR THIS WEEK

The Eugene Country club will make a strong bid for state-wide golf honors next week-end, June 6 and 7, when representatives from the club will compete at Marshfield in a two-day tournament celebrating the grand formal opening of the Coos County Country Club.

Representing the Eugene club will be a four-man team consisting of Bert Prescott, captain; George McGill, Albert Tiffany and Bud Sigwart.

Todd Gardner, Eugene professional, will enter the event for the prize. Should Gardner duplicate his performance of the past week-end when he held out in one stroke to beat an opponent's two, the going at Marshfield will be hard sledding for the rest of the entrants.

An invitation was extended to all members to enter the amateur open event, but as yet none of the Eugene members have signified their intentions of entering.

The Eugene players will motor to Marshfield Friday in order to be on hand for the tournament which covers two days, Saturday and Sunday.

Cities that will be represented in the tournament are Eugene, Marshfield, Corvallis, Albany, Salem, Hood River, Oregon City, Roseburg, and Medford. A victory over this array of entrants would be a decided achievement for the local players.

DEMPEY WANTS TO MEET WINNER

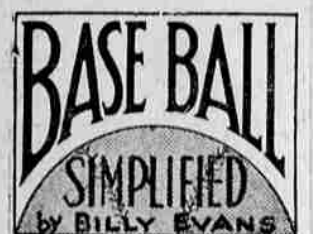
NEW YORK, June 4.—(Special)—A faint hope of more than \$4,000 a minute will be made by Gene Tunney and Tommy Gibbons for their 15-round heavyweight battle tomorrow night at the Polo Grounds if the bout goes the limit. It is stated. The advance sale of tickets indicates an attendance of 60,000 and receipts of \$40,000. Thirty per cent will be the share of Gibbons, giving him \$12,000 or \$80,000 for such three-minute rounds. Tunney's share will be \$80,000, representing 20 per cent of the receipts, or more than \$5,333 per round.

The fighters are resting today after a month's preparation for the battle. Both are pronounced in perfect trim.

NEW YORK, June 4.—(AP)—Jack Dempsey, world's heavyweight champion, today cabled Billy Gibson, manager of Gene Tunney, that he would meet the winner of the Tunney-Gibbons match if "proper inducements were offered." The cable came from Berlin, Germany.

The cablegram follows: Will positively meet the winner of the Tunney-Gibbons bout if proper inducements are offered. We both are enjoying the trip immensely. Thanks for the good wishes. Hope you have a sell out.

If an improper batsman hits safely and the team in the field discovers the mistake and appeals to the umpire, what action does he take in the matter?

If one remembers that the proper batsman is always out in the case where a batter bats in the wrong place in the lineup much of the confusion over batting-out-of-order plays will be cleared up.

For instance, Smith, the third batter, should have started the inning, but Jones, the fourth batter, leads off and cracks out a double.

The team in the field, noticing the mistake, makes an immediate appeal to the umpire for a ruling. The official consults his batting order and verifies the slip.

Jones, who hit the double, is removed from second base. Smith, who should have been the proper batsman, is called out. This puts it up to Jones, who follows Smith in the batting order, to bat again in his proper place.

The batting order is then resumed in regular fashion. But years there has been the impression that after a player once bats out of order he cannot bat again in the same inning. This is, of course, erroneous. He must always bat in his regular order, regardless of any improper batting he may have done.

Baseball Puzzlers

THERE are runners on second and third and one out. It is Jones' turn to bat. His place in the lineup being third. However, Smith, who occupies the fourth position in the batting order, goes to bat and doubles, scoring the runners on second and third.

The team in the field, realizing that Smith has batted out of order, calls the attention of the umpire to the play before a ball has been pitched to the next batter.

Do the runs count and what is the proper handling of the play?

The runs do not count. No runs

When there is a batting-out-of-order play, and it is discovered in time, the umpire must always call out the proper batsman, the man who should have batted.

In this case the proper batsman was Jones. He is called out for Smith's act of batting out of order. The runners are sent back to their original bases, second and third.

Smith, who batted improperly and doubled, is removed from second.

The next batter must be the player who follows Jones in the batting order. In this case it is Smith. He must come back and bat over.

In batting-out-of-order plays that are properly discovered, the proper batter is always called out and no bases can be run on any act of an improper batsman.
