Field Secretary Here--W. H. Lees, field secretary of the United States chamber of commerce, with headquarters at San Francisco, arrived here today to confer with officials of the Eugene chamber. Mr. Lees is on his way south and leaves tonight for North Bend, Marshfield and Coquille where he will hold meetings at the chambers of commerce at those cities. Mr. Lees expects to return to Eugene in the near future to hold a meeting with the officials and membership of the Eugene chamber. The field secretary has just returned from attending the annual meeting of the national chamber at Washington, D. C. "The national meeting was the largest ever held and the dedication of the new headquarters building of the organization was directed by Judge William Howard Taft while president of the United States was instrumental in the founding of the national chamber," Mr. Lees said today.

Bankers at Meeting--Several Eugene bankers left today for Corvallis to attend the annual meeting of the Oregon State Bankers' association. C. D. Rorer, president of the state association, left this afternoon. Others from here who went to Corvallis today were David Auld, United States National bank; P. E. McGrath, W. T. Gordon, Darwin Elliott and C. R. Cleaver, all of the First National bank; O. A. Houghlum, president of the Lane County Bankers' association, and A. A. Rogers, president to attend the meetings tomorrow. Mr. Houghlum will present the annual report of the Lane county association at the state meeting, it is assumed.

Prisoners More Scarce--Only 21 prisoners are now confined at the Lane county jail, this being the lowest mark in enrollment recorded since nearly a year ago, according to H. L. Lee, county jailer. During the present term of court a number of cases were taken care of and this cut down the population considerably. A number of cases will also be taken up by the grand jury in the near future. "The manufacturers of illicit liquor seem to have curtailed their operations during the late spring as recently indications have been found of plants in various parts of the county that have been closed, temporarily at least, it seems," according to Van Stover, chief deputy sheriff.

Thistles Grow Rapidly--The Canadian thistles are growing fast, one of the best crops in Lane county, but we are holding our own and hope to have them exterminated this summer," is the report of C. E. Stewart, county fruit inspector, who was here today from his home at Cottage Grove. Mr. Stewart is in charge of the 20 thistle patrolmen recently appointed by the county court to take steps to eradicate the thistles which are proving a pest to farming. Two new inspectors were authorized by the court today, Elmer Baker and E. C. Cole, both of Eugene, being appointed.

Chickadee Plans Events--Chickadee will play host for the largest crowd ever gathered there at one time in the history of the community July 4 during the rail celebration, according to Perry Steelmacher, deputy state game warden of that district, who was here today. No visitor need fear that provisions will run out as ample plans for the feeding of a multitude at the big show are being made, the warden states. Housing accommodations for the throng are also to be provided and it is understood that a large number of cots will be rented to provide for the influx from the rail construction camps and other camps Friday and Saturday nights, July 3 and 4, it is reported.

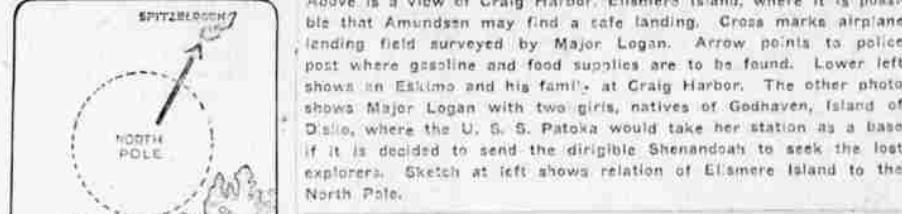
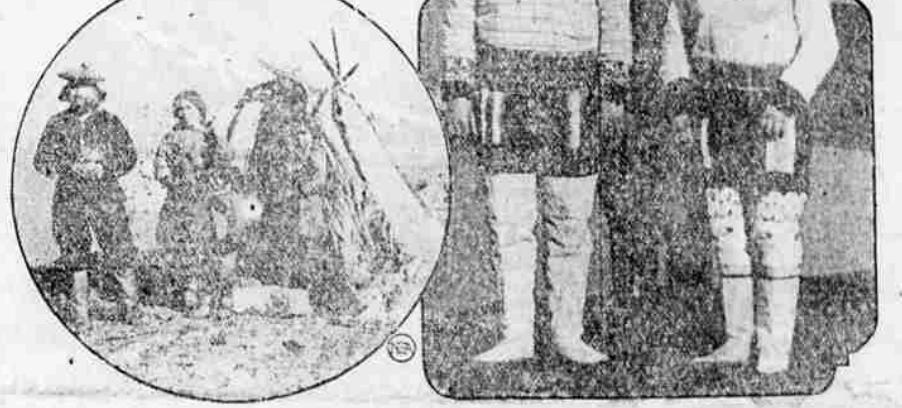
