

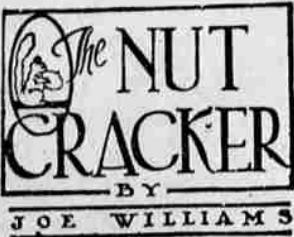
BASEBALL AWARDS GIVEN TO TWELVE OREGON ATHLETES

Music Clubs are For Bacon Bill

PORTLAND, Ore., June 11.—(AP)—The National Federation of Music Clubs in biennial convention here, today went on record favoring action by congress upon the Bacon bill, which provides for appointment of a commission to examine the feasibility of establishing a national conservatory of music.

The action was taken after a report by Mrs. Frances E. Clark of Camden, N. J., chairman of the legislative committee.

Nomination of five directors from the floor of the convention, following the report of the official nominating committee, was sufficient to keep the election day from being a cut and dried affair and to make the personnel of the new board a matter of uncertainty until the election closes.

With 45 to be elected, the nominating committee had turned in just 45 names of candidates.

Mrs. Cecil Frankel, of Los Angeles, Cal., who may be designated as the "progressive" candidate and Mrs. Edgar Stillman Kelley, of Oxford, Ohio, who is said to be backed by the conservative group, are the recognized candidates for the presidency.

The new board will elect the officers tomorrow.

The organization is authorized to operate homes for the aged and other benevolent institutions and the estimated value of possessions at the time of incorporation is set at \$20,000.

OLYMPIA, Wash., June 11.—(AP)—Proceedings to secure an injunction to restrain the railroads from raising log rates other than those in effect during the time the question of log rate adjustment has been under consideration in this state, were filed shortly afterwards in Thurston county court by Raymond W. Clifford, special assistant attorney general, in charge of the log rate case for the state.

Parties defendant to the suit are the Northern Pacific, Great Northern, Oregon-Washington and Chicago, Milwaukee and St. Paul railway companies and S. J. Henry of Seattle agent for the North Pacific Coast Freight bureau. The bureau represents the roads in tariff and other matters common to carriers operating on this section, it was pointed out.
