

# RECORDS FOR GOLF COURSE BROKEN BY AMERICAN PLAYERS

PRESTWICK, June 25.—(AP)—Returning a card of 69, a new course record for his afternoon round in the British open golf championship, MacDonald Smith, American professional with 147 for the 36 holes played today, took the lead from Long Jim Barnes, who had 147.

Joe Kirkwood, American professional golfer, returning a 79 for the second round, giving him an aggregate of 163 for the 36 holes played today.

Joe Kirkwood, American trick shot artist, came in with 83. After starting well, Kirkwood began slumping at the long third, where he sliced a brassie and pulled an iron shot into the bunker. At the 15th he pulled both his drives and the second went into the rough. For the remainder of the course his golf was none too good, his main difficulty seeming inability to hold to the true inward line.

## Puzzle Plays
