LEADERS OF TONG AGREE TO CEASE FIGHTING TUESDAY

NEW YORK, Aug. 6.—(AP)—Leaders of the On Leong and Hip-Sing tong, in conference today with federal authorities, declared a truce until 10 o'clock tonight. At that time they will go into conference in an effort to effect a lasting peace.

Today's parley was attended by three leaders of each tong, half a dozen neutral Chinese representing benevolent societies, U. S. Attorney Charles H. Tuttle, at whose request the conference was called, and Assistant U. S. Attorney George J. Minter.

With five Chinese killed in the last two days here, in Newark, N. J., Chicago and Boston, Tuttle sent out word today that if the tongs did not settle their differences by tonight federal agents would stage a wholesale roundup that would result in hundreds of Chinese being deported.

NEW YORK, Aug. 6.—(AP)—Prospects of one of the bloodiest tong wars in years were seen today by additional killings both in this city and Boston, bringing the dead to five in two days in addition to several wounded.

A few hours after U. S. Attorney Charles H. Tuttle and Samuel Sun Young, Chinese consul general, had warned tong leaders here that no violence would be tolerated pending a peace conference today, a Harlem handymen was shot and killed at his ironing board.

Similarly in Boston two Chinese were shot and killed within a few hours after tong leaders had assured the police there would be no tong warfare in that city. Police officials said it was the first time tong leaders had deliberately deceived them and expressed the belief the killings would result in the bloodiest tong war ever seen in New England.

In Chicago and Newark, N. J., where the killing started with one death each on Sunday, a tense quiet prevailed. Police maintained close watch on the Chinese sections but no attempts at violence occurred.

The cause of the renewed tong outbreak remained in mystery. One theory upon which New York police were working was that he was over the rice liquor trade which was said to have become quite profitable with the deteriorating quality of other bootleg liquor. At Newark it was thought the war might be over the opium trade, \$50,000 worth of the drug having been seized in that city Saturday.

After a conference yesterday with Young and representatives of the rival tongs, Mr. Tuttle let it be known that if the warfare was not stopped in New York at once wholesale deportations of Chinese would result.

In a statement he said his purpose in calling a meeting of tong officers was to offer the good offices of Young and himself to settle any differences that may have arisen and restore the peace agreed upon after the

last tong outbreak several years ago. "I have stated to representatives of both tongs that it is the intention of the American government to take all steps necessary to prevent an outbreak of organized murder," he said.

way, Salmon and Nez Perce forests, a dozen or more new fires were reported, and fighters were still battling the blaze on Bald mountain, which was still out of control. Its extent could not be estimated. The Salmon river fire in south Idaho was roaring anew, and fighters were sent across the Montana line to check it. High winds were blowing and the humidity was far below the danger point.

The Chelan fire in Washington today was covering its front, and nearly 500 men were fighting it. It was started by lightning Friday night, and had burned over nearly 12,000 acres. Late last night it had reached the crest of the Chelan-Methow divide, and volunteers from Chelan, Methow, Twisp, Cowlitz and other towns were moving against it, under the direction of F. H. Brundage of Portland, Ore., federal forest control chief for Oregon and Washington. Forty-two fires in the Wenatchee forest were reported under control last night. A blaze started Saturday near Wilbur, was believed to be near control after having burned 500 acres.

A fire which was thought to have burned over a large area and was apparently not in control Monday evening was reported to R. S. Shelley, supervisor of the Siuslaw national forest by M. H. Durbin, ranger at Gardiner, Tuesday. Mr. Shelley said the report did not give the exact extent of the burn.

The fire's location was said to be on the south side of the Umpqua river between Reedsport and Winchester bay. The fire is not in the Siuslaw forest, but is across the river.

The fire was burning over logged off land, the report stated. Mr. Shelley said that the Boos Bay Fire Patrol association has charge of the fire-fighting in that locality.

Several small lightning fires from the storm of Tuesday of last week were reported to have flared up in various parts of the Cascade forest by Arthur Moses, executive assistant of the Cascade office. All were reported under control.

Harriman Case is Taken Off Docket

The case of Fred E. Harriman versus Dora M. Harriman was dismissed from the county court by Judge C. P. Barnard Tuesday morning on motion of the district attorney.

The case was a dependency proceeding and was withdrawn. District Attorney Alta Kim said, because of a divorce proceeding filed by the defendant of the case against the plaintiff. The circuit court will adjust the matter through the divorce trial, it was said.

DEMOCRATIC HOSTS IN VIRGINIA LOOK FOR PARTY HEAD

RICHMOND, Va., Aug. 6.—(AP)—Virginia's embattled democratic hosts were choosing a champion today to lead them in an effort to drive the republicans beyond the Potomac.

Factional differences, characteristic of southern states in which democratic nomination is equivalent to election, was conspicuous by its absence in the democratic primary campaign that closed last night. The three candidates for the nomination for governor calling upon the voters to participate in today's primary regardless of their choice for party nominee.

John Garland Pollard, A. William Mapp, a former state senator, and Roosevelt Page, brother of the late Thomas Nelson Page, were the candidates for the gubernatorial nomination. James H. Price for lieutenant governor and John R. Saunders for renomination as attorney general, had no opposition.

While democratic leaders declared a somewhat general apathy would prevent the primary becoming a test of democratic strength, local elections in several sections were expected to aid in bringing out a vote of close to 150,000.

The anti-Smith democrats, who refused support of the party's national ticket last year made a vigorous effort to keep last year's anti-Smith democrats from entering the primary so that they might be morally free to support in the general election Dr. William Mowley Brown, nominated for governor by both anti-Smith democrats and republicans.

Democratic leaders also saw an effort to keep voters out of the primary in the statement issued from Washington yesterday by Bishop James Cannon of the Methodist Episcopal church.
