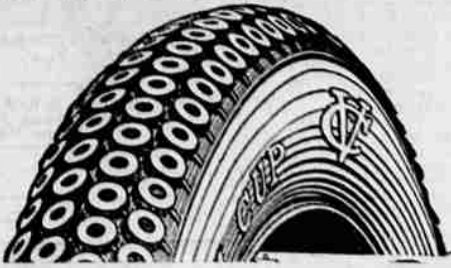

MODERN BUSINESS BLOCK OF 5 STORIES PLANNED

Wetherbee-Walker Furniture Company Will Build

HENDRICKS LOT LEASED

Two-Story Structure on Willamette Between Eighth and Ninth to Be Razed to Make Room

A five-story business and office block is planned by Frank H. Wetherbee and Deane H. Walker of the Wetherbee-Walker Furniture Company, to be located on the site of the two-story block owned by the Hendricks estate and occupied by the Hauser sporting goods store and E. Schwarzschild's stationery store on the west side of Willamette street between Eighth and Ninth avenues. The old structure will be razed to make room for the new block and it is expected that construction will start within a year. Mr. Schwarzschild's lease runs for a year yet, but he has promised to vacate the premises as soon as he is able to get another location, said Mr. Walker yesterday. The Hauser sporting goods store is simply renting the room it occupies from month to month.

Ten-Year Lease Obtained
The deal for a 10-year lease on the Hendricks lot was completed yesterday afternoon. While no definite arrangements are made, it is expected that the Wetherbee-Walker Furniture Company will purchase the lot at the expiration of that time.

The lot is 48x150 feet in dimensions. The old building is two stories high for a distance of about 80 feet back and one story high from there to the alley. The upper floor is occupied by offices. Attorney Lark Rilyeu has had his office there for a third of a century or more.

The furniture company will occupy the basement, the first floor and the mezzanine floor of the new block, said Mr. Walker, and the outer floors will be devoted to offices and possibly a lodge hall. Mr. Walker said that the office of one of the lodges of the city had spoken to him about such an arrangement.

Block to Be Modern
Plans as to the style of the new building are as yet indefinite, said Mr. Walker, but he stated that it would be faced with pressed brick although it might be of concrete construction. He said it is planned to erect an entirely modern building, but in the appointments. It will be equipped with freight and passenger elevators and other modern conveniences.

The rapid increase in the business of the Wetherbee-Walker Furniture Company necessitated taking this step, Mr. Walker said. The present quarters in the Brown block at the corner of Ninth avenue east and Oak street and in the building adjoining are badly congested. It has become a great problem how to take care of the business there. Mr. Walker said that the Brown building will be retained for some time as the firm has a lease on it that does not expire for a number of years.

Dean Walker, bought out Brauer and Conley three years ago next July and Frank Wetherbee bought an interest in the store about a year and a half ago. They have met with confidence enough in the future growth of Eugene to invest their money in such a building as they are planning.

Mr. Walker said that they will have the largest furniture store in the state outside of Portland when they occupy their new block.

The old building which is to be razed was erected over 30 years ago and was at one time occupied by the First National bank.

INJUNCTION IS THREATENED
Cottage Grove People Announce That They Will Start Suit—Money Held Up Until Court Decides Another

Injunction proceedings against the Lane county court are threatened by a number of residents of Cottage Grove if the court proceeds to expend any more money from the market road fund on the Pacific highway, according to word received by the court from Cottage Grove yesterday.

The court budgeted \$43,000 of the market road fund of Lane county for different pieces of work on the Pacific highway this year for the reason that there were no other funds available for the county's share to complete the highway through the county. A portion of this sum was allotted to the overhead crossing at McVeigh point, which has been completed and there were no other funds available for the county's share to complete the highway through the county.

County Judge C. P. Barnard said yesterday that these two projects will be held up until the circuit court in Polk county decides a parallel case. A decision is expected to be made in a few days.

Judge Barnard in explaining the court's reason for allowing a portion of the market road fund to the highway is that there was no bond money available, the general fund was all allotted elsewhere and the court demanded it a wise expenditure of funds inasmuch as the state was expending seven or eight dollars to the county's one on the projects to which the county money was allotted.

meet this indebtedness and now the state highway commission is demanding the money. Word has been sent to the county court that it will proceed no further on any of the overhead road contracts here until a settlement is made. Attorney Devers came up from Salem yesterday held a long conference with the court but no agreement was reached. As those appearing to doubt as to the legality of the bill it was agreed to leave this question to Mr. Devers and District Attorney Johnston.

The children are now rehearsing for the pageant, which promises to be an elaborate production. Every child in the school will take some part either as a character or in the drills.

The scene of the pageant is in Tackhammer's toy shop in summer time. Even though the old shop is full of toys that move in mechanical fashion the dances and drills are very distinctive and cleverly arranged.

The proceeds of the entertainment will go toward building a fence around the school playgrounds.

BRONZE TABLET TO MARK OLD TRAIL THROUGH PASS

Local D. A. R. Will Erect Memorial to Felix Scott

DEDICATION IS PLANNED

Oregon Pioneer Who First Blazed Route Through McKenzie Will Be Commemorated by Organization

In commemoration of the first Oregon pioneers who made a trail through the McKenzie pass in 1862, the Lewis and Clark chapter of the Daughters of the American Revolution of this city, will erect a bronze memorial tablet at the crossing of the old Scott trail at the McKenzie bridge. The placing of the tablet has been planned for some time by the local organization and a committee has been named to arrange for an official dedication early next month. Although no definite date has been set for the unveiling it is announced that it will be held on a Sunday to enable the greatest number of people to attend the ceremony to which invitations will be extended to all the pioneers of the state.

Program to Be Planned
Mrs. Bruce Bogart is in charge of the arrangements for the dedication of the tablet which is to be placed on a huge boulder near the McKenzie highway on the edge of the former trail. The erection of the tablet will be made by officials of the national forest service who will cooperate with the D. A. R. chapter in the work. Mrs. Bogart announces that an extensive program will be prepared for the event and several prominent speakers of the state will be obtained for the ceremony which will mark one of the early historic achievements of the Oregon pioneers.

Route Blazed in 1863
It is planned by the members of the D. A. R. chapter here to make the affair an all-day celebration and draw visitors from various parts of the Willamette valley and beyond the

McKenzie summit to take part in the official unveiling. Many of the Oregon pioneers are still here who were in the state when the trail was first ventured by Felix Scott in 1863 in order to drive a herd of cattle from California to The Dalles. Scott according to the records of old Oregon brought the herd across the Siskiyou from the south and to get to his destination at The Dalles without going to Portland and up the Columbia river left the cattle near Eugene and blazed the trail through the pass and then returned for his herd.

The bronze tablet will be the second memorial mark that has been placed in Lane county by the D. A. R. chapter. In 1916, Mrs. Bruce Bogart presented a tablet to the organization which was placed at the present site of the new overhead crossing near Springfield. It is called the Correll memorial and marks the spot where the Hendricks and Bristow families, early Oregon pioneers, made their first camp in Lane county.

Officers for Year Elected

Discussion concerning the plans for the dedication event on the McKenzie highway was held yesterday afternoon during the meeting of the chapter at which officers for the ensuing year were elected. There are now 58 members affiliated with the chapter here. The officers named were: Mrs. Mary Hudson, regent; Mrs. Blanch Willoughby, vice-regent; Mrs. Edwina Prosser, recording secretary; Mrs. Emma Brandage, corresponding secretary; Mrs. Cora Morgan, treasurer; Mrs. Beula Morgan, registrar; Mrs. Georgia Gilstrap, historian. Three directors were also named: Mrs. Emma Wilkins, Mrs. Albert McMurphy and Mrs. Florence Pierce. The members also discussed the possibility of holding a colonial ball some time next autumn as the feature of the social program of the organization.

LABOR DEMAND IS HEAVY

LOCAL EMPLOYMENT PLACES 114 PEOPLE DURING WEEK

The week report of the local office of the United States labor bureau showed that 114 people had been furnished employment here during the past week. Mills and camps with 52 men placed furnished the largest demand.

The men were placed in positions as follows: Farm, 57; carpenters, 4; helpers, 6; casual laborers, 7; common laborers, 35; mill and camp, 52; millwrights, 3; salesmen, 2; engineers, 2; firemen, 4. Women were placed in the following positions: Waitresses, 6; housework, 11; cooks, 4.

The demand for labor this spring shows a considerable increase over the same period last year.

BANK DEPOSITS ARE HIGH

NEARLY SIX MILLION DOLLARS IN THREE INSTITUTIONS

The total deposits in the three banks of Eugene at the close of business May 5 were \$5,909,702.82, according to the published reports of the banks.

This almost reaches the high mark attained about two years ago and is taken by the bankers as an indication of a return to normal conditions. The increase in deposits during the past 48 days has been approximately 170,000.
