The new timber recently purchased from the Morris and Moore company. Operations are to be started at once on the new stands, according to J. W. Lichty, president of the Penn company.

**New Lincoln Car Here For Show**—A model of the new Lincoln limousine has been received here at the E. C. Simmons agency, as a demonstrator, and will be feature of the Simmons booth at the auto show this week. A model of the new four-door sedan Ford has also been sent here for the motor car show in addition to new models of the Ford line, according to Mr. Simmons.

**Coal Concern to Increase Holdings**—The stockholders of the Coquille Valley Coal company, which operates at Riverton, in Coos county, met here yesterday and voted to increase the capital stock of the corporation to provide for the purchase of additional property of about 500 acres near the mines. Plans were taken up for a motor caravan to go to the mines from here some time in the spring.

**Leaving for South to Purchase Horses**—Charles Taylor, proprietor of the Ninth avenue feed barn, leaves today for the southern districts of the county for the purpose of purchasing horses for the auction to be held at the local barn next week. A string of between 50 and 60 horses are now at the stable, according to Mr. Taylor who states that the auction will be one of the largest horse sales held here in some time.

**Farm Machinery Arrives**—A carload of farm machinery from the plant of the Moline company has arrived here over the Oregon Electric road. The shipment has been consigned to the Grangers' Warehouse association and will be sold on the co-operative plan to the members of the organization. This will be the first venture of the Grangers to purchase farm equipment in a carload lot for resale to the membership of the association.

The train was backing slowly and of the five occupants of the motor car none was injured but the machine was badly damaged as a result of being carried along the right-of-way. Those in the car were Mr. and Mrs. Bert Bailey and infant son and Mr. and Mrs. Walter Anderson.

**High School Baseball Men Active**—Although the baseball season will be several weeks in the future, active preparations for the organization of a team to represent the Eugene high school are under way, according to F. L. Granula, coach of the local squad. The diamond on the South Willamette street grounds will be put in shape for the coming practice, says Mr. Granula. It was planned to have been marked out on the proposed new athletic field of the school, but this plan has been postponed for the present. The prospects are bright for a fast aggregation of talent at the E. H. S. this spring, is the prediction of Granula.

**More Bonds to Be Sold**—The Lane county court is planning to sell a block of \$400,000 of its high-way bonds at once, according to Commissioners Sharp and Roney. This will take care of all bond projects planned for the year. The proceeds of this year are three sections of the old territorial road, a section of the

high pass road to Lake creek valley, the Glendon-Ada road, the surviving of the Wash Fork road and the Coburg-Lane county line road.

**Two New Residences to Be Built**—Yesterday W. H. Alexander, city building inspector, issued a permit to Marie H. Sorenson to erect a residence at 1011 Sixth avenue west at a cost of \$2900 and to W. G. Houser to erect a residence at 570 Eighth avenue west at a cost of \$2000.

**W. U. Office Gets Improvements**—The W. U. office, district commercial superintendent and F. B. Hibbard, of San Francisco, plant superintendent of the Western Union Telegraph company, were here yesterday looking over the local office with a view to installing a number of improvements.

**Guardsmen to Take Navy Examination**—Olin Murray, member of Company C, Oregon National Guard, of this city, and H. S. Elsenhohn, of the headquarters company, have applied for enlistment in the United States navy through the local recruiting office and will leave for Portland to complete the final examination.

**Handle Factory Installing Equipment**—Several pieces of new mechanical equipment are being installed at the local plant of the Eugene handle factory, according to J. I. Jones, who recently with his associates purchased the controlling interest in the firm. A new saw and motor in addition to a dowel machine are included in the shipment, according to the manager.

**Commissioners Go Over Road**—County Commissioners Sharp and Roney went over the Jasper-Pleasant Hill road yesterday. This is one of the market road projects on which \$300,000 will be placed this year, according to the budget. Commissioner Roney said that some changes will be made in the road. The improvements will be made as early this year as possible, he said.

**Washington's Birthday to Be Celebrated**—J. W. Geary post, G. A. R. and the Woman's Relief corps will give a Washington's birthday entertainment in the post room at the armory Thursday night. J. M. Williams will speak at the home of Washington, Howard M. Brownell on Lincoln and C. M. Stevens on Grant. These addresses will be interspersed with readings and music.

**Proposed Golf Club Site Inspected**—A committee of the Eugene Country club accompanied by George Junor, golf green architect, has completed an inspection of the proposed location of the new club grounds at the Braes. A meeting of the officers of the club with the directors will be held at the rooms of the chamber of commerce tonight and reports will be made on the advantages of the Braes and also on the site now on the way. A decision will be reached as to what plans will be launched for the new grounds.

**German Students Coming**—Two German students, Joachim Friedrich of Heidelberg, and Hans Tiesler, of Berlin, and a Hollander, Piet Roest, of Leyden, will visit the University of Oregon campus March 4 under the auspices of the National Student Forum of America to inform Oregon undergraduates of present-day European collegiate life. The visitors will remain on the campus for four days appearing at a number of meetings to be held under the auspices of student organizations.

### FOUR DIVORCES GRANTED

**MRS. ROBT. MCMURPHY AND OTHERS GIVEN DECREES**

Wife of Man Serving Life Term in State Penitentiary Obtains Legal Separation

Four more divorces were granted by Judge G. F. Skipworth at yesterday's session of the circuit court.

Isa Leora McMurphy was given a decree from Robert S. McMurphy on the ground of cruel and inhuman treatment. She was given the care and custody of their child, Eugene Bushnell, and \$25 a month alimony for his support. Mrs. McMurphy stated that her husband used her roughly and that he remained out late at night. They were married October 6, 1917.

Mrs. Carrie Richardson was freed from her husband, Jerry M. Richardson, who is now serving a life term in the state prison for a statutory crime against their 12-year-old daughter. They were married October 18, 1905, at Blanchard, Iowa. Mrs. Richardson was given the care and custody of the other children.

Mrs. Mary Smith was divorced from Luran E. Smith on the ground of desertion. They were married in Portland June 20, 1919. Mrs. Smith testified that her husband told her in June, 1921, that he was coming to Eugene to attend the state American Legion convention and that he has never returned.

Mrs. Ella Hake was given her decree from Stanley Hake because he refused to support her. She was allowed to resume her maiden name, Ella Mary Hayes. They were married at Jacksonville, Ore., December 4, 1916.
