NOT GUILTY IS PLEA IN
BALLANTYNE DEATH CASE

MARRINER AND JOHN BROWN-
ING ACCUSED OF DEED

Alleged Slayer Confessed to Kill-
ing Salt Lake Banker Say Po-
lice—Probe Continued

SALT LAKE CITY, April 12.—
Pleas of not guilty were entered
today by Marriner and John
Brown, Jr., prominent Utah
business men, when they were ar-
raigned in court on charges of
murder in the first degree for the
killing of Benjamin F. Ballantyne,
former bank teller in his fash-
ionable home here last Monday.

Judge Noel S. Pratt, who pre-
sided at the arraignment an-
nounced that the preliminary hear-
ing in the case would be held Apr.
26. Attorneys for both prose-
cution and defense said the de-
fense was satisfactory.
