FRUITS OF INTOLERANCE

Addressing a luncheon club in San Francisco day before yesterday, Senator James A. Reed, of Missouri, criticized blithely the growing tendency toward control of business and home by government bureaus and commissions. He told his hearers that:

Certain so-called reformers would centralize in the federal government complete jurisdiction over the private and business life of one hundred and ten million people, apparently forgetting that such a philosophy must be based upon the assumption that all the people are either dishonest or foolish. Senator Reed, we should say, is a shallow thinker. The philosophy against which he declaims is not based upon the assumption that all people are either dishonest or foolish; it is based upon the conviction that all the people are dishonest or foolish "excepting me." The voters and lawmakers are like the fond mother who remarked regretfully that all the soldiers were out of map but like—each one knows that he is all right, but feels certain that the rest of the community needs regulating.

There is a certain amount of truth in the frequently repeated statement that the tendency in this country is toward regulating by law every human act from the cradle to the grave, and the bald truth is that this tendency is rooted in intolerance. Each of us wants to regulate the other fellow. And all of us complain bitterly because the other fellow wants to regulate us.

POINTING OUT A DEFECT

Those critical Britons who complained loudly in parliament day before yesterday of conditions at Ellis Island, which is America's immigration gateway, are in the unfortunate position of getting "all set up" with nothing much to get hot about. If Englishmen want to desert their native soil and come to America to make their homes, they must put up with such conditions as they find at the gates of the new country they seek to enter. That is about all there is to it.

When American tourists enter Canada, there are certain regulations that must be complied with and if they present themselves at the Canadian border in sufficient numbers there is bound to be congestion—just as there is congestion at Ellis Island. Congress, however, would not be likely to pay much heed to a demand from these tourists that Canada be required to build steam-heated waiting rooms for those who are compelled to tarry at the border.

Nevertheless, the British protest about Ellis Island serves to call attention to a defect in our whole immigration policy. We accept at our ports of entry whatever in the way of immigrants the steamship companies dump upon us and proceed there to classify the desirables and undesirable. It would be far better to do the sifting at the other end of the line—that is, before they get on the steamships.

IT MUST BE A MESS!

The statement has been made from time to time by mere amateurs that political conditions in Oregon are badly mixed. Comes now a qualified expert with testimony to the same effect. Listen to this from George Chamberlain, written to a friend in explanation of his backwardness about becoming a candidate for office at the next election:

I do not think it would be advisable for me to change this resolution (not to run). It is, as you say, a hopeless situation in Oregon. Party lines have been eliminated, and unless a man aligns himself with one or the other of the factions now engaged in the contest, political there is no telling what his fate might be. I would decline to be anyone's ally, and I would not have the support of any but my old time friends.

HARDING SPEECH IS WORLD COURT PLEA

turn our thoughts to living things?" Mr. Harding said he recognized rudiments of good in the league organization, however, and repeated his declaration of 1922 that he hoped to "take and combine all that is good and excise all that is bad" from the league and the Hague tribunal.

"Sound Genesis in Hague"

"The abstract principle of world court found its genesis in 'The Hague tribunal,' he continued, 'the concrete application of that principle has been made by the league. Sound theory and admirable practice have been joined successfully. The court itself is not only firmly established, but has clearly demonstrated its utility and efficiency."

"It is a true judicial tribunal. Its composition is of the highest order, none better, none freer from selfish, partisan, national or racial prejudice or influence could be obtained. That, to the best of my information and belief is a fact universally admitted and acclaimed. I care not whence the court came. I insist only that its integrity, its independence, its complete and continuing freedom be safeguarded absolutely."

"The sole question is whether the requirements which I have enumerated as essential to adherence by the United States can be met. My answer is that where there is a unanimous will, a way can always be found. I am not wedded irrevocably to any particular method. I would not assume for a moment that the readjustment of the existing arrangement which appears to my mind as feasible is the best, much less the only. But as it is I submit without excess of detail, as a basis for consideration, discussion and judgment."

Court Plans Set Forth

The President then presented his proposal for a self-perpetuating court and added:

"The fixing of compensation of the judges, the supervision of expenditures, the apportionment of contributions, etc., could also be transferred from the league to either the court of arbitration or commission designated by the member nations."

"Thus, incidentally, would be averted the admitted unfairness of the present system, which imposes the tax upon members of the league who are not subscribers to the court."

"The exclusive privilege now held by the league to seek advisory legal guidance from the court might either be mollified, or more wisely perhaps, be extended to any member group of member nations. Thus all would be served and subject no longer to determination by the court itself of the kind of questions upon which it would render judgments."

Voting Disparity Eliminated

"The disparity in voting as between a unit nation and an aggregated empire which now maintains in the assembly of the league to which many object, because of apprehensions which I do not share, would under this plan disappear automatically."

In presenting these suggestions the President declared he neither advanced nor retreated from the position assumed in presenting the court proposal to the senate, but merely indicated "ways and means for realization of our common aspiration," which he defined as a desire to substitute "justice for warfare in the settlement controversies between nations."

"Further than that I shall not go," he declared, "I shall not attempt to coerce the senate of the United States. I shall make demand upon the people. I shall not try to impose my will upon anybody. I shall embark upon no crusade. Hereafter, from time to time, as tonight, acting strictly within, but to the full limit of my authority, I shall make further exposition of my matured views and maturing proposals."

Plea Made to Patriotism

"But I shall not restrict my appeal to your reason. I shall call upon your patriotism. I shall beseech your humanity. I shall invoke your Christianity. I shall reach to the very depths of your love for your fellowmen of whatever race or creed throughout the world. I shall speak, as I speak now, with all the earnestness and power of the sincerity that is in me and in perfect faith that God will keep clear and receptive your understanding."

"I could not do otherwise. My soul yearns for peace. My heart is anguished by the earnestness and power of the sincerity that is in me and in perfect faith that God will keep clear and receptive your understanding."

The President voiced the "enhanced regard" of this country for the British empire, of his "sturdy assumption" of her financial obligation to the United States. He recognized the German democracy's "clear manifestation of faith in our consciousness of fairness—and of our disinterestedness."

He bespoke good will for Mexico with a hope of early resumption of "fraternal relations." He hoped that Germany, Turkey and Mexico would accompany the United States into the world court.

Speech in Big Coliseum

The big Coliseum, where the President spoke—the scene of several national political conventions—had some empty spaces in the galleries when the President, accompanied by Mrs. Harding, arrived at 8:15 o'clock. As he stepped on the platform the audience rose and cheered.

The meeting, which was a mass gathering, was opened with the singing of "The Star Spangled Banner" in which Mr. and Mrs. Harding joined. May H. Kneel of St. Louis introduced F. W. A. Vesper, president of the chamber of commerce, who, in turn, introduced Governor Hyde. The governor extended a welcome to the chief executive and introduced him as a "statesman of constructive vision and purpose."

While the governor was speaking, Mrs. Harding fanned the President, who wore a heavy cut-away coat.

The President, before plunging into his prepared address, spoke a few words of appreciation for the welcome extended him and Mrs. Harding in St. Louis. He departed from his manuscript early in his speech to tell Governor Hyde, who had mentioned inland waterway developments as one of the achievements of the present administration, that he would discuss that subject tomorrow night in Kansas City.

with the ashes hurled skyward from the crater, which is completely hidden by a dense pall of smoke and cinders. Thunderous explosions continue and from all quarters are heard distressing tales of wild stampedes by the panic-stricken population, the destruction of homes, and heroic efforts at rescue.

Castiglione in Lava Path

The town, now almost entirely deserted, is a small hamlet entirely deserted, except for a young priest who wore on his breast ribbons denoting deeds of valor during war. No other soul was visible and the village seemed dead under its coating of black dust. The priest pointed out a considerable pool of lava, hissing and fuming in a depression of the ground.

"That is Catena's graveyard," he said.

Tourists Crowd Into District

The congestion caused by the automobiles of tourists, curiosity seekers and amateur relief workers in the affected area, became so great that Prefect Pericoli and Generals Strace and Battaglia have issued orders that no car shall circulate in the district without permission.

Funds and offers of help have begun to pour in from all over the world. Pope Pius and King Victor Emmanuel have each given \$50,000 lire, an Italian newspaper in New York has cabled 100,000 lire and the various municipalities throughout Italy are sending contributions.

The force of the eruption is slowly but steadily decreasing. The progress of the lava is more sluggish and wide tracks watch have already hardened are forming to some extent barriers to the fresh outflows.

Fury of Etna Abating

ROME, June 21.—The fury of Mount Etna seems to be diminishing tonight and messages of hope are pouring in from Sicily. The flow of lava which became slower during the day now is almost stopped, although the volcano is still belching forth smoke, cinders and dust.

Dr. Nicolosi, mayor of Linguaglossa, informed King Victor Emmanuel that the damage amounts approximately to 7,000,000 lire. Most of the residents of that town and Castiglione have returned to their homes, the panic has abated and conditions in general are becoming normal.

Red Cross Offers Aid

WASHINGTON, June 21.—An offer to aid to relieve suffering which has resulted from the eruption of Mount Etna was extended to the Italian people today by the American Red Cross.

The Red Cross also announced that it had forwarded an emergency relief fund of \$5000 for sufferers from the recent earthquake in Persia. Reports to the organization are that 2700 people were killed and 39 towns destroyed.

Murderer Resentenced to Hang

PORTLAND, Ore., June 21.—Dan Casey, convicted of the murder of J. H. Phillips, a railroad detective, here, in June, 1921, was resented in circuit court to be hanged on August 24. He was alleged to have shot and killed Phillips while the latter was pursuing box car thieves.
