MAIL SERVICE NOW DAILY (Register Lane County Special) SPRINGFIELD, Ore., July 28.—Daily mail service has been established to Oakridge now, effective yesterday, and a mail clerk has been put on the train to care for the matter. The train carrying mail and passengers leaves here every day at 1:45 p. m. and arrives in the morning from the mountains.

REV. A. G. SATER TO LEAVE (Register Lane County Special) SPRINGFIELD, Ore., July 28.—Reverend A. G. Sater, who has been pastor of the Christian church here for the past year, will deliver his farewell sermon tomorrow morning and in the evening will address the union meeting at the Methodist church. FERRY TRAFFIC IS HEAVY TOURIST TRAVEL OVER HIGHWAY AT ITS PEAK

HARRISBURG, Ore., July 28.—(Special to the Register)—Tourist travel over the Pacific highway through Harrisburg is now reaching its height. Last Sunday experienced the heaviest traffic thus far this season. The count taken shows 983 cars having crossed the ferry here between the hours of midnight and midnight. In the afternoon between 12 and 8 p. m. 503 cars were crossed, averaging 67 cars each hour.

A record of the number of cars taken across for the entire period beginning Monday, July 16 to Sunday night July 22 showed that in those seven days 5294 cars had been ferried. This would average more than 370 cars each day. All of these autos were not tourists, of course, as several home autoists cross the ferry daily. It is easily possible though that the number of tourist cars for the seven-day period ran close to the 5000 mark.

This is the heaviest auto traffic Harrisburg has ever experienced in a single week. Last Sunday's record was the heaviest of any single day ever recorded here. The ferry requires about ten minutes to cross the river both ways and handles from eight to ten autos. It is not infrequent that from two to four ferry loads of autos will be lined up at either of the ferry approaches. Southbound tourist traffic through here
