GOOD FOOD IN U. S.

From the bureau of chemistry of the United States department of agriculture comes this encouraging assurance:

"The food we eat today is more free from harmful preservatives and other deleterious ingredients than ever before, and no country in the world so efficiently or carefully inspects the food supply of its people, or protects them from consuming, through ignorance, food or drugs of a harmful nature."

There is first the federal food and drug act, effective since 1906, which states that no food or drugs, medicines or liquors which are adulterated, misbranded or deleterious shall be manufactured or offered for sale or transportation in the United States. In addition to this there are storage regulations and a comprehensive system of inspection. And not least of the precautions is the health publicity generally promoted by newspapers and health organizations, which, in teaching health, also teaches much about foodstuffs and warns against spoiled or adulterated foods. All imported foods, too, must come up to the standards set for domestic products.

Foreign lands are very much behind the United States in this matter. In general, those that have attempted food protection have made laws with reference to specific products and have tried to state in each law all possible conditions that might arise in regard to a single product. Naturally that is a cumbersome system, difficult to enforce and not at all inclusive.

LLOYD GEORGE NOW ON AMERICAN SOIL

enter the United States in Minnesota, visiting afterward a number of middlewestern and eastern cities and ending his tour in New York in early November.

Welcomed Marred by Disorders

New York's welcome to its distinguished visitor was but slightly marred by two disorders, quickly controlled by specially assigned squads of police. Between the battery and city hall in lower Broadway, in which scores of thousands of cheering admirers were massed, the police broke up a parade of middle-aged Irish women, carrying placards denouncing Great Britain and characterizing Lloyd-George as a "murderer" of Irish women and children. A melee ensued in which banners were torn from the hands of the paraders and in which police and rioters exchanged fatigues. The women were dispersed, one was arrested. Later, when the Lloyd-George party was proceeding up town, another group of Irish sympathizers was dispersed. Throughout the day, besieged again and again by newspaper men who asked

ed his views on current European affairs. Mr. Lloyd-George expressed his unwillingness to bring any message to America.

At a reception luncheon tendered him by the United Press, which was attended by owners and representatives of American and Canadian newspapers, he expressed the opinion that until the unity among nations, which prevailed during the great war, is regained, "the condition of the world will be a very troubled one."

Admits Europe Is Sick

The veteran statesman admitted the situation in Europe was desperate but pointed out it would have been infinitely worse had the allies been defeated. He refused to admit that the treaty of Versailles was at the bottom of the political and economic difficulties of the world, adding that the "mischief" lay in the way the treaty was being carried out.

Mr. Lloyd-George denied that he had political aspirations, declaring that after 17 years of service he thought it was time to rest and try something else.

Mr. Lloyd-George, his wife, Dame Margaret, his daughter, Megan, and several secretaries, were greeted on board the Mauretania early this morning by a committee which included representatives of the city, Secretary of Labor Davis, Assistant Secretary of State Butler Wright and a group of representative Americans.

Daughter Is Charming Maid

Miss Megan Lloyd-George, a devoted companion and ardent admirer of her father, was charming and youthful miss as she stood beside her father. Small and rosy checked, she was dressed in a blue velvet coat with scarlet collar and chic black turban. Unblushingly and with quiet composure, she said she was 31, not in love and not yet sure whether politics or matrimony would claim her future.

Of politics, Mr. Lloyd-George had little to say. He thought, he said, the Ruhr situation showed signs of improvement; the league of nations, he added, could not be a going concern without the concurrence of the United States; Central Europe, he admitted, was still in danger of disastrous developments, adding his opinion that adoption of Secretary Hughes' proposal for analysis of the situation by an international committee, would help bring about a peaceful settlement.

One of the most pleasurable experiences, he looked forward to, he said, was a visit to former President Wilson, with whom he declared he had worked for five months in great amity and cordiality.

Will Call on Wilson

At quarantine the latest member of the "Big Four" to come to the United States made it known that he intended while here to call on former President Wilson with a view to the treaty of Versailles ending the world war was drawn. He defended the treaty, asserting that it was the manner in which it was operated that had caused unhappiness. OWN COMPASS AVAILABLE

SQUADRON COULD HAVE USED SHIP SETS, IS CLAIM

(By The Associated Press)

SAN DIEGO, Cal., Oct. 5.—Destroyer squadron eleven could have used its own radio compass sets in checking supposedly erroneous radio compass bearings received from Point Arguello shortly before seven ships of the squadron crashed to destruction on the rocks off Honda, Cal., September 8, a radio expert today told the naval court of inquiry investigating the disaster.

Lieutenant Mervin W. Arps, in charge of radio instruction at the naval training station here testified that a simple adjustment of antennae would have enabled any destroyer in the squadron to have taken its own bearings on Point Arguello with the radio compass each had aboard that night.

Under cross-examination, Lieutenant Arps admitted that the individual destroyers who have been accused of helplessness so far as making accurate use of their equipment were given on the various activities that will be planned by the students for the coming year.
