PAPERS ASKED TO LOCATE D'AUTREMONT BROTHERS

Father Believes They Can Establish an Alibi

WANTS THEM TO WRITE

Makes Plea to Sons Asking Them to Tell Where They Were at Time of Murder

Paul D'Autremont, father of Eugene boys accused by railway and postoffice detectives of holding up the Southern Pacific train and killing four trainmen near Siskiyou on the night of October 11, is making a plea to the newspapers of the Northwest to endeavor to reach his sons, believing implicitly that if they read in the papers that their father is anxious to hear from them and to establish an alibi for them, they may come home and tell where they were at the time of the murder and what they have been doing since.

Asks Boys to Write

D'Autremont said yesterday that if by any possible chance his boys read his appeal in the newspapers he would like for them to communicate with him or any of the following: Percy Varnier, former parole officer at Salem; D. C. Lewis, 422 Chamber of Commerce building, Portland; or Fred E. Smith, Eugene, who has been retained as attorney to defend the boys if they are arrested and indicted for the crimes of which they are accused. The father also makes an appeal to anybody who knows of the whereabouts of the three boys to communicate with any of these men.

D'Autremont, since the detectives have accused his sons of the crimes, has received many letters from persons in different parts of Oregon where the boys have worked, expressing confidence in their innocence. Their lives have been such, the letters in nearly every instance state, that the boys seem incapable of committing such crimes as attributed to them.

Methodist Minister Writes

Among the letters received by the father is one from Rev. John D. Woodfin, pastor of the Methodist church at Westport, Oregon. He said: "It is hard to believe that there is a ghost of a chance of these boys being the culprits. I am sure of what I have seen of them that they are the kind of boys who do such a nature or tendency in their lives."

Mrs. S. D. Dornes, 850 Twelfth street, Salem, writes to the father of the boys that she knows them well and that they joined the Christian church at Albany two years ago. She said they were regular in attendance while they lived there and seemed to be good Christian boys. Other letters are of the same tenor.

D'Autremont declared last night that if Dan O'Connell, chief of detectives of the Southern Pacific, had no more evidence against the boys than has been announced by him, there is a very slim case against them.

EDMUNSON BOUND OVER

ALLEGED MOONSHINER WAIVES EXAMINATION

Pleads Not Guilty to Charge of Illegal Possession of Liquor

John M. Edmundson, arrested late Friday night on his farm near Creswell, charged with possessing liquor and a still, pleaded not guilty to the liquor charge in Acting Justice of the Peace Harold J. Wells' court yesterday and waived examination on the charge of possessing a still. Judge Wells bound him over to the grand jury with bail fixed at \$1000. Edmundson had not furnished bond late yesterday.

The arrest of Edmundson came as a surprise to the people of Eugene but the members of the sheriff's force had known of the existence of his still for a number of weeks and had suspected him of moonshining for some time previous to the discovery of the plant. The still was found by the officers at his place one night about three weeks ago but as he was not at home he was not molested. They wanted to arrest him while he was in possession.

Edmundson, some time after his graduation from the University of Oregon, in the 90's, was admitted to the bar for the practice of law but has spent most of his time since farming. He was a star guard on an early-day football team of the University of Oregon.

DIVORCE CASE IS FILED

MRS. JUANITA HAYES ALLEGES FAILURE TO SUPPORT

John E. Edmundson, Who Was Arrested on Moonshine Charge, Is Sued in Same Court

Alleging cruel and inhuman treatment, Mrs. Janita Hayes yesterday sued Wade H. Hayes for divorce. They were married in Eugene March 12, 1918, and have no children she says in her complaint. She alleges that her husband failed to provide for her. Mrs. Hayes seeks the restoration of her maiden name, Juanita Emery. L. Blyden is her attorney.

John M. Edmundson, Goshen farmer who was arrested Friday night on a charge of moonshining, was sued yesterday by L. M. Travels, Inc., to recover the sum of \$76.49 alleged due Roney Bros., merchants of Goshen, for goods. John R. Gentile and H. E. Gleason yesterday began suit in circuit court against George N. Knox seeking a decree declaring that the defendant holds certain property in trust for the plaintiffs and that the defendant be directed to make a deed to the property. A. E. Wheeler is attorney for the plaintiff.

F. H. WEST PASSES AWAY

LOCAL REALTOR DIES SUDDENLY IN OFFICE

Francis H. West, 71, local realtor, died suddenly yesterday afternoon at his office on Seventh avenue east in the Zumwalt building. Mr. West seemed in the best

of health yesterday but about 4:30 o'clock he fell and expired before medical aid could be summoned. Heart disease is attributed as the cause of death. Mr. West has been in business in Eugene for the past several years and formerly resided in South Dakota. He resided here in the College Crest district. For the past few months he has been associated with W. O. Swan.

He is survived by his wife and one daughter, Mrs. Elmer Van Dyke, of College Crest. He was a member of the Methodist church here and of the Masonic lodge of Brookings county, South Dakota. He was also a member of the A. O. U. W. of South Dakota. The funeral arrangements are in charge of the Veatch chapel and will be announced later.

JULIUS WILDE HAD WINE

JUNCTION CITY FARMER ARRESTED AND FINED

Says He Never Sold Any in His Life But Makes It For His Own Use

Julius Wilde, farmer living near Junction City yesterday paid a fine of \$350 and costs in Acting Justice of the Peace Harold J. Wells' court here for unlawful possession of a large quantity of wine found on his place.

Wilde was arrested late Monday night by Howard Lant, special prohibition agent of the state. He was turned over to Sandy Peterson, special deputy sheriff of that place, who allowed him his freedom until yesterday morning when he was brought to Eugene. Wilde pleaded guilty before Judge Wells.

Wilde had somewhere around 100 gallons of home-made drink, according to the arresting officer. Wilde said he had never in his life sold any liquor and made the wine for his own use but at the time of his arrest was making a quantity for a neighbor who had furnished the fruit for the purpose. He said that some of the drink found in his possession was made as far back as 1908 and that he never drank any of it until it was five or six years old.

Wilde's wine was brought to Eugene yesterday and turned over to Sheriff Stickels.

Gaven and E. G. R. Pixley, 19, of Wendling, were arrested at Canyonville the next day after serving the car. Pixley is now serving a term in the state prison at Salem for the crime.

Young Gaven will leave for his home at Sacramento today, Sheriff Stickels promising that he would put him on the train.

BAND WILL INCORPORATE

LOCAL MUSICIANS STATE THAT BACKING IS ASSURED

Plans for the incorporation of the Oregon State band of this city are under way and arrangements are to be made for the reorganization of the band on a sound basis with the backing of local men, according to officials of the organization. The backing for the band here is assured, is the report, and with the incorporation active efforts will be made to have the plans completed in the near future.

Albert Perfect, who is directing the University of Oregon band, will again head the organization under the new management, is the announcement. At present there are 74 men in the U. of O. band taking training from Professor Perfect.

FIRST LAW SCHOOL DEAN WILL RECEIVE HONORS

Thornton to Be Given Doctor of Laws Degree

CEREMONIES TO BE HELD

Prominent Attorneys of State and Alumni of University Will Be Speakers

Richard H. Thornton, the first dean of the University of Oregon school of law and from 1884 to 1903 in charge of the work, will be honored formally for his long and effective service when President P. L. Campbell will confer upon him the degree of doctor of laws in the presence of a gathering of the state bench and bar in Portland next Saturday.

Mr. Thornton, a resident of Portland, is 74 years old. Because of his advanced years friends urged that the ceremony be held in Portland in order that the former dean might avoid the trip to Eugene.

Judge Robert S. Bean, of the federal district court, who was a member of the board of regents when the university law school was founded; Judge James W. Hamilton, of Roseburg, president of the board of regents; Judge Earl C. Bronaugh, graduate of the law class of 1890; William G. Hale, dean of the school, and President Campbell will deliver addresses at the gathering, which will be held in the Portland hotel at noon.

Lawrence A. McNary, a practicing attorney of Portland and graduate of the 1890 class, will preside as toastmaster.

Judge Bean will speak on behalf of the board of regents as constituted when the law school was founded in 1884. Judge Hamilton will represent the present board and Judge Bronaugh, the alumni.

Dean Hale will introduce President Campbell. The latter will invest Mr. Thornton with the robes of the doctor of laws.

Mr. Thornton was a practicing attorney in Williamsport, Pa., when the late Judge Deady, then a distinguished member of the federal bench and chairman of the university board of regents, invited the Portlandian to come on behalf of the board to organize the school of law. Following his acceptance Mr. Thornton came to Portland to organize the school. Work began in the fall of 1885. Classes were held in the evening in a downtown building then occupied by the Armstrong business college.

School Had Small Beginning

The school had a modest beginning. Dean Thornton secured a small class, three students, the following year. The number of courses was increased. Dean Thornton offered the work in common law, contracts and evidence. Judge Deady lectured on constitutional law; Judge John W. Whally on pleading, and Judge E. Shattuck on equity.

An excellent teaching personnel continued the work throughout Dean Thornton's administration. In June the graduating classes journeyed to Eugene to take part in the commencement exercises. J. M. Pattinger, of Portland, and the late George M. Hays, were the members of the first graduating class in 1886. They received their diplomas at exercises held in Deady hall. Later, when villard hall was dedicated, following the gift of \$50,000 to the university by Henry Villard, the graduating exercises were held in that structure.

Between 500 and 700 students have been graduated from the school since its founding. The school is one of the most important departments of the university.

LOAN FUND ESTABLISHED

ORDER OF EASTERN STAR ANNOUNCES PLAN

The Oregon grand chapter of the Order of Eastern Star has announced the establishment of a student loan fund for the University of Oregon for women. The loan has been turned over to the loan fund office at the university.

In a letter of thanks to Mrs. C. H. Castner, of Hood River, who is chairman of the student loan fund committee of the lodge, university officials made the following statement concerning loans made to university students:

"In our experience of twenty years we have suffered practically no loss in handling these student loan funds. The students consider repayment a matter of honor and not only repay the amounts borrowed with interest, but in some instances have added by personal gifts materially to the fund itself. I am sure that the grand chapter of the Eastern Star will be amply repaid for its generous thought in providing this substantial fund for the use of university students."

His death was caused by blood poisoning. The funeral is to be held this afternoon at McMinville.
