SUIT REVEALS ALLEGED LOVE AFFAIR OF RULER (Continued from page 9)

merchant, who lived in the eighteenth century.

For many years the Fredericks family lost suit after suit for the estate, but several years ago a document, claimed to be a confession of Mlle. Daum in which she reveals that she came into possession of the property through intrigue, murder and falsification was found. Then Fredericks won a series of victories in the lower courts and the defendants appealed.

Fredericks claims the fortune dates back to his great uncle, Michael Gabriel von Fredericks, secret chamberlain of Frederick the Great. Many favors and much property were heaped upon the chamberlain by the king.

Moved into the Palace Mlle. Daum, with two children, was known as Mrs. Fredericks. The widow of the chamberlain's brother, she was the object of the attention by the king, the Fredericks petition alleges. The real Mrs. Fredericks, it is contended, died under mysterious circumstances in 1772. The chamberlain died a year later.

The alleged confession reveals that Mlle. Daum met Frederick while he was crown prince and when the latter became king and heaped favors upon his chamberlain, she became jealous. As a result, the document continues, she poisoned both the Fredericks, altered the chamberlain's will so as to gain the property and filed a fake marriage certificate showing she was the chamberlain's first wife, whom he had not legally divorced before marrying a second time.

Angela, instead of Monterey, the capital of the state. In 1848 a road-weary courier about from the Plaza that gold had been discovered in Northern California. Two days later, the dusty throat of Calaveras Pass was choked with wealth seekers and only twelve persons were left here.

Life about the Plaza has not always been happy. Eighteen Chinese were hanged here in 1871 during a race uprising.

Chinatown, adjoining the Plaza, contains Ferguson's Alley, Apalasa and Marchessault streets, where young Chinese trade with tourists and old men sit silently puffing at long-stemmed pipes.

Two years will be required to complete the reconstruction program, but already demands are being made to save the plaza. It appears certain, however, that the old tunnels and underground chambers to which the Chinese settlers fled at any suspicion of recurrence of the massacre of 1871 must surrender to steam shovels the secrets they have hoarded for decades.
