

WAND WRESTLES KRUISE TO DRAW IN MAIN EVENT

Trick of Fate Keeps Eugene Man From Winning

RETURN MATCH PROMISED

Brown and Pete Put Up Fast Bout for Fans With Neither Gaining Decision; Lamb Defeated

Ralph Hand and Bob Kruse failed to show the fans who was the better man in wrestling circles in the match held at the Hotel last night. The outcome of this spectacular battle was a draw as each man had a fall.

Hand took the first fall after going through one hour and 12 minutes of fierce grappling but failed, by the merest trick of fate, to hold his lead.

This trick of fate, a matter of seconds as the clock ticks, ended the most spectacular wrestling bout held in the local arena.

Hand was leading with one fall and but three minutes to go before time would be up. However, when the timer sounded the nearness of the time, Kruse rapped his leg around Hand's left arm and began cinching down. Hand tried to hold on gamely until the seconds had ticked by. Whether he did or not was a question as referee Bill Hayward slapped Kruse on the back for the fall before anyone heard the gong, although a short time later was held up as to whether the bell rang or not. It was decided that it had not sounded.

Bout Was Good Draw

Even if the bell did ring before the fall was completed, Kruse deserves a draw. He and Hand wrestled through as even an hour and a half of good clean grappling as fans have ever witnessed on any holding card. The going was even throughout with the exception of a toehold which Hand applied to Kruse making him give in. Other than this both men worked as hard as possible for a fall or decision but neither proved himself any better than his opponent.

The fight as to the better man between the two will terminate with a two-hour match, January 12, to be held here. It was decided immediately after the bout was over, as the winner was either Mike Yotel or Ted Thye of Portland as soon as a decision is reached.

Pete and Brown Draw

"Wildcat" Pete and Ted Brown went through an hour and a half of a hard battle in another draw. Both men took a fall during the encounter. Brown gained the first in 22 minutes but Pete made a sensational comeback and threw Brown in 21 minutes. The remainder of the time saw both men doing everything to gain either a fall or decision but the bout was given nothing but a draw would have suited anyone.

These two men will be on the next card as each thinks he is capable of proving himself the better man. The outcome of this next card should prove a real battle.

Sanderson Is Corner

Mark Sanderson made his initial appearance in a professional wrestling match before fans here by taking Guy Lamb down for two consecutive falls. The first was gained in two minutes and the second in but one. Sanderson proved himself to be a real corner in the mat game and will probably see more action on cards here as the fans liked his stuff. Lamb deserves credit for the showing he made in his opponent had too much stuff to give him a show.

A Resume of the Card Shows that

Hand threw Kruse in one hour and twelve minutes with a punishing toehold. Kruse came back and put Hand's shoulders to the mat with but a few seconds before the end with a short arm scissors, using his leg as leverage, which compelled Hand to put his shoulders down. Hand weighed in at 173 and Kruse at 174.

Brown threw Pete with a short arm scissors and wrist lock in 22 minutes and Pete came back with a toehold after but 21 minutes and

compelled Brown to pound the mat. Brown and Pete weighed 147. Sanderson headlocked Lamb for both falls, the first in two minutes and the second in one. Both tipped the scales at 169 pounds. William "Bill" Hayward of the university refereed all bouts.
