

CARNEY AND CLARK DRAW IN WINTER GARDEN FIGHT

DeMith of Corvallis Wins Over Reese By Foul

OTHER BOUTS END EVEN

Another Big Fighting Card Promised With Local and State Renowned Boxers to Be Matched

Spike Carney of Yakima and K. O. Bobbie Clark of San Francisco pummeled each other through 10 rounds to a draw in the main event of the all-star card staged at the Winter Garden boxing arena last night.

Jimmie DeMith, Corvallis favorite, drew a win over Harold Reese of Portland in the third round of a scheduled six round bout when the Portlander hit a foul blow, Speed Landers, Eugene, and Billy Robbins of Portland fought through six rounds to a draw. Slow York, Eugene, and Lefty Wharton, Portland, drew in a four-round match.

In the main go Spike Carney started out by shooting his famous left to the side of Bobbie Clark's head. This lasted throughout the first two rounds but after this the young Californian started shooting in counter blows and carried the fight to his opponent. The fighting throughout was even with both boys giving and taking as much as possible.

Boxers Show Fight
Carney showed local fans how he gained the reputation he had when he arrived to fight Clark but Clark didn't seem to care for this reputation and started in to make Carney get his fire up and then both boys began mixing in real fighting fashion.

A draw was the logical decision to render as Clark's leading and forceful fighting was offset by the clever left jabs Carney used to stop these rushes with. During the seventh and eighth rounds both boys seemed to have taken everything from the opponent possible but kept boring in all the time. The punishment given and taken was equal.

Harold Reese of the Rose City substituted for Harold Davis of Eugene against Jimmie DeMith and seemed well on his way to winning the hearts of local boxing fans when he seemingly accidentally shot an uppercut which failed to find the chin of his opponent as it stopped low. This was in the fourth round and the referee stepped in to stop the fight as Reese hit his opponent low during the first part of the round and was cautioned. Reese then in some manner let his left hand fly and cracked DeMith in the same spot. This made the Corvallis boy fall to the mat in pain. In seconds he threw in a towel to stop the bout but as a foul was committed it was given to him.

Bobbie Shows Ability
Billy Robbins won the favor of local fans with his show of boxing ability and smile. Speed Landers

showed some fast footwork in dodging the heavy blows of Bobbie and earned a draw. However, Robbins led slightly throughout and if it hadn't been for the uncanny ability of Landers to swap blows without seemingly hurting himself the outcome might have been different. Robbins showed real class but the bulldog tenacity of Landers earned him a draw.

Slow York threw his gloved hands repeatedly at Wharton in their four-round bout but as he was shooting in blows he was also taking them. This bout was a thriller throughout with first one man gaining the lead and then the other. However, when the final round came the going was about even and if it wasn't, the final period proved it so.

The promised four-round preliminary proved one of the clearest and most swinging bouts on the program. Two 60-pounders, Hugh and Jimmy Murphy, acclaimed as champions in their weight in Baker, Oregon, drove each other round-and-round the ring. Several cheers and rounds of applause were accorded the youngsters who proved themselves able punch swappers.

Fighters Are Light
The five bouts proved to be the lightest in weight held in the local arena. The main eventers weighed in at 120 pounds. The remaining fighters tipped the scales in the following manner: Harold Reese and Jimmie DeMith, 133 pounds; Speed Landers and Billy Robbins, 115 pounds; and Slow York and Lefty Wharton, 140. Cal Herman of Salt Lake City, refereed all matches.

Another real fighting card is promised the local fans during the month, according to M. A. Galloway, boxing promoter. Several boys of home reputations are expected to go against fighters of state reputation.

AL KARASICK AND HAND MATCHED FOR MAT BOUT

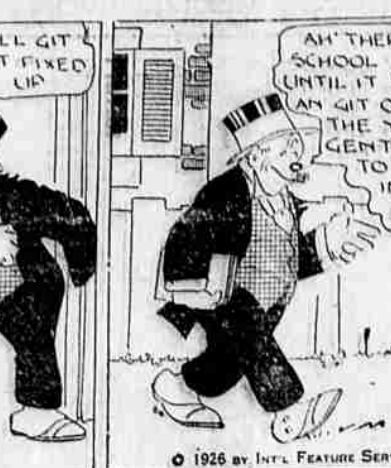
