

NINETY-FIVE GIRLS SIGN TO ATTEND SCOUT CAMP

Registration for 3rd Week Still Going On

7 COUNCILORS NAMED

Mrs. Schrupp, Director, Returns From Inspecting Blue River Site

Ninety-five girls have signed to attend the first two weeks of the Girl Scout camp to be held August 6 to 27 at Blue River. It was announced last night by Mrs. Arnold Schrupp, director. Forty-five of those signed will attend the first week and 50 will go up for the second. Registration for the third week is still going ahead and about 25 girls are expected to attend, Mrs. Schrupp says.

Unusual interest is being taken in the camp this year. It was first planned to take care of about 15 girls at all three of the camp periods, but this number has been exceeded by 20 for the first two periods alone. The girls are making many preparations for their departure for the camp Monday morning. Physical examinations are being taken this week at the Eugene hospital.

Director Visits Camp Mrs. Schrupp returned last evening after spending the day inspecting the Y. M. C. A. camp at Blue River which the girls will occupy. She reports that the camp is in excellent condition for the girls and that only a few changes in the arrangements will be made.

The seven councilors who will assist Mrs. Schrupp with the camp are: Alice Spurgin, Peggy Price, Inez Simons, Elvira Jensen, Mrs. Thomas Corey, Miss Larson and Mildred Reynolds. The unit system which has proven popular in girl's camps all over the United States will be used, Mrs. Schrupp says. The girls will be divided into three groups. The pioneers will consist of girls who are working for their pioneer awards which will be made at the camp. The two other units will be the Indians and Robin Hoods.

To Dramatize Work The camp life of the girls will be dramatized to keep in spirit with their names. Each example the Indians will study the history of the early days of Lane county and will weave the stories into their work and play each day. Plays and programs of this nature will be put on each evening around the camp fire.

Health work is to be emphasized at the camp. When the girls first arrive they will be given sealed instructions by the camp nurse, Miss Larson. When these instructions have been fulfilled another set will be given the girl. Finally when she has fulfilled all the requirements an emblem will be awarded her.

JACK DEMPSEY IS SKEPTICAL

Mauler Doubts if Gene Is Serious in His Intentions

BOSTON, July 31.—(AP)—Jack Dempsey, whom Gene Tunney dethroned as heavyweight champion, does not think Gene is serious in his announced retirement from the boxing game an undefeated champion.

Dempsey, who arrived here today as announcer of the Schaaf-Mays bout at Braves field tonight, expressed the belief that Tunney would enter the ring again should the occasion demand it.

"It is a shame that Tunney is quitting just now when he is at the top of his fighting career," the Manassas Mauler said. "I can say, however, that Gene's retirement will not affect my own plans in any way."

Dempsey, who also is supposed to be on the retired list, did not appear to be very sure that he was through with the game for keeps. He declared, however, that he had no immediate fistic plans.

armaments, or handed as a separate treaty matter, would be effective only for a definite period of time, such as ten years, within which time each nation would agree not to exceed the specific tonnage in any category.

The nub of the whole matter, it is believed here, is that at last France and Great Britain appear to have arrived at a solution of the difficulty in regard to construction of submarines which prevented extension of the Washington five-power naval reduction treaty to other than capital ships and aircraft carriers so far as tonnage limitations went. It was French rejection of any limitation on submarine construction that led the British then to decline to accede to any limitation on anti-submarine craft, such as cruisers, destroyers and smaller vessels.

TORAL TAKES ALL BLAME

SLAYER OF OREGON SAYS HE HAD NO ACCOMPLICES

Declares No One Knew of His Intention to Assassinate the President-Elect

MEXICO CITY, July 31.—(AP)—Jose de Leon Toral, slayer of President-elect Alvaro Obregon, in a confession made public today, took all blame for the crime and declared no one knew of his intention to slay the president-elect.

The assassination, he declared, was motivated by General Obregon's "intellectual responsibility" for the religious policy of the Mexican government and his responsibility for "everything else in Mexico."

Although he denied he had revealed his intentions to anyone, he admitted he went to mass and confession by a priest named Jimenez at a private residence in Mexico City a few hours before the slaying.

Toral made these declarations today to a group of Mexican and foreign newspaper reporters whom Chief of Police Rios Zertuche permitted to question him.

Did Not Confess Intention "I did not confess what I intended doing," Toral said, "because you only confess sin, and the killing of Obregon was a good deed and not a sin. You do not confess good deeds."

Replying to another question, Toral said: "I will not make any defense in court. I have no defense. My soul is tranquil. I expect to die and go to heaven."

Sixteen Catholic nuns, arrested at Guadalupe Hidalgo shortly after the slaying of General Obregon, are still being detained at police headquarters for further examination. Toral admitted having visited them frequently in recent months but said they were ignorant of his desire to kill the general.

Police today began an active search for the priest, Jimenez.

Hamm wound up the most sensational broad jumping campaign any human kangaroo ever had by adding the world's championship to his national and world's record holding honors. His winning leap of 25 feet 4 1/2 inches displaced the Olympic mark set in 1912 by the American A. L. Gutterren and gave the Georgia tech star possession of all the jumping honors worth mentioning. He out-leaped S. P. Casor, negro rival from Haiti, and his own countryman, Al Bates, who finished third, while the former champion, Dehart Hubbard, failed to reach the final.

Where the American men sprinters had been falling dismally, Miss Robinson, the only Tanke to reach the women's sprint final, ran a beautiful race to beat two Canadians and one German rival. Bobbed hair flying in the breeze, the Chicago girl sped down the straightaway, flashing a great closing spurt to beat the Canadian favorite Fanny Rosenfeld by two feet.

Polish Wins Discus It took a world's record discus throw of 39.62 meters by a husky Polish lass, Halina Monopacka, to beat another American feminine star Lillian Copeland who finished second with 37.93 meters.

The 5,000 meter trials, determining 12 competitors for the final Friday gave two young Boston A. A. stars, Leo Lermond and Macauley Smith a chance to shine. Lermond uncorking a typical sprint, won the first heat in the day's best time, 15 minutes 2-3/5 seconds. Smith even more spectacularly had the moral satisfaction of leading the great Paavo Nurmi at least for a day.

The American, running third most of the way behind Edwin Wide of Sweden, rushed out in the final lap 16 win by a big margin. The Scandinavians did not chase him, being satisfied to qualify.
