The committee on conferences & congresses at the Lewis and Clack Exposition is sending a letter to the mayor of all cities and towns in Oregon, Washington and Idaho requesting the appointment of official and lay delegates to the convention of Pacific Northwest cities to be held in connection with and as a feature of the Civic Congress from the 14 to the 19 of August in the Auditorium on the grounds. It is believed that these efforts will bring together one of the most important assemblages ever held in Oregon, which will mark an era in the municipal progress of the Northwest. The greatest specialists in municipal affairs will take part, among them are William T. Jeome, the noted district attorney of New York City who will speak on "The Battle Against Corruption;" Josiah Strong, president of the American Institute of Social Service and author of Our Country; Congressman John DeWitt Warner of N. Y.; Prof. C. Zueblin of the Chicago University; Clinton Roger Woodruff, secretary of the National Municipal League, and J. Graham Brooks, author of "The Social Unrest." The subjects of municipal control by corporations and municipal ownership will be discussed by such experts of Mr. Brooks, Amos Parker Wilder and Frank J. Goodnow. Problems of intimate interest to people all over the world will be handled by the best authorities in the world.
