Poultry Day

The Poultry Show at the Lewis and Clark Exposition opens today. Something like 2,000 birds have been entered. In quality the show will be the greatest exhibition of the kind ever given West of the Rockies. The Eastern entries are not so heavy as expected, owing to the high express rates, and the Western bird will predominate. Pierce county, Washington, did head the list with 225 entries. The pigeon show will be quite extensive as there have been several hundred birds sent in.

Senator Mitchel in Hospital

A Tuesday news item says: U. S. Senator John H. Mitchell is confined to the Good Samaritan hospital as the result of the fracture of a rib, received last Thursday. He is progressing well and beyond the fact of his being obliged to remain in bed for a long time no fears are felt for his recovery.

Senator Mitchell met with the accident while at the dry dock last Thursday to which place he went with a company of friends to inspect the large steamer Oceano which had just been docked. As he was leaving he stepped upon some loose earth that gave way under his weight and he fell to the ground.

It was not until later that the Senator realized that his injury was serious. It kept growing more painful, until at last he was obliged to have it examined. Dr. P. J. Wiley took charge of the case, and soon determined that there was a fracture of a rib, and the senator was removed to the hospital.

A young kindergarten teacher who is made much of by her pupils, frequently meeting their parents, has a very affable manner, and, on entering a car recently, exclaimed in her most cordial way to one of the passengers: "Why, how do you do, Mr. Brown." As the old man spoken to evidently did not know her and looked rather dazed, she noticed the mistake and apologized: "I beg your pardon, I thought you were the father of one of my children."
