SALUTATORY

With this issue is presented to the public the first copy of ESTACADA PROGRESS, successor to The Estacada News.

ESTACADA PROGRESS is a corporation duly organized under the general incorporation laws of the State of Oregon, its stockholders comprise many of the business men of Estacada and vicinity, and its general policy and administration is controlled by a Board of three Directors, whose names are signed to this statement, and who desire the initial number of the paper to announce clearly the purposes and policy of the Publication.

The Estacada News was an estimable country paper and under the guidance of Mr. H. A. Williams occupied the field of a country newspaper at Estacada in a satisfactory manner as could possibly be expected, under the existing conditions.

But The News was a country paper owned by one individual, who naturally and very properly published it with the sole object of making it a profitable enterprise of itself, irrespective of any other object or purpose.

The time having arrived when the growing population and expanding business of the great Pacific Northwest have made it imperative that a wider publicity be given to the many advantages of the soil, climate and productions of Central and Eastern Clackamas County, in order to keep this rich section of Oregon abreast of the march of progress, it was decided by the business men and merchants, now comprising its stockholders, to establish an incorporated paper for Estacada that would not only have many supporters and workers in its officers, Directors and Stockholders, but being solely interested in developing this section of the county, would direct its policy with that object mainly in view, leaving the question of earning power of the paper to take second place.

The objects and purposes of ESTACADA PROGRESS are, therefore to advertise, and to direct attention to this section of Clackamas County for the purpose of developing and enriching it.

ESTACADA PROGRESS believes that the breaking up of the large farms and old Donation Land Claims in this vicinity will do more to increase the wealth of the country than any other single agency.

It believes also that the best way for the man of small means to make himself independent, is to purchase a small tract of the rich, alluvial soils of Central and Eastern Clackamas County, because the soil is in most cases better and in all cases as good as elsewhere in the Northwest, and owing to its, until recently, isolation the prices are about one quarter of the same lands in other, equally favored localities.

The happiest man these days is he who owns a ten acre farm that he has highly improved and thoroughly cultivated. President Roosevelt says: "Even five acres is enough to support a family and keep it busy."

The owner of ten acres of the rich soil of Eastern Clackamas does not have to "Knuckle to the Boss" nor strain his conscience in the struggle of the intense commercialism of the day.

His income is untouched by "Panics" or "Financial Depressions."

His living and peace of mind are not dependent upon the fluctuations of the stock market nor upon the whims of any man or set of men.

He is a King whose sway is undisputable in his own, small domain.

He can make his highly cultivated ten acres earn as much as a quarter section (160 acres) scratched over would produce—as much as between twenty and eighty thousand dollars in cash would earn loaned out at 6% interest.

He has his close neighbors, his telephone, good roads, the best of schools, churches—in fact all the comforts and conveniences of life that come with the prosperous, close-knit community, though they pass by the great, isolated farm.

This, then is one of the main objects for which the owners of this paper called the corporation into existence.

And with that end in view it will constantly agitate the question of dividing and breaking up large land holdings, the building up of good roads, maintaining good schools, developing the vast timber and milling industries and the establishing of new enterprises.

Let it be understood once and for all, that ESTACADA PROGRESS was not called into being to be used as an engine to the injury of any individual or clique; neither was it created to advance the interests of any person or faction.

Its sole purpose is to become an effective instrument in the developing, enriching and building up of this section of Clackamas County and the beautiful little City of Estacada, and it is inconceivable that any thinking, sentient being can oppose so laudable an object, but surprises sometimes occur, and should the unexpected happen the Steam Roller of Progress will quickly flatten obstructions in its path.
