New Experimental Crops
Since the Progress has been seeking information regarding experimenting with different grains and vegetables in this part of the country, many reports have been received from farmers, who are and have been working along these lines.
In the George section, several farmers have had good success with alfalfa, especially Chris Johnson and Robert Miller. Johnson has part of an acre in good condition now, allowing for the dry season. He carefully inoculated his seed with the necessary germs, obtained from the Oregon Agricultural College and also spread some inoculated soil on the land.
Mr. Joyner of George reports having good results from the planting of "sand vetch" which grows along the ground similar to a vine, and has attained a length of 14 feet on his place.
Stories of 6 foot sweet clover also come from the George district and it looks as though this country can raise suitable crops for ensilage, besides corn.

Walter Gibbens of Estacada Heights has sugar cane three and one-half feet high, now growing on his place and millet doing nicely.

The Progress wishes to obtain specimens of all of these grains and vegetables, for use at the East Clackamas Fair and for permanent exhibit here.

All grain, fruit or vegetable exhibits for the East Clackamas Fair may be left at the Progress office and the new tags have been printed to be attached to each sample. Save out some good specimens of your grains before finishing threshing and bring them in. Don't merely bring a bouquet, but bring a good-sized bundle and pull it up by the roots.

New coats of paint are in evidence on many houses and buildings in Estacada right now. Melvin Shankland has about finished the painting of Reed's garage and will paint the house recently occupied by Mrs. M. E. Graham on Main St. and the vacant house on the corner above. Bert Byers has recently painted his house brown, with light trimmings and green stained shingles and it presents a beautiful appearance. The R. G. Marchbank home on Main St. is being repainted, from white to a darker color, the Laddix kennels and the home of E. W. Bartlett have also been newly painted. At this present rate of improvement, it won't be long before the Progress can chronicle some new sidewalks.

George Community Fair
